7 Good day – Attached please find a civil Complaint filed in the District of Columbia, related to activities
8 which occurred in your district and in other districts around the United States. The NYPD and federal
9 agencies have been involved in civil rights violations against me in and around Manhattan and other
10 locales. Most recently, they ran a honey trap against me at Hunters Point on November 13 between
11 6PM and 8PM using a dozen or so lone female undercover officers on vacant sidewalks. They have
12 arranged my social life and a series of dates and girlfriends for me over the past 15 plus years as I lived
13 in New Jersey. All without legal basis or any basis of reasonable suspicion.

14 In fact, very similar operations were run against me in Washington and Oregon in 2005. My
15 worst offenses were five speeding tickets in my teens and early 20s. I'm 66. All my parking tickets – 2 –
16 both in New Jersey, were paid on time. My violent history and arrest record – none ever. I worked with
17 the Governor and State Legislature in Washington state in the late 1990s and early 2000s, hold a BA,
18 MBA, and was a CPA and well-traveled consulting manager for a large international accounting firm
19 there.

20 My prior attempts to bring this to the attention of federal authorities, including the US Attorney
21 for Western Washington in 2005, failed to produce any improvement. One element of these on-going
22 operations against me, a counter-terror operation, has been directly confirmed by NYPD, though they
23 refuse to produce the documentation under New York State's FOIL law. The confirmation is included in
24 the enclosed Complaint.

25 I am informing you of these activities because we are all well aware of past NYPD violations of
26 civil rights, as well as the past misconduct of federal agencies and departments against US citizens, some
27 of which occurred historically in your district. These activities have also been reported to DOJ OIG in DC,
28 among others.

29 These operations appear to be part of a larger pattern of reprisal and coverup conducted by
30 federal and local authorities over an extended period of time. Please note that all information contained
31 in the enclosed documents is the direct explanation and result of my own personal experience and open
32 sources. I have never held a security clearance of any consequence – just ramp passes at a couple of
33 international airports.

9 Good day:

10 This is a citizen criminal referral. Please do not immediately refer it to the FBI or any other
11 police powers authority until you review the materials in full and have discussions with the DOJ
12 Assistant Inspector General for Investigations in DC. Also please note this is a follow up to an
13 earlier mailed communication from me to SDNY dated December 6, 2021 and modifies that
14 communication.

15 This misconduct involves operations of Joint Terror Task Forces in the tri-State area and other
16 Districts in the United States, among other things. The long-running criminal misuse of classified
17 national security systems against U.S. persons is the critical underpinning and original
18 motivation for these ongoing operations and the accompanying coverup efforts. I realize this
19 may all sound fantastical and detached from reality but so did MKULTRA and Cointelpro,
20 roughly similar and long-running operations of CIA and FBI in the 1950s through early 1970s. It
21 is grounded in reality, actual physical conduct, and real experiences. Also, please note that I
22 have never held any federal national security clearance of any kind.

23 According to the USPS website, the enclosed document set, addressed to the Assistant
24 Inspector General for Investigations Headquarters Unit in DC, was diverted to a series of USPS
25 facilities in Atlanta, Georgia to avoid its delivery to its intended recipient. The next several
26 pages provide direct evidence from the USPS website of the mail fraud involved in this ongoing
27 operation. It appears this incident of mail fraud was yet another example of a deliberate and
28 malicious effort to evade accountability for a durable set of criminal acts by persons with police
29 powers in metro New York City Districts and the New Jersey District, perhaps others. This
30 pattern of misconduct dates to at least 2007 and continues into the present time.

31 As described in the document package, and in other evidence of mailings likely in the hands of
32 the FBI since at least 2018 and dating as far back as 2005, this type of document diversion has
33 happened fairly frequently over the years, as have other incidents of mail and wire fraud. In
34 2005, I was forced to travel from Seattle to Washington, DC to hand-deliver complaint letters,
35 never followed up or acted upon, to DOJ and FBI, among others.

36 **This matter is time-critical and has potentially life-threatening consequences. Prompt action**
37 **is strongly recommended to avoid further violations of civil and constitutional rights,**
38 **potential injury, and loss of life.**

15 Good day – Attached please find a revised and expanded civil Complaint filed in the District of Columbia,
16 related to activities which occurred in the Southern District of New York, in nearby jurisdictions, and in
17 other districts around the United States. This complaint replaces a Complaint previously provided to the
18 Court and to you with a transmittal letter dated February 16, 2022.

19 The most recent efforts to frustrate communications in this matter include a series of hacks of my
20 computer on February 26, 2022, as I prepared this and related documents, and the non-delivery of the
21 most recent replenishment of my HP ink subscription via USPS. While these disruptions are certainly not
22 debilitating, they do demonstrate the continued efforts to frustrate my litigation and whistle-blowing
23 activities. The underlying technology described in my Complaint does continue to be used against me on
24 a daily basis and continues to present the risk of severe harm or worse.

25 I revise this letter on Sunday afternoon to report another episode of symptoms which are comparable to
26 those experienced and explained on MSNBC Sunday afternoon as Havana Syndrome by Olivia Troye. Ms.
27 Troye is a former national security official who worked in ODNI CTC, DOE and DHS Intelligence
28 operations, and for former Vice President Pence. The resumption of these attacks on me in the past few
29 days and weeks, with the strongest in this series occurring on Sunday, creates symptoms which are
30 consistent with episodes of a cluster of symptoms including headaches, visual confusion, mental
31 confusion, and nausea I previously experienced. These occurred periodically in the State of Washington
32 prior to 2006, primarily while driving. The frequency went to daily while I was in a homeless shelter in
33 Boston for 17 months, occurred occasionally during my employment in northern New Jersey at my office
34 during 2007 to 2008, and resumed extremely high intensity and daily frequency in my residence in
35 northern New Jersey from late 2008 through 2010.

36 Their resumption now coincides directly and specifically with other recently accelerated disruptions of
37 my communications with DOJ OIG and the US District Court in DC, and with my efforts to contact expert
38 witnesses and outside counsel. Further documentary detail of those communications disruptions,
39 including wire fraud and mail fraud, is enclosed. I note that I have no reason whatsoever to believe they
40 are caused by any non-US entity in my specific situation. Rather, it is far more likely they are being used
41 by elements of or those allied with the Defendants listed in my Complaint.

As previously mentioned, the NYPD and various federal agencies operating under auspices of a JTTF have been involved in sustained and repeated civil rights violations against me in and around Manhattan and other locales. Some examples are detailed in the Complaint. Many hundreds more such incidents will be found during the discovery process. Recently, they ran a honey trap against me at Hunters Point on November 13, 2021 between 6PM and 8PM using a dozen or so lone female undercover officers on vacant sidewalks. They have arranged my social life and a series of phony dates and girlfriends for me over the past fifteen plus years as I lived in New Jersey.

All these activities lack any legal basis, reasonable suspicion. The efforts to disrupt, discredit, and cover up have been and are being undertaken by operations acting under, though not within, the authority of the United States and its subdivisions. This is formulaic and typical treatment of US persons abused by the United States who elect to blow the whistle on such criminal conduct.

There is no reason for any foreign intelligence service to inflict Havana Syndrome and thereby disrupt my life on this day or any other day. I have held no security clearance, ever. No intelligence, military, or police powers service, ever. No access to classified information, ever. Simply the victim of corrupt US government acts. They know this as well and already understand the technology's impact on their own people in the past.

They are simply awaiting the international embarrassment and outcry against the US government which will arise from the disclosure of this technology and its potential Orwellian implications on people everywhere. The irony and hypocrisy of our allegedly democratic government protecting freedom and national security by using this technology and these tactics to abuse US persons is a propaganda victory of nearly unparalleled dimension.

There are few starker recent examples of impunity, and corrupt, out of control, and unaccountable police powers and intelligence operations hiding behind national security than this. And carrying on in the same unreformed manner and traditions as they had in previous decades. After strong Congressional reforms.

Notably, it was an activist burglary of an FBI office that gave Congress and the public the grotesque and felonious dimensions of two decades of illegal Cointelpro activities against Dr. Martin Luther King Junior and other activists trying to enforce the Constitution, the Bill of Rights, and their right to vote. No internal affairs unit or inspector general ever said a word about it before the burglary.

CIA's MKULTRA and other LSD experiments on US soldiers and US citizens were ignored as well, until a researcher died hitting a New York City sidewalk about seventy feet below. A while later, the CIA Director ordered the incriminating evidence of that project destroyed, and amnesia became the chief ally of the agents who had perpetrated two decades of criminal acts against soldiers and citizens.

The reckoning for this outrage must come. Government employees who have acted with impunity over decades must be held to account. Not by permitting retirement on full pension as FBI Director J. Edgar Hoover did after ordering and supervising decades of Cointelpro felonies conducted by FBI agents against people trying to peacefully assert their Constitutional rights. Nor by promoting and confirming a CIA Director as Ambassador to Iran after he ordered the destruction of evidence in CIA and Army's criminal use of LSD on soldiers and other US persons.

As President Biden said recently in Tulsa about the White race riot and massacre there:

"We should know the good, the bad, everything," Biden said of America. "That's what great nations do. They come to terms with their dark sides. And we're a great nation. The only way to build a common ground is to truly repair and to rebuild....."

The only question that remains is whether the United States is up to this challenge?

We need real accountability for the dead, the disabled, the emotionally and financially destroyed US persons, for any non-state or friendly actors, and for their families, from this durable and horrific criminal conduct hiding behind the cloak of secrecy called US national security.

Not another perjured government affidavit as in *United States v Reynolds* (1953).

13 Good day – This is a follow up to my letter dated February 28, 2022, and hand delivered by me to SDNY
14 Security at One St. Andrews Plaza on that day.

15 For your information, the HP ink subscription mentioned in that February 28 letter was sent via DHL to
16 USPS in Avenel, New Jersey (an illogical transfer point which is a considerable distance from the USPS
17 distribution hub for the postal region in which I reside) for final delivery by USPS arrived in my mailbox
18 this afternoon (Tuesday).

19 This point in and of itself would be considered a minor error or delay when taken by itself. I would not
20 bother to mention it except that it forms part of a durable pattern in recent times (since at least 2019).

21 This type of “coincidental” conduct is entirely consistent with the series of undertakings apparently
22 intended to discredit me as a whistleblower/witness. Comments were verbalized by me to myself in my
23 residence to no one else and in no other location, and/or I specifically made follow up attempts with
24 third parties to complete the contact or delivery in question. My comments and follow ups were related
25 to the following situations, each of which was followed by the externally driven outcomes noted.

- 26 • **Management of my personal affairs by a third party** - lack of White female dating opportunities
27 in a region which is more than 50% White (NYC and northern NJ) in 2019 and 2020. I dated one
28 White female, followed by about fifteen one and out dates with Black females, and a Black
29 “girlfriend.” I presume, with the benefit of hindsight, that this sequence was externally managed
30 by a police powers operation. One day after my verbal comment on this matter to myself
31 (earlier this year) in my residence with no one else present, only the second White female
32 match since 2007 appeared, then disappeared with little or no communication.
33
- 34 • **Complete disruption of my ability to contact nine expert witnesses in computational**
35 **neuroscience** at various research universities, institutes, and corporations by email to discuss
36 my technical case. My inability to communicate with these outside experts has severely
37 weakened my ability demonstrate the technical veracity of my technology claims and get this
38 deeply technical set of claims to be accurately considered by judges in the DC US District Court.
39
- 40 • **Complete disruption of ability to contact and enlist support from legal counsel** at three entities
41 which have legal practices and/or access to relevant legal resources- ACLU in New York City,
42 Hogan Lovells in Washington, D.C., and Human Rights Watch in New York City by mail on

43 January 28, 2022, and email. This was followed a few days later by notices of delivery to an
44 agent (for Hogan Lovells) and to addressee's building garage (not necessarily to ACLU, the entity
45 to which it was addressed). Interestingly, on my first attempt to send these two packages,
46 neither website included the floor number, only the building street address. When I checked
47 again for a second mailing or to confirm the address, floor numbers appeared as part of the
48 address for both entities. My January 28, 2022, package to Human Rights Watch was "lost,"
49 never delivered the eight miles or so from my residence to its offices in New York City.
50

- 51 • **Diversion in the USPS system of my February 10, 2022, complaint package to DOJ OIG**
52 **Investigations** in Washington, DC. This package originated in Edgewater, NJ, was diverted to
53 Atlanta and bounced around facilities there, according to the USPS tracking website. This was
54 followed by a late delivery of this Priority Mail package directly from Atlanta to DC the day after
55 I had delivered a notice that it was missing. .
56
- 57 • These incidents of mail fraud and wire fraud closely match my experience with delivery failures
58 of mail and express services in Summer 2005, which forced me to take a trip from my then
59 residence in the Seattle, Washington area to FBI Headquarters, DOJ Headquarters, Executive
60 Office of the President, Treasury, and other Executive Branch offices in Washington, DC.

61 Finally, as you know by now, these mail fraud and wire fraud incidents are only one small element of the
62 totality of criminal conduct by persons with police powers and/or other legal authorities acting against
63 me and my interests.

64 For your convenience in tracking the sequence, the full text of my letter dated February 28, 2022, is also
65 enclosed.

13 Good day – This is a follow up to my letters dated February 28, 2022, and March 2, 2022, and hand
14 delivered by me to SDNY Security at One St. Andrews Plaza. This letter is also hand delivered there.

15 For your information, the Complaint delivered to you on February 28, 2022, has been assigned Case 22-
16 cv-00592 by the Clerk in Federal Court for DC. No word on the judge assigned to this complaint or when
17 or whether my emergency TRO request will be heard. US Attorney for DC – Civil unit head was contacted
18 informally and indirectly via correspondence with his EA some time ago, but complaint has not yet been
19 served.

20 Further relevant leads for evaluation:

- 21 1. I was the principal shareholder of a now-defunct Colorado corporation Winnett Perico, Inc. One
22 of the investors in that company in 2015, Dean T. Smith, Auburn, CA, had previously owned a
23 freight brokerage/logistics company which provided logistics services to the Defense Logistics
24 Agency in the Pacific region. Smith later sued me and the company in the Eastern District of
25 California for fraud 19-cv-1918. The case is currently awaiting a May 13, 2022, hearing on my
26 motion to dismiss with prejudice. Notably, the plaintiff's legal counsel did virtually no due
27 diligence prior to filing the case and provided no shred of evidence of any fraud in the initial
28 complaint, was ordered by the court to redraft due fatal flaws as originally and has to date not
29 filed a shred of evidence in response to my 200 plus page answer. It is certainly possible that the
30 entire investment made by Smith was intended primarily to entrap, delay, and deny me the
31 authentic opportunity to develop this business in the manner I intended. This could be yet
32 another element of the defendants' overall corrupt enterprise alleged in my DC complaint. (22-
33 cv-00596 mentioned above).
- 34 2. As previously mentioned, my prior experiences in the national security space from 1996 to 2004,
35 including overall management of a variety of projects including the engineering design work on
36 the USAF/Boeing Delta IV rocket assembly plant; at Sea-Tac and Anchorage International
37 Airports (not national security but viewed through a different lens after the events of
38 9/11/2001); at the secured yard Puget Sound Naval Shipyard in Bremerton, Washington, where I
39 and another of my engineering company's employees were left standing alone in a vacated
40 waterfront shop building next to a green-tarped shipping pallet said to be a pump from a
41 nuclear submarine (one of the Navy's most closely guarded pieces of technology, extremely
42 sensitive); and my sales call/tour at Aerodyne in Folsom, California, where I was given a tour of
43 an advanced fighter forward fuselage assembly operation for a next-generation fighter aircraft,

again in a secured area with no other persons present, and of no relevance to the purpose of my supposed sales call. These contacts and others were previously reported by me in prior documents submitted. I also repeat here I have never been a government employee, a military member, or held a security clearance in the national security space.

3. It is also notable that a key consultant (Gregg Crossgrove, a primary resident of Maricopa County, Arizona and part-time resident of Idaho) in the development of our above referenced organic produce company in Arizona was the brother (according to Gregg Crossgrove, not verified by me) of the President of a California produce company controlled by the family of Devin Nunes, the former Congressman and member of the House Intelligence Committee (this relationship was previously disclosed to OIG in my original submission). Further, a great deal of the effort in Arizona to develop this organic produce business occurred in Maricopa County and Pinal County from 2016, late in the tenure of Joseph Arapaio as Maricopa County Sheriff. This tie-in is speculation on my part at this point but is a connection which cannot responsibly be ignored in any inquiry in this long-running matter. It will be the subject of discovery in my civil RICO/KKK Act complaint (22-cv-00596 as above).

18 Good day – This is a follow up to my letter dated March 21, 2022, and hand delivered by me to SDNY
19 Security at One St. Andrews Plaza. This letter is also hand delivered there.

20 Please note that the italicized text below and my closing comments modify the contents of portions of
21 that March 21st letter based upon additional analysis I have undertaken since that date.

22 Further relevant leads for evaluation:

- 23 1. I was the principal shareholder of a now-defunct Colorado corporation Winnett Perico, Inc. One
24 of the investors in that company in 2015, Dean T. Smith, Auburn, CA, had previously owned a
25 freight brokerage/logistics company which provided logistics services to the Defense Logistics
26 Agency in the Pacific region. Smith later sued me and the company in the Eastern District of
27 California for fraud 19-cv-1918. The case is currently awaiting a May 13, 2022, hearing on my
28 motion to dismiss with prejudice. Notably, the plaintiff's legal counsel did virtually no due
29 diligence prior to filing the case and provided no shred of evidence of any fraud in the initial
30 complaint, was ordered by the court to redraft due fatal flaws as originally and has to date not
31 filed a shred of evidence in response to my 200 plus page answer. It is certainly possible that the
32 entire investment made by Smith was intended primarily to entrap, delay, and deny me the
33 authentic opportunity to develop this business in the manner I intended. This could be yet
34 another element of the defendants' overall corrupt enterprise alleged in my DC complaint. (22-
35 cv-00596 mentioned above).

36
37 *Dean T. Smith owned a freight brokerage business which provided extensive services to the*
38 *Defense Logistics Agency in the Pacific region, including Japan, Korea, and elsewhere in 2015, the*
39 *year his initial investment was made. Notably, neither the Army nor CIA has even acknowledged*
40 *my FOIA and PA information requests. Both have engaged in well-documented involvement in*
41 *the search for the ultimate non-lethal weapon since at least World War II. This ultimate non-*
42 *lethal weapon is the ability to directly manipulate a person. Non-lethal weapons research and*
43 *development units of other elements of Department of Defense, including the services, DARPA,*

44 *and others, have been similarly engaged for decades. It is most certainly possible there was and*
45 *is a connection between the investments made by or through Smith and these elements of DOD*
46 *or some other police powers or intelligence entity within the federal government as part of an*
47 *effort to extend and perpetuate my subjugation, engage in entrapment, and perpetuate the*
48 *coverup of the criminal acts and violations of civil and constitutional rights. It certainly deserves*
49 *close scrutiny and will be an element of discovery in my civil litigation.*
50

- 51 2. As previously mentioned, my prior experiences in the national security space from 1996 to 2004,
52 including overall management of a variety of projects including the engineering design work on
53 the USAF/Boeing Delta IV rocket assembly plant; at Sea-Tac and Anchorage International
54 Airports (not national security but viewed through a different lens after the events of
55 9/11/2001); at the secured yard Puget Sound Naval Shipyard in Bremerton, Washington, where I
56 and another of my engineering company's employees were left standing alone in a vacated
57 waterfront shop building next to a green-tarped shipping pallet said to be a pump from a
58 nuclear submarine (one of the Navy's most closely guarded pieces of technology, extremely
59 sensitive); and my sales call/tour at Aerodyne in Folsom, California, where I was given a tour of
60 an advanced fighter forward fuselage assembly operation for a next-generation fighter aircraft,
61 again in a secured area with no other persons present, and of no relevance to the purpose of my
62 supposed sales call. These contacts and others were previously reported by me in prior
63 documents submitted. I also repeat here I have never been a government employee, a military
64 member, or held a security clearance in the national security space.
65
- 66 3. It is also notable that a key consultant (Gregg Crossgrove, a primary resident of Maricopa
67 County, Arizona and part-time resident of Idaho) in the development of our above referenced
68 organic produce company in Arizona was the brother (according to Gregg Crossgrove, not
69 verified by me) of the President of a California produce company controlled by the family of
70 Devin Nunes, the former Congressman and member of the House Intelligence Committee (this
71 relationship was previously disclosed to OIG in my original submission). Further, a great deal of
72 the effort in Arizona to develop this organic produce business occurred in Maricopa County and
73 Pinal County from 2016, late in the tenure of Joseph Arpaio as Maricopa County Sheriff. This
74 tie-in is speculation on my part at this point but is a connection which cannot responsibly be
75 ignored in any inquiry in this long-running matter. It will be the subject of discovery in my civil
76 RICO/KKK Act complaint (22-cv-00596 as above).
77

78 *On a hunch, I reviewed photographs of Joe Arpaio available on the internet. Mr. Arpaio, the then*
79 *current Sheriff of Maricopa County, Arizona was the person I knew as Greg Crossgrove. It is*
80 *probable that all the other persons involved in the Arizona organic farming opportunity I sought*
81 *to develop, including my own company management team and the recruiters who introduced*
82 *them, as well as the potential investors, and the fraudulent investment documents signifying a*
83 *\$52 million investment in the company, among other things, were the result of a systematic*
84 *police powers operation which repeated the starve-out and entrapment efforts against me*
85 *previously undertaken while I was a resident of the State of Washington and Performa partner.*
86 *While I am unable at this time to identify which other police powers agencies might have been*
87 *involved, the Maricopa County Sheriff's Office was a prime mover in this episode of the*

abridgement of my civil and constitutional rights. It is further likely that the Nunes connection was part of this effort and there was no actual family relationship, rather a political connection.

A separate element of the Arizona organic produce project was the involvement of Ray Sullivan, an attorney in Maryland, who had previously worked in U.S. Customs and claimed a close professional relationship with U.S. Trade Representative Peter Navarro's office. Mr. Sullivan was introduced to me by a former Merrill Lynch investment banker, Charles Jackson.

Mr. Jackson, now supposedly deceased, had ostensibly been a key executive in Mexico City and traveled extensively in Latin and South America. It is unclear what his actual role in that region may have been, but it is curious that he worked with me from near the inception of the organic produce company, was notably unsuccessful in raising funds for the company despite his extensive contacts.

Mr. Jackson fits nicely into a chain of international connections during my "executive management experiences" which stretch back to my involvement with the CIA's civilian cover project manager for the South Africa ATM network. This project plumbed the South African banking system prior to the embargo of South Africa by the U.S. and other countries while I was a Consulting Manager at Deloitte, my initial employer after graduate school. Several members of the CIA's Saudia Airlines project team also originated cover in Deloitte's Seattle office during that time.

It is quite probable that my sequence of directed employment was specifically managed in accordance with the design, direction, and intent of the covert project and criminal enterprise which directed my fate, my income, my destiny, and perpetuated my subjugation, among others, by the United States.

Further, it is likely that this series of interventions drove certain of my behaviors and those of close family members and may well have been the root cause of the destruction of my two marriages. This corrupt criminal enterprise is likely the root cause of the destruction of my relationships and directly endangered others, such as my first spouse in the potentially fatal sleep inducement attempt while driving eight feet from sea cliffs north of Vancouver, British Columbia on Howe Sound.

It is also probable that other persons died in such activities, and that some relationships and families may be founded upon these types of acts intended to benefit certain people with access, knowledge, and/or the ability to manage these types of criminal interventions and manipulations.

A full accounting is required of this entire continuing criminal enterprise which has hidden for all these years behind the fraudulent labels of police powers, state secrets, and so-called national security.

Cointelpro, involving a two decades of felonies, civil rights, and constitutional rights violations, and may have led to inter-group assassinations, should have resulted in the imprisonment of J. Edgar Hoover. Mr.

Hoover retired on a full pension. MKULTRA, and related projects included crimes against military personnel, civilians, and at least one civilian death over more than two decades. Together with the associated destruction of evidence, it should have resulted in the imprisonment of Richard Helms, other senior CIA managers and employees, and some senior members of the Army command who were directly involved, among others. Mr. Helms was confirmed as Ambassador to Iran instead. The Army lab in question suffered no consequences after the program was discovered and disbanded.

The rule of law in the United States? The full enforcement of the plain text of the Constitution and the United States Code in a fair and even-handed manner? Or with liberty for just us, et al? Is the Justice Department actually up to the challenge? Or will malice aforethought and purpose of evasion prevail in the so-called national security and police powers space? Like it did in the *United States v Reynolds* (1953) SCOTUS opinion, which was based upon a perjured affidavit intended to hide simple negligence which had absolutely nothing to do with national security. A convenient refuge for corruption, criminality, malice, and negligence, and used to continue to deny U.S. persons the right to redress of their grievances. It certainly harbors and reinforces a sense of imperial impunity among certain elements of the government which use it to hide their criminal, malicious, and negligent conduct behind the cloak of "national security."

I am hopeful. But I am also known a world-class optimist.

A realist will tell you that time will tell if the United States actually has the will to realize the plain meaning of it's the document which created it, the Constitution, and to equitably and fairly enforce the U.S. Code within its own departments and the several states. There is considerable room for doubt.

19 level employee.

20 At the time, and into the recent past, I was engaged in a series of efforts to raise funds for a series of
21 companies I was attempting to establish. My last letter detailed the fraudulent interference in this effort
22 by the Maricopa County Sheriff Joe Arpaio which occurred some years after my contacts with Daniel
23 Weiner.

24 On knowledge and belief, it is likely the Mr. Weiner in question was actually the Chairman of the
25 Litigation Department at Hughes Hubbard and Reed, New York, NY misrepresenting himself as an
26 employee of Arlon Group LLC.

22 Good day – This is a follow up to my series of letters and complaint previously hand delivered
23 by me to SDNY Security at One St. Andrews Plaza.

24 Over the weekend, I noticed a small item in the Washington Post indicating William
25 Webster, former Director of FBI and CIA is selling his Washington, DC residence. I explored the
26 notion he could have been the person I encountered in Spring 1979, dressed in stark contrast to
27 the tourists in the rotunda of the East Building of the National Gallery of Art. That was not the
28 case. It prompted me to look further at photos of FBI and CIA Directors from that era.

29 If CIA Director Stansfield Turner was between 6 feet 2 inches and 6 feet 5 inches tall,
30 there is a high probability that he was the man I saw that day in the Spring of 1979. He was
31 dressed in a dark blue suit, white shirt, and tie whose color I do not recollect. The age was right,
32 the basic physical shape and degree of fitness was right. I recognize that would describe
33 hundreds of men in DC that day, but the face shape was and is quite distinctive in my memory.
34 His face bore a very slight smile as he looked me directly in the eyes. Not knowing his
35 intentions, I simply returned the look without expression and passed about four feet away as I
36 continued my walk from the west wing of the East Building through the rotunda in the direction
37 of the Mall entrance to the building. Both of us were slightly to the south of the rotunda status
38 when I passed by him.

39 At the time, I was completing graduate school at Washington State University. I arranged
40 a recruiting trip to GTE in Stamford, CT so that I could visit Washington, DC during our Spring
41 Break before I returned to complete my MBA studies in Pullman, WA.

42 As CIA Director under President Carter from 1977-1981, Admiral Turner did a reduction
43 in force in the covert operations of CIA, choosing instead to emphasize the development of
44 technologies as the primary mechanism for future intelligence operations. Many years later,
45 CIA's newly formed venture capital unit, known as In-Q-Tel, made a presentation at an AeA
46 national board meeting I attended in Washington, D.C. AeA was then the leading technology
47 trade association. Formed by the founders of Hewlett-Packard, it included Intel, Microsoft,
48 Motorola, and other key companies in the technology industry.

49 My next likely encounter with CIA was while employed at Seattle, Washington office of
50 Deloitte, Haskins & Sells between 1979 and 1986. Now known as Deloitte, I was a CPA auditor
51 for several months in 1979-1980, followed by about six years as a management consultant. For
52 whatever reason, I was the only person on the sidewalk on the north side of the Seattle US
53 District Courthouse when FBI and the Marshals Service brought a terror suspect to the secure
54 underground garage entrance at that location. Peculiar.

55 The Deloitte Seattle office was also used to provide a cover for the CIA's involvement
56 with Boeing Corporation and others, in the installation of the ATM network for the South Africa
57 banking system, shortly before apartheid sanctions were declared by the United States. The
58 office was also home base for two consultants, including a partner level individual, who were on
59 site at Saudia Airlines for an extensive computer software implementation in the early to mid-
60 1980s around the same time the King of Saudi Arabia's personal Boeing 747, manufactured in
61 Everett, Washington, was found to have electronic bugs in the headboard of the King's bed.

62 I note that neither CIA nor the Army have ever formally acknowledged my FOIA/Privacy
63 Act information requests made in the past few months. This is required by law. See enclosures
64 for more details of these requests.

65 Both CIA and Army engaged in LSD experimentation and worked together on some of
66 these projects. MKULTRA and a series of related projects included illegal surreptitious LSD
67 dosing of unknowing soldiers and civilians. In the initial stages of the program, it included the
68 1953 death of contract researcher Frank Olson. Olson shared a Penn Station, New York hotel
69 room with Robert Lashbrook, the personal assistant to the CIA chemist directing that program.
70 NYPD found Lashbrook sitting on the toilet when they entered the room. During an independent
71 post interment autopsy in 1994, the team (with one exception) assessed that Mr. Olson had been
72 the victim of blunt force trauma he received prior to his exit from the tenth floor window of the
73 Hotel Statler (15 Penn Plaza). These details are from Wikipedia, which provides an extensive
74 biography of Olson and the surrounding events.

75 The LSD experiment programs continued into the 1970s under Director Richard Helms

(1966-1973). When Director Richard Helms terminated the program in 1973, he ordered the records destroyed. CIA employees involved in the program developed a mass attack of amnesia, and the criminal abuse of soldiers and citizens, the felonious destruction of evidence, and an investigation of other wrongdoing was not pursued by the Justice Department. These events are officially documented in the 1977 Rockefeller Commission report which was formed to review some accounting records the evidence destroyers had missed. CIA has never renounced its stated goal of pursuing the ultimate weapon, the ability to engage in remote mind control of its own agents and of adversaries, including erasing memories, managing thought and event sequences, and manufacturing particular outcomes.

Instead of being properly prosecuted for destruction of evidence, and of other criminal conduct within the national security space, Mr. Helms was confirmed as Ambassador to Iran in 1973. No person was ever charged.

This same outcome is well documented in the Church Committee report of 1975 as relates to the FBI Director and his principal deputy for Cointelpro, which criminally abused people seeking to enforce their constitutional rights and the rights further guaranteed by the Civil Rights Act of 1964. RICO was first enacted by Congress in 1970, though the Constitution, Bill of Rights, and the 14th and 15th Amendments had been in place for some time by then. Any of them provided sufficient basis for indictment and prosecution, rather than full pension in retirement.

So, I guess out of sight out of mind is considered the just outcome for high-ranking unindicted felons in the United States? Is that still the case?

Re: NOTICE OF DUTY TO PRESERVE EVIDENCE

Good day:

Dennis Sheldon Brewer has filed a lawsuit against various law enforcement and intelligence agencies. To date, your FOIA/PA unit has repeatedly failed to acknowledge in any way my information request and is therefore more likely to be named in this lawsuit. The preservation of all documents for the duration of the litigation or until you are notified in writing you are not subject to this litigation is required under federal law and the Rules of Civil Procedure of the US District Court.

Pursuant to the federal Rules of Civil Procedure, every party to a lawsuit has a duty to preserve all evidence which could be relevant to the suit. This includes the duty to preserve all electronic and paper-based evidence, such as notes, emails, communication logs, recordings, plans, analyses, and other relevant materials discussing the incidents or related to matters at issue in the suit. The suit contemplates a broad and durable set of civil rights violations, constitutional rights violations, wrongful process, conduct not permitted under Article I Section 8 of the Constitution, and eminent domain violations. Statutes cited or to be cited in conjunction with the contemplated federal Complaint include the Klu Klux Klan Act, civil RICO, and FTCA.

This duty to preserve evidence is broad and extends to all documents, regardless of whether the document is stored electronically (such as email) or in hard-copy and regardless of the type of document. For example, reports, spreadsheets, photographs, and videotapes are all considered documents that must be preserved. Furthermore, the duty to preserve this documentary evidence extends to all documents in existence as of the time you reasonably anticipated this litigation. This Notice covers information retained on all computers, servers, server back-up systems, CDs, tapes, PDAs, cell phones, and any other device on which information may be stored electronically.

To avoid civil or criminal sanctions by the Court, ensure that all relevant documents are preserved, and no alterations are allowed. Furthermore, advise all such persons that any regularly scheduled and/or automatic deletion of email or other electronic documents must be discontinued with respect to any relevant data. In addition, any document destruction (such as shredding of documents) must cease with respect to any relevant documents. All relevant documents, both electronic and paper, must be preserved for the duration of this litigation.



22 Good day – This is a follow up to my series of letters and complaint previously hand delivered
23 by me to SDNY Security at One St. Andrews Plaza.

24 Over the course of two weeks in early January 2009, I noted two flights of Canada geese
25 over my Cliffside Park, New Jersey residence. Each flight was comprised of about 6 to 8 birds
26 which flew from the northeast directly toward my apartment and passed about 20 feet above the
27 apartment. On January 15, 2009, US Airways flight 1549 passed in front of the living room
28 window on the east side of my Cliffside Park residence at an elevation of around 1200 to 1500
29 feet above sea level. The aircraft was in a glide toward an emergency landing in the Hudson
30 River after a simultaneous bird strike congested the rotors on both engines causing simultaneous
31 flameouts. These events would be unremarkable and of no particular interest in association with
32 each other to most people.

33 However, over the years prior and since, I have been exposed to a variety of what I will
34 call “trailers,” as they are similar in content to the movie trailers you see in a movie theater.
35 These trailers are transitory event sequences played out in public spaces using commonly
36 available street scenes, people, and props. To all but the initiated, they would go completely
37 unnoticed. They are used in psychological operations and can also be used to communicate
38 certain information and/or instructions to those who understand them. Since they are fleeting
39 street scenes, the target must witness the entire sequence to understand the intent of the visual
40 communication. If you are not familiar with these elements of tradecraft, please verify their

41 existence and use with someone in your contacts who does or has previously worked human
42 intelligence or counterintelligence.

43 Simply put, this set of scenarios is an extremely reliable indication that the event
44 sequence involving the collision of US Airways Flight 1549 with birds at an altitude well above
45 the altitudes where these birds typically fly was a planned event, not an accident. There is a very
46 high probability the two unusual flights of Canadian geese, exhibiting behavior not otherwise
47 seen either before or after the 1549 Hudson River water landing, were a pre-planned trailer, not a
48 coincidence.

49 I have only ever read press reports of the 1549 incident and witnessed it's southbound
50 glide down the Hudson River airspace from a point a few hundred yards north of my line my
51 living room window until the aircraft disappeared from my sight a couple of miles downriver
52 behind some buildings on the west side of the Hudson River. I have never read the NTSB report
53 so I would have no reason to understand the technical details associated with this event and
54 reproduce those details in some way here. I earned a single engine land FAA pilot's license in
55 the 1970s, have a more than passing interest in aviation, and some experience with aviation
56 facilities, equipment, and operating practices.

57 I witnessed these events at [REDACTED] Avenue, Apartment 5, Cliffside Park, New
58 Jersey, between approximately January 2, 2009, and the January 15, 2009, water landing of
59 1549. I occupied the residence between August 2007 and October 2010. Apartment 5 is the top
60 floor apartment on the east side of this seven unit apartment building. I can offer no further
61 details on this event sequence.

62 This is the same address where FBI removed a foreign national for deportation during the
63 period I resided there, according to the landlord, as previously reported. These events have no
64 known relationship to each other.

65 I have enclosed a copy of my last letter dated April 11, 2022, so you can identify the
66 sequence of letters this letter relates to more easily.

24 This is a follow up to my series of letters and complaint previously hand delivered by me to
25 SDNY Security at One St. Andrews Plaza. My most recent letter was dated May 16, 2022, regarding U.S.
26 Airways flight 1549 Hudson River landing on January 15, 2009, and certain events I observed previously.

27 **Cliffside Park - Anomalies between June 2008 and October 2010**

28 Residential address: [REDACTED] Avenue, #5, Cliffside Park, NJ 07010 (August 2007-October
29 2010)
30

31 As reported by my landlord, Marc Chalom, FBI allegedly removed a non-resident alien from the
32 7 unit building I lived in on top floor facing east toward Manhattan sometime during my tenure. So, it is
33 likely the building was under some form of surveillance at the time, even if I was not a target at that
34 moment. As confirmed by NYPD, it is likely I was also under surveillance as part of an ill-conceived
35 counterterrorism operation at the time as well and that may have been part of the reason I was
36 moved/trafficked from Pine Street Inn (homeless shelter in Boston) toward “selecting” that Cliffside
37 Park, NJ building as I became employed at Establish, Inc, in Fort Lee, NJ from August 2007 until
38 approximately June 2008.

39 In early September 2007, I went to London with other members of the Establish Fort Lee team
40 (including one who had been transferred to Fort Lee from Shanghai before I arrived) for a week.

41 Subsequently, I worked on a bogus project (S&OP software selection) at PPG headquarters in Pittsburgh,
42 PA, and another bogus project (SAP readiness) at Clipper Windpower in Carpinteria, CA and Cedar
43 Rapids, IA until shortly before my termination. My employment by Establish was terminated about six
44 weeks after I refused to invest \$25,000 in the company.

45 After my termination from Establish, the following events occurred:

- 46 1. Image of 737 at high angle of attack about three or so miles to the north (based upon image
47 size) above the Palisades with open bay on bottom of fuselage. Aircraft nose was oriented
48 toward the Hudson River, belly tilted in the direction of my view (what would be a very high
49 angle left turn from an abnormally low altitude). Low altitude and high angle of attack would
50 have required full power or nearly so to avoid stall, but there was no such engine noise. Aircraft
51 image was a single color (medium dark gray) and located in a place and in a position no air
52 traffic controller would have permitted. Was apparently a visual image/illusion created in my
53 visual system.
- 54 2. As mentioned in my last letter dated two flights of Canadian geese from approximately 30
55 degrees to the northeast of the west bank of the Hudson River between approximately January
56 1 and January 12, 2009.
- 57 3. US Airways flight 1549 lands in the Hudson River on January 15, 2009.
- 58 4. Secret Service Presidential limousine (beast) run-by in Obama era on Palisade Avenue directly
59 east of building location heading south.
- 60 5. Audible messages three times in about ten minutes alleged to be from United States Secret
61 Service sent me to the building basement twice, I ignored the message on the third repetition.
62 Two white females, 30-50 age range, were standing at the residence door in the stairwell
63 immediately below my unit #5. One appeared to reside in that unit based upon that individual
64 standing inside the unit (and other contact I had with that person two other times when she
65 complained about audible footfall noise by me in my unit keeping her awake). The other female
66 was apparently acting as a guest standing immediately outside the door. They both turned to
67 observe me on my first trip to the basement, no words were exchanged. At present, I believe
68 they were likely two undercover officers and were expecting me to come down the stairs at that
69 time as they were there at that moment. There was only one other time I observed that door
70 open during the entire time I lived there (during the complaint mentioned above). I have no idea
71 which agency these plainclothes officers were employed by.

72 The Canadian geese flights directly preceded the US Airways 1549 Hudson River landing event in
73 time. It is likely that the 737 image was prior to the Canadian geese sightings but I am not absolutely
74 certain of this element of the sequence. While not intending to disparage anyone, I note the 1549 water
75 landing occurred five days before the end of the Bush administration and about a month prior to the
76 end of Gen. Hayden's tenure at CIA while he was maneuvering to avoid being replaced by Leon Panetta.
77 The pace and intensity of adverse events in my remaining tenure declined after Hayden's departure. The
78 activities including various interventions continued until I completed writing and filed a Complaint in
79 Newark federal court. As I completed this Complaint, I was replaced by a landlord removal (termination,
80 not a legal eviction) as a resident of that Cliffside Park building and ended up in a regional hospital due
81 to stress in early October 2010.

82 For your information, I am currently appealing the preemptory dismissal of 22-cv-00996 in DC
83 Circuit Court as noted in enclosure.

23 Good day –

24 This is a follow up to my series of letters and complaint previously hand delivered by me to
25 SDNY Security at One St. Andrews Plaza. My most recent letter was dated June 13, 2022, regarding U.S.
26 Airways flight 1549 Hudson River landing on January 15, 2009, and certain events I observed previously.

27 **US Airways Flight 1549, January 15, 2009**

28 One important additional detail which is likely relevant to this particular scenario is:

29 One of the visual images conveyed to me during the months between July 2008 and December
30 2008 while I took my daily walk from my apartment to the Starbucks located at 457 River Road in
31 Edgewater Commons was a shrouded gray building image which seemed to appear and disappear as I
32 walked down Gorge Road (southbound toward Starbucks) toward River Road and as I walked along River
33 Road (southbound on my return from Starbucks). There is a 160 degree change in direction on this walk
34 so I was able to see this approximately 400 foot tall image on the Palisades in these places on my walk to
35 and from the Starbucks. I place the image about 2.5 to 3 miles south of my position during the walk and
36 on the eastern edge of the Palisades, which are about 350 feet above the surface of the Hudson River.

37 Given my 40 plus years of experience with these types of episodes, which dramatically increased
38 in intensity following the events of 9/11/2001, I interpret this particular sequence in 2008 to early 2009
39 as an attempt to signal an attempt to psychologically associate an attachment to those events. This is

likely out of some sense of anger, indignation, or simple psychopathy, by some entity or team among the Defendants in my current Complaint related to Brain Remote Management Technology (BRMT) manipulation and psychological operations undertaken against me (and likely others) as part of an intelligence community effort. The identifiable Defendants are named in my original Complaint 22-cv-996 in DC District Court and include the United States and various police powers agencies. Please see that Complaint and the DC Circuit Court brief 22-5158 for further details.

These are projected images to be perceived as seen in the eye, not necessarily a literal projection which any person could see. I saw a smaller similar image at the Port Authority Bus Terminal in Manhattan during my return from the SDNY NYC office on Monday, June 13. That image appeared to be a child (of mid-thigh height) walking next to a Black female on the 200 terminal level enroute between the escalators and the eastern route to the restrooms located at the 200 level in the south building near the crossover to the north building. It appeared in color (unlike the previous gray images in the 2008-2010 period) for about 0.7 seconds. There was, of course, no child next to the Black female when we passed. There was a Black male, tall and stocky, who held slightly open his left lapel on his black suit jacket on my right as we passed.

False Sales Leads and Commercial Starve-Out

One other event of note: While watching CNN in the early 2000s, I noted a warehouse fire in the Atlanta, Georgia area. This was the principal warehouse of a subsidiary of Great Lakes Chemical, Bio-Control, which manufactures and distributes bromine, primarily for water treatment, such as swimming pools. Bromine is highly flammable and combustion gases are poisonous. I had a professional relationship with Zoe Schumaker, CIO of Great Lakes Chemical, through my consulting firm, Performa. I and my business partner, Darrell Pray, made a sales presentation to a Bio-Control information technology team, at their headquarters, which Ms. Schumaker also attended, during the weeks prior to that fire. I followed up with the primary local contact to offer assistance as we had extensive warehousing and logistics experience as well. The offer was declined.

Though I did not realize it at the time, this professional relationship was the result of what was likely a Boston Field Office originated stave-out operation which ran across various FBI Field Offices. These types of follow-on incidents may have occurred in other such "commercial opportunities" presented by the cover company Technology Sales Leads, then located in a small downtown Boston office, during that period (2003-2005). It is highly probable that all those sales contacts were actually FBI operations and part of a commercial starve-out operation intended to destroy my personal cash flow and ability to maintain my income and personal assets, including my personal residence, vehicle, and so forth. Evaluation of this sequence of events, reported in a letter dated March 25, 2022 (enclosed) to the Assistant Inspector General for Investigations, by a team not institutionally attached to FBI, is necessary to pursue justice.

Possible Use of BRMT in Q Train Murder on Manhattan Bridge May 22, 2022

This is very speculative, and will seem quite far-fetched to most people, probably striking many as delusional. However, I recommend you determine if Mr. Andrew Abdullah, the indicted suspect, could possibly have been influenced by BRMT manipulation. The association is very loose and very speculative, but his pacing behavior prior to the actual stranger murder, the Q train association, and the occurrence on the Manhattan Bridge, all strike me as peculiar and perhaps a signature event following

my discussion of the MKUltra code name some days prior. MK was/is the technical services branch of CIA, equivalent to the character "Q" (MI-6 technical services) in the James Bond movie series. Ultra was the national security classification level of that operation (ultra-secret) which was known only to the CIA Director and those directly involved in that 1953-1972 era program of drug experiments on some knowing participants and many unknowing participants, including at a CIA brothel near Las Vegas and on Army personnel.

A 1953 death at a hotel across from Penn Station was later determined by an independent exhumation to have been a hotel room bludgeoning followed to a ten floor fall to the sidewalk of a possible whistleblower, Frank Olson, a CIA contract researcher on MK Ultra at the time. His roommate in that double bed hotel room was the personal assistant of the MKUltra program's Director.

The program was investigated by the Senate's Church Committee and the Rockefeller Commission in 1975. A comparison of my experiences with the findings of both of those Committees is included in the DC Complaint exhibits (22-cv-996).

The balance of this letter is a repeat of my June 13 letter for your convenience:

"Cliffside Park - Anomalies between June 2008 and October 2010

Residential address: [REDACTED] Avenue, #5, Cliffside Park, NJ 07010 (August 2007-October 2010)

As reported by my landlord, Marc Chalom, FBI allegedly removed a non-resident alien from the 7 unit building I lived in on top floor facing east toward Manhattan sometime during my tenure. So, it is likely the building was under some form of surveillance at the time, even if I was not a target at that moment. As confirmed by NYPD, it is likely I was also under surveillance as part of an ill-conceived counterterrorism operation at the time as well and that may have been part of the reason I was moved/trafficked from Pine Street Inn (homeless shelter in Boston) toward "selecting" that Cliffside Park, NJ building as I became employed at Establish, Inc, in Fort Lee, NJ from August 2007 until approximately June 2008.

In early September 2007, I went to London with other members of the Establish Fort Lee team (including one who had been transferred to Fort Lee from Shanghai before I arrived) for a week. Subsequently, I worked on a bogus project (S&OP software selection) at PPG headquarters in Pittsburgh, PA, and another bogus project (SAP readiness) at Clipper Windpower in Carpinteria, CA and Cedar Rapids, IA until shortly before my termination. My employment by Establish was terminated about six weeks after I refused to invest \$25,000 in the company.

After my termination from Establish, the following events occurred:

1. Image of 737 at high angle of attack about three or so miles to the north (based upon image size) above the Palisades with open bay on bottom of fuselage. Aircraft nose was oriented toward the Hudson River, belly tilted in the direction of my view (what would be a very high angle left turn from an abnormally low altitude). Low altitude and high angle of attack would have required full power or nearly so to avoid stall, but there was no such engine noise. Aircraft image was a single color (medium dark gray) and located in a place and in a position no air traffic controller would have permitted. Was apparently a visual image/illusion created in my visual system.
2. As mentioned in my last letter dated two flights of Canadian geese from approximately 30 degrees to the northeast of the west bank of the Hudson River between approximately January 1 and January 12, 2009.
3. US Airways flight 1549 lands in the Hudson River on January 15, 2009.
4. Secret Service Presidential limousine (beast) run-by in Obama era on Palisade Avenue directly east of building location heading south.
5. Audible messages three times in about ten minutes alleged to be from United States Secret Service sent me to the building basement twice, I ignored the message on the third repetition. Two white females, 30-50 age range, were standing at the residence door in the stairwell immediately below my unit #5. One appeared to reside in that unit based upon that individual standing inside the unit (and other contact I had with that person two other times when she complained about audible footfall noise by me in my unit keeping her awake). The other female was apparently acting as a guest standing immediately outside the door. They both turned to observe me on my first trip to the basement, no words were exchanged. At present, I believe they were likely two undercover officers and were expecting me to come down the stairs at that time as they were there at that moment. There was only one other time I observed that door open during the entire time I lived there (during the complaint mentioned above). I have no idea which agency these plainclothes officers were employed by.

The Canadian geese flights directly preceded the US Airways 1549 Hudson River landing event in time. It is likely that the 737 image was prior to the Canadian geese sightings but I am not absolutely certain of this element of the sequence. While not intending to disparage anyone, I note the 1549 water landing occurred five days before the end of the Bush administration and about a month prior to the end of Gen. Hayden's tenure at CIA while he was maneuvering to avoid being replaced by Leon Panetta. The pace and intensity of adverse events in my remaining tenure declined after Hayden's departure. The activities including various interventions continued until I completed writing and filed a Complaint in Newark federal court. As I completed this Complaint, I was replaced by a landlord removal (termination, not a legal eviction) as a resident of that Cliffside Park building and ended up in a regional hospital due to stress in early October 2010.

Suspect in fatal Q train shooting charged with murder

The man accused of fatally shooting another subway rider in an unprovoked attack on board a Q train on Sunday has been taken into custody and charged with murder in the second degree and criminal possession of a weapon in the second degree, the NYPD said Tuesday.

Andrew Abdullah, 25, was taken into custody in connection with Daniel Enriquez' death Tuesday afternoon, police said.

Do you know where Andrew Abdullah is? He's wanted for shooting a fellow New Yorker in the chest on Sunday, May 22nd, causing the victim's death, while on a "Q" train in Manhattan.

Enriquez, 48, was **shot and killed by a gunman** as he was riding the Q train from Brooklyn into Manhattan Sunday morning, police said.

According to Chief of Detectives James Essig, Abdullah had eight prior arrests and a criminal record that extends back to August 2016, and was a member of the Nine Block gang.

Flanked by Mayor Eric Adams, Chief of Transit Janno Lieber and other NYPD officials, Police Commissioner Keechant Sewell blasted the state's criminal justice system, and called for reforms to its bail laws.

"The murder of Daniel Enriquez was every New Yorker's worst nightmare," Sewell said.

"The violence on the Q train last Sunday morning was committed by another repeat offender who was given every leeway by the criminal justice system," Sewell added. "We cannot and will not stand for it."

"We got a killer off our streets," Adams said, "but far too many killers are back on our streets through a revolving door criminal justice system."

Essig said a regional task force received word Monday night that Abdullah intended to turn himself in.

"[Abdullah] was given ample time to turn himself in," Essig said. "And [the Regional Task Force] found him in front of 49 Thomas today and brought him in."

In a statement released Tuesday afternoon, The Legal Aid Society, which is serving as counsel for Abdullah, said it had been "actively speaking with the New York Police Department and the New York County District Attorney's Office to negotiate [Abdullah's] surrender," while calling the circumstances surrounding his arrest "completely inappropriate and unwarranted."

"Before Andrew Abdullah could voluntarily surrender himself to the local precinct, he was needlessly ambushed out front of our Manhattan Trial Office by City Marshalls [sic], denied of his opportunity to first consult with counsel," the statement said.

Abdullah "is presumed innocent and entitled to counsel and a robust defense," it went on to say.


"At this preliminary moment in the case, we caution New Yorkers from rushing to judgment, as we are just beginning our investigation and reviewing evidence," it added. "Mr. Abdullah deserves vigorous representation from his defense counsel and that is what The Legal Aid Society will provide."

Adams also extended his condolences to those affected by a mass shooting in a Teas elementary school, where 14 children and one adult were killed Tuesday.

"Also want to put my heart out to the family members in Texas elementary school. A mass shooting," he said.

"These shootings are happening far too often. And the response is not meeting the level of threat and danger that we are experiencing. Not acceptable. We will never surrender our streets to violence."

Navarro/Sullivan Connected by Sullivan

Raymond Sullivan was the corporate lawyer for a succession of entities I was stymied from securing sales, including Winnett Perico which offered organic produce to Walmart and Kroger. Both these entities headquarters city offices were used as meeting places. Mr. Sullivan was also involved with Winnett Cattle Company and Sheldon Beef which, among other things, attempted to buy an Idaho feedlot which sold fed cattle to JBS in Orem, Utah. Mr. Sullivan received only one significant cash compensation payment of \$10,000 from funds which were available in 2015 from a \$100,000 investment by Dean Smith, Auburn, California, and some stock offered in 2019 for his services over the years he worked with these entities, despite a considerable amount of effort on his part.

Mr. Sullivan reported he had close ties with Mr. Peter Navarro's Office of Trade Representative in the executive branch. This occurred as Sheldon Beef worked to secure a Walmart China contract and other Chinese and Asian beef sales opportunities after the Chinese eliminated trade barriers to U.S. beef in 2017.

40 **Connections Potentially Involving Former Sherriff Arpaio and U.S. Intelligence**

41 Mr. Sullivan originally worked in U.S. Customs, then for prominent Washington, DC law firms,
42 before starting his private practice. He was introduced to me by an online acquaintance I made, Charles
43 Jackson, who was at least allegedly assisting me to raise funds for the entities mentioned above. I spoke
44 frequently by email and phone with Mr. Jackson over several years. Mr. Jackson claimed a residence in
45 Columbus, Ohio. I met him in person only once – in Maricopa County, Arizona. So, it is also possible that
46 Mr. Jackson was also connected to Mr. Arpaio, the then Sheriff.

47 Mr. Jackson related to me that he had previously worked for Merrill Lynch as an investment
48 banker deployed for some years in Mexico City, Mexico. Mr. Sullivan also told me that Mr. Jackson had
49 called him once from France. It is also possible that the reportedly now-deceased Mr. Jackson worked
50 for the intelligence services of the United States, using Merrill Lynch as a cover. As you may recall, a
51 number of the people I came into [professional contact with over the years worked on these kinds of
52 assignments in various parts of the world.

68 communications environment with individuals with appropriate authorization and cleared access to this
69 type of information. The disclosure of those contacts’ cover identities may inadvertently identify sources
70 and methods which ought not to be widely disclosed or known. I leave any next steps in this area to your
71 discretion.


