

WCC - Waiting on indication of next steps from three investors. While it is doubtful they will all move forward, there are encouraging signs from Sole Source Capital, Los Angeles. Also have inquiries in with three financial institutions regarding financing our mortgages, receivables, and cattle inventory.

Working on the simultaneous acquisition of three feedyards, giving us 250,000 head per year of capacity. Two are in operation, 18,000 and 24,000 head, the third is not, 65,000 head one-time capacity. Typical 2.5 turns per year gives a theoretical capacity of 267,500 head per year. Located in Hereford, Dimmitt, and Friona, Texas, just south of Amarillo. Favorable reaction to this proposition so far from Sole Source.

No word yet from Walmart on the date of their first trial order. Once Walmart establishes an ordering pattern indicating they are serious, we will place a General Manager in Shenzhen to expand that business and sign other accounts. Also beginning to evaluate the feasibility of fresh product delivery to Shanghai via the Pudong airport there. Shanghai is the major trade hub in China, with 24 million people in the city and a relatively high standard of living so there may be room for an ultra-premium priced product. We would need to charge \$7 per pound for fresh beef there as compared to a \$2 per pound wholesale price in the US. They do have refrigerated handling facilities at the airport and an Americold distribution warehouse is located about two hours away so it is practical if the demand is there.

Dewey – I hope your NYC LP tour went well. We expect to be making offers on the two operating feedyards late next week. These offers will require about 3% be placed in escrow on or before February 2^{nd} . Will SSC be in position to either lend WCC these escrow funds (roughly \$250,000) or have concluded a deal with us to invest the \$25 million we are seeking for WCC by that time?

Based upon information received, we have elected to delay the escrowing of the non-operating feedyard until we can clarify the water situation and get a more firm handle on the feedmill and yard rehabilitation costs. This process will probably take another six weeks or so. We understand there is a need to lease water from a neighboring farm but the cost is not yet known. Also, we have seen estimates on the feedmill rehab ranging from nominal to \$750,000. This higher figure would still put us under the initial \$2 million estimate for total rehab but we want to be confident of our total rehab costs and the costs of needed water availability before making an offer.

NBH Bank, operating in Texas as Hillcrest Bank, made very aggressive overtures to me yesterday to gain our business. They are a \$5.5 billion set of banks operating in the Midwest and Southwest so they would be able to fully support the debt we need at excellent advance rates against assets. They have strong cattle experience in their Food and Agribusiness group. Unlike Rabo, known for a slow approval process, and Wells Fargo, known for being somewhat difficult to deal with, their Food and Agribusiness unit appears to be both well-staffed and nimble. I have attached a one-pager for your information.

Walmart China is moving ahead. They asked yesterday about extending the number of items in their trial order. This would give us more shelf space in their stores when they begin ordering in significant quantities, furthering our sales efforts with them.

Reed - We have identified three feedyards in the Amarillo area with a combined capacity of 107,000 head as acquisition targets. Two are operating as custom feedyards, the third is not operating at this time. They are available at approximately \$10.5 million total. This combination would replace the single 22,000 head Colorado feedyard and farm listed at \$19.5 million but require an equity investment of \$25 million. We would continue to feed custom cattle in the two operating yards for the next several years, bring the unused yard up to capacity with owned cattle, and gradually supplant the custom cattle in the other two yards with owned cattle.

The plan is to export most or all of the owned cattle to Asian countries, beginning with China and adding Japan and South Korea. This will give us premium pricing on these cattle. The premium, including processing cost, insurance, and freight is approximately 60% above the US market, so the net premium is about 25%.

Dewey – I hope your NYC LP tour went well. We expect to be making offers on the two operating feedyards late next week. These offers will require about 3% be placed in escrow on or before February 2^{nd} . Will SSC be in position to either lend WCC these escrow funds (roughly \$250,000) or have concluded a deal with us to invest the \$25 million we are seeking for WCC by that time?

Based upon information received, we have elected to delay the escrowing of the non-operating feedyard until we can clarify the water situation and get a more firm handle on the feedmill and yard rehabilitation costs. This process will probably take another six weeks or so. We understand there is a need to lease water from a neighboring farm but the cost is not yet known. Also, we have seen estimates on the feedmill rehab ranging from nominal to \$750,000. This higher figure would still put us under the initial \$2 million estimate for total rehab but we want to be confident of our total rehab costs and the costs of needed water availability before making an offer.

NBH Bank, operating in Texas as Hillcrest Bank, made very aggressive overtures to me yesterday to gain our business. They are a \$5.5 billion set of banks operating in the Midwest and Southwest so they would be able to fully support the debt we need at excellent advance rates against assets. They have strong cattle experience in their Food and Agribusiness group. Unlike Rabo, known for a slow approval process, and Wells Fargo, known for being somewhat difficult to deal with, their Food and Agribusiness unit appears to be both well-staffed and nimble. I have attached a one-pager for your information.

Walmart China is moving ahead. They asked yesterday about extending the number of items in their trial order. This would give us more shelf space in their stores when they begin ordering in significant quantities, furthering our sales efforts with them.

The list looks pretty inclusive. I do better with pictures on what is missing.

The ability to flake two grains at the same time would be nice but not mandatory. The yards that I have seen flake milo will feed it with high moisture corn. Usually when yards flake wheat they will switch to 100% wheat for a period of time that usually coincides with wheat harvest. David will have a good idea if any of the local yards are or have been flaking milo or wheat. Milo and wheat require flaker rolls with different corrugations than corn.

The ability to store and feed liquid or dry protein supplement would be very nice. We will want to have a heated tanks for tallow or corn oil also. You are correct that a liquid weighing system will be essential.

We will probably want to go with a portable hay grinder. We also have the option to purchase hay ground and delivered. A stationary grinder limits the variety of roughages you can feed. We will probably feed alfalfa, corn stalks or wheat straw and some mixtures.

I will work on this more later today.
