Okay, thanks. I spoke with someone else about the property earlier today and there is apparently an auction upcoming on April 13th - and the place is not operating - so the financials would do us no good. Thanks for your efforts.

We are interested in multiple options in Texas where the owners are sincere about selling and will give us the time to negotiate a deal and put it in front of our partners. Those partners will not make any final commitment in the absence of a thorough review of financial information. Despite having told us our approach is a perfect fit for their fund – a direct quote from the founder of one of them at a meeting I had in NYC about three weeks ago – they insist on seeing this info before committing. We won't go back to them without meeting their criteria as it would be wasted effort for all of us.

What we are trying to put together is an integrated dairy beef operation from calf to boxed private label beef for the export market. We do not want to be in processing but will do all the other steps ourselves, from procuring dairy calves to marketing the finished product in China and elsewhere in Asia. We will feed custom conventional cattle in the meantime as we build up our export capacity. So, we are looking for custom feedyards, preferably with a permitted capacity over 20,000 head, up to a total of 60,000 head or more and calf and backgrounding facilities to support them. The finishing yards come first. We do not have to have the calf facility immediately but it is on our list of things to acquire. Once we are in operation, it will be much easier to acquire these non-operating assets, such as E6 or HEC Friona. But for now we need operating feedyards with several years of stable finances and ownership to persuade the PE firms to act.

The owner had already told us, which we had passed on to you, that he would provide financials. That is not the issue. But there is a bank involved and they are in the process of deciding whether to let the owner keep it on the market, take it to auction, foreclose, and/or etc. If they are going to leave it on the market to allow us time to negotiate

and close a deal with you, they want to know that a willing and capable buyer is available. What that takes is putting the guy that writes the check and possibly his banker in touch with our client's banker. That should not be a challenge and in my experience, is never a challenge except for the guys that don't have committed funding. Wade told me there is about \$8 million in debt outstanding, including an operating line and a mortgage. He will provide details and confirmation of the exact loan amount shortly. According to the 2017 appraisals for the farmland and feedyard, there is about \$5.3 million of value in the collateral if orderly sold. They are currently planning an auction on April 13th. As you know, these auctions rarely bring in anything resembling fair value. Chad - I have a three pronged opportunity for a raised from calf dairy beef operation serving the export market. This involves:

- A 40,000 head custom cattle feeding operation in Farwell, Texas currently in full operation, and available for about \$4.5 million, including significant farmland and good water supply
- An 8,000 plus head calf rearing operation in Hart, Texas currently winding down but has been operating, available for \$5.8 million, including significant farmland and good water supply. A 2016 freak snowstorm caused a high death loss and has crimped the Company's finances severely. We have a plan in place to mitigate the possibility of a reoccurrence of this type of weather event.
- An 80,000 head backgrounding and finishing yard in Friona, Texas last operated in 2015. Available for \$600,000. Requires rehabilitation, including new feed mill and some repairs to feedyard. Most of the water supply will be leased from neighboring farms, and is reasonably priced.

We would purchase these three facilities and continue the conventional custom feeding operation in Farwell as is. It provides solid EBITDA and monthly cash flow to support ramping up of the Hart calf operation, and within six months, the restart of the Friona backgrounding operation, and the subsequent restart of the Friona finishing operation. Once the Friona feedyard is rehabilitated, we would purchase outside cattle for finishing to fill in the gap while our own calves are growing to the point where finishing is appropriate. We would grow cattle at Friona primarily for export and fill in with conventional cattle, reducing the total number of conventional cattle being finished there as our export business grows. All three facilities are relatively close together – less than an hour apart, and can be managed in common. To further reduce the net price, we can also sell the farmland, subject to maintaining an adequate water supply.

As you may recall, we have a pending contract with Walmart China and will be working to secure further contracts in China, Japan, and Korea.

Here are two equations:

16hrs x 60min ÷ 5feedings ÷ 3min/calf =64

16hrs x 60 min ÷4feedings ÷ 3min/ calf =80

I'm sure you'll be more cost effective with a structure...

I have a few questions/ proposals...

Why not head to head and save \$ with half the rail?

Is the 16 hour period so that someone is around all the time? We've found with calves if you feed them too often they tend to skip feedings more readily. This results with a messy feeding report for your staff to sort through.

Here's a proposal to be perhaps the most cost effective/ calf:

24hrs x 60 min ÷ 4feedings ÷ 3.6 min/ calf= 100

We have a light and suckling/mooing audio on the feeder to help alert calves for night feedings and if they're trained and healthy they will rise to feed at any hour.

So for training new groups we could feed 3x in a 16hr period for the staff's sake then add 4th feeding after a couple days.

If you had 50 pens to a side and 3' pen width I'm thinking the cost of one system would only increase from \$35K to \$40-42K.

Bruce - Please take a look at this workflow software. It may be useful for our animal tracking, scheduling, calf collection route management, calf intervention tracking such as vaccinations and medications, field task and time tracking, etc.

We should have an answer on whether we are proceeding with our E6 calf ranch and Friona HEC feedyard acquisitions with Summit Investment, Denver, by months end. If we proceed, the calf ranch has capacity for 8,000 calves to six weeks old, and 16,500 calves six weeks to three months old. HEC, which will receive the three month old calves, has the capacity for 80,000 head in backgrounding for up to 18 months (for dairy heifers). It will also accommodate our dairy beef program which requires backgrounding for nine to twelve months and finishing for an additional five months. Since we must track every animal individually using RFID, we have a big data challenge ahead of us starting as soon as eight weeks from now at the calf ranch and four to five months from now at HEC.

To add to the challenge, the calf ranch is in the process of terminating operations per direction from the bank which holds their loan and HEC has not operated for three years and has a derelict feed mill. Both are available at excellent price points which interests a deep value investor like Summit. So, if this moves ahead, we will have no legacy to fall back on or to contend with as the staff will all be new and all information infrastructure will be implemented from scratch.

Chad – We will need \$15 million equity plus \$9 million bank debt this year, followed by \$15 million sub debt and bank debt next year. The \$15 million is the only equity ever required to meet the numbers. As for the debt, we will have plenty of property, equipment, A/R, and cattle to act as collateral to meet bank requirements.

We need to follow-up on the calfyard by next Monday, March 5th, with the bank that holds the loans on property and equipment. The property and equipment are worth \$9.1 million, available for about \$6.5 million if we act quickly. To purchase this property timely will require \$6.5 million cash or an agreement with the current bank to hold a mortgage. It can be mortgaged (property and equipment) for about \$5.3 million, so we would need to come up with \$1.2 million in cash right away. No deadlines on the other properties as yet.

Yoshi – I have found a new fabricator that is on the USDA EV and CNCA lists. They are more than happy to take on our business so that problem is finally solved.

Now we have to find several more customers who want to buy the remainder of the frozen carcass. We are looking in both China and the EU for customers who are willing to take these more expensive cuts. We need enough volume to make up for the fact that Walmart China is using only about 5% to 8% of each carcass with its flank and shank orders. Six hundred eighty tons of flank and shank will require thousands of carcasses so this is taking a bit longer than expected. If Walmart China would be interested in a full array of cuts it would solve this problem immediately but I have not asked as I do not believe this is consistent with their current merchandising plan.

Sorry for the delay – I was surprised when the first fabricator quit without saying a word to us.
