Good day –

This is a follow up to my series of letters and complaint previously hand delivered by me to SDNY Security at One St. Andrews Plaza. My most recent letters were dated July 12, 2022.

Enclosed please find evidence of another series of potential wire, passport, or records alteration frauds related to various FOIA and Privacy Act requests of federal agencies:

1. Missing FOIA entries – a series of FOIA and Privacy Act requests are missing from the FOIAonline.gov system. This may reflect the online system’s errant record keeping capabilities or some attempt to hide or expunge records. It is also possible that a false set of records is being presented to me on my login and the underlying system is accurate and correct. See the documents headed by Missing FOIA Entries From Various Agencies for more information gathered on July 14, 2022, using my login on the FOIAonline.gov system.
2. FOIA Response from DOI NPS – this information provided in the FOIAonline.gov NPS response document appears to be fraudulent. On knowledge and belief, only about 200 people were present at this site adjacent to the National Archives on August 28, 2021. It

is my belief they were sent along with me to this location rather than the actual rally site which was likely at the Lincoln Memorial. I left the National Archives site about 20 minutes after arriving as a larger crowd did not follow as one would reasonably have expected. This is, of course, also a civil rights violation under the First Amendment.

3. Incorrect Passport Entry Record – US CPB in its initial response to a FOIAonline.gov request included a travel record entry for a transit to DXB (Dubai) in 2015. No such trip has ever been made by me at any time. I replied with the email shown in the enclosed documents indicating no such trip had been made. This inaccurate record indicates the possibility that (a) information was incorrectly captured and entered to my record; (b) that my passport was fraudulently used for travel by another party or (c) a travel record was fraudulently entered to the passport system to falsify the official record for some other reason not known to me.

Certain persons who worked for Establish Inc in Fort Lee, NJ when I was at that fake employment site did report having made a round trip to Dubai at some point between September 2007 and my termination in about June 2008. (See my Complaint DC US District Ct 22-cv-996 regarding this faux employment at blue paginated page numbers Document 1 pages 48, 56-57 and Document 1-1 page 3.) This faked employment may have had absolutely no bearing on the incorrect record noted above. However, the number of “coincidences” evidencing various frauds lends a least some credibility to the hypothesis that this records error, falsification, or illegal passport use may not have been merely a bureaucratic foul-up.

I am making a FOIA request to identify the sponsors of that event. This event occurred at the same time as another voting rights event at the Lincoln Memorial. Please let me know if you require other information from me prior to fulfilling my FOIA request. Thank you."

The following response was prepared by the National Capital Area through consultation with the division of Permits, National Mall and Memorial Parks. The FOIA, 5 U.S.C. § 552, generally provides that the Government shall make documents available to the public for inspection and copying to the widest extent possible. However, certain classes of documents may be exempt. The FOIA does not require that new records be created in response to a request and only applies to records in existence at the time the request is received. Additionally, because the NPS creates and maintains law enforcement records, we are required by the Department of Justice to provide the following information, even though it may or may not apply to your specific request. 11 On July 16, I attended a play called 1+1. The event was to take place at the Chain Theater  
12 Mainstage. Upon arrival, I was directed to the double glass doors immediately to the west of the  
13 building entry by the person at the door who said that the elevator was not functioning. The plot  
14 concerned two men and a woman, an aspiring actor waitressing her way to planned stardom in Los  
15 Angeles. One male played a manipulative porn producer who lured the woman into a drug-filled  
16 relationship/porn production. They both made money, he left, and gained respectability after a time.  
17 She was left pregnant, unknown to both at the time he left.

18 Confronted in the second act, he told her was now married and off drugs expecting a child with  
19 his new wife. He offered her a small bit of the cash he had made as he had cashed the royalty checks  
20 from the porn, noted that she was still an addict, had no resources, was practically homeless, and made  
21 some take-it or leave-it threats.

22 The other man was the woman's boss, had encouraged her acting interests while she was a food

## 29 **Increasingly Explicit Content of Indirect Threat and Related Civil Rights Issues**

30 What is interesting about this scenario is the lead-in and lead-out scenes played out to me  
31 enroute to and from the theater. The bus ride in was considerably delayed. I spent about 38 minutes  
32 from 6:24pm to 7:12pm waiting for a bus (NJT Route 158) which supposedly arrives about every 30  
33 minutes at 6:44pm and 7:13pm on Saturday evenings. As is frequently the case, maximum delays  
34 enroute on the bus and substantial blocking and slow walking on the 8<sup>th</sup> Avenue sidewalks were  
35 experienced without it seeming too unusual. I have lived here for about 15 years and know the typical  
36 Saturday Summer evenings with tourists on the sidewalk experience well.

37 I arrived at the theater (more likely an adjacent theater in the adjacent building to the west with  
38 scaffolding above the sidewalk) and walked up three floors up as directed, arriving at about 8:06pm.  
39 Upon entry to the theater, a lone tall, slim 30 something white female wearing a slit dress (typical bait  
40 presented frequently during nearly all visits to NYC) was directly in front of me seated alone next to the  
41 wall. I turned right at the aisle, walked down a few steps, and chose a seat in the front row to the left.



During intermission, the lone voice I heard clearly was that of a male behind me saying to someone words to the effect of watch yourself, don't go too far. After the show, I descended the stairs and noted two uniformed NYPD officers as I exited the glass doors. I turned left on the sidewalk and passed an NYPD van and two marked patrol cars, walked north on 9<sup>th</sup> Avenue. On my 9<sup>th</sup> Avenue walk from 36<sup>th</sup> to 40<sup>th</sup> there were the usual pickets, some blocking and obstructing on the sidewalks, some usual muttering I walked by.

A group of 5 or 6 gay men crossed 40<sup>th</sup> directly ahead of me. I turned right on 40<sup>th</sup> and walked to 8<sup>th</sup> Avenue, then north on 8<sup>th</sup> to the South PABT building. I visited the rest room and made it to Gate 301 just before the bus left the gate. Later on the bus an older Hispanic male looked in my general direction, made a gesture toward a young male wearing tight white shorts as the young man exited the bus. Just another day in my New York City experiences since 2007.

The one notable difference is that some scenes of sexual conduct acted out by the restaurateur, including masturbation and internet adult porn image viewing and video interactions were driven by BRMT hijacking in my own personal life from 2011-2019 (with some limited exposure into 2021) were included in the first act of the play, and the indirect threat noted above was delivered out loud at intermission. Otherwise, the police powers treatment was fairly typical of my overall experiences on a daily basis, particularly in my frequent visits to New York City.

It is highly probable that this was an in-house production for my benefit with an audience comprised of police personnel. I have experienced this same in-house police powers entertainment on other prior visits, though certainly not all visits to theaters, comedy, and bar entertainment venues in NYC. Since my income is limited to Social Security these days, my access is typically via ClubFreeTime.com. The version of that site which I can access appears to be managed, as do most other websites I use, by police powers agency or agencies, including, of course, most if not all social and dating activities.

### **Currently Running Public Spaces Harassment Campaign**

1) Recently reinstated on-going story-telling - Movie trailer style messaging as previously described, enroute to and from my City Place, Edgewater residence and Acme Edgewater Commons supermarket, in street traffic patterns and vehicle sequencing, the occasional near miss of turning traffic, sidewalk blocking and in-store obstructions by people with shopping carts and employees with stocking carts.

2) Fake free events - A series of fake events on EventBrite.com including a non-existent indoor art fair April 6 at Pier 36; a street fair supposedly around Theater for the New City on May 29 with an empty street blocked off by a barricade likely placed by NYPD; and a non-existent 4-7pm event at Harlem School for the Arts on June 8.

3) Programmed disruptions of free performances - frequent view blocking and continual parading during the following live performances – Central Park Delacorte Theater – June 25; Bryant Park – June 3, June 18; Lincoln Center Damrosch Park July 3; Marcus Garvey Park – Rodger Bandshell July 15.

**Currently Running Scam**

Undeclared taxable income on credit card charge-offs – I switched banks recently. CapitalOne alleges it cannot locate a charged-off account so I can continue payments to retire the debt. I tried compromising it online when offered, this was blocked when I tried to accept the reduced payoff offer. This entire sequence was most likely a planned hack event, similar to the previously described HP printer endurance contest (July 12, 2022, letter to Tom Eichler NJ Public Integrity unit, cc to George Turner, SDNY) which cost a considerable amount of my fixed monthly income and forced me further into credit card debt.

Unpaid charge-offs outside bankruptcy would eventually result in taxable income. In my case, it is likely well below the threshold which would require actual tax payments but could result in an IRS referral and/or taxable income reporting error by others when run against another target. When combined with other harassment techniques such as denial of free access to employment (also previously experienced by me), it can be used to enable civil tax penalties and potential criminal tax exposure for the unaware.

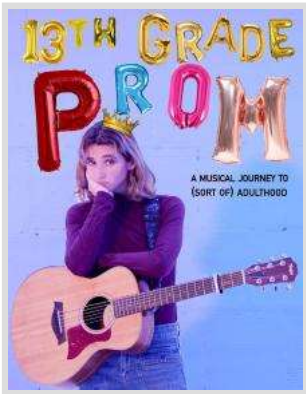

20         Given the frequency of front-running of adverse events in my presence over a considerable  
21 number of years, I am providing another and very urgent potential example of the same kind of  
22 surreptitiously delivered visual messaging I have received in the past as noted in prior letters.

23         On one of my infrequent visits to the main concourse level of Grand Central Terminal in New  
24 York City in the last several months, I followed a very well dressed white female bearing a mink or  
25 similar stole a few steps ahead on the final stair riser leading up from the Dining Level (my infrequent  
26 visits there were for snack/coffee or restroom visit) where it enters the Main Concourse Level. I have  
27 rarely encountered this level of fashion on any person I have noticed on any of my visits to Grand  
28 Central. It was very unusual. Regrettably, I do not recall the specific date or the specific riser (there are  
29 several such risers to the main concourse from the lower level) of this sighting but have recreated the  
30 dates when I have visited some level of the terminal over the past nine months below.

31         I have no ability to identify this female face or age. The female's height is difficult to estimate as  
32 I was below and behind her, but the shape was of a moderately slim and moderately tall female.

33         Surveillance video will be required to make an identification of this person. In any video  
34 recorded from the perspective of the main concours, I am on the same riser a few steps behind and  
35 below the white female as she moves from the riser to the main floor level. For a viewer looking toward  
36 her face and my face in any video, I am 3 or 4 steps below and will most likely be a small distance to her  
37 right a few steps behind, though that is not absolutely certain. I am likely in a short-sleeved shirt or golf-  
38 style open neck shirt and blue jeans.

Each package was dropped off at the employee/visitor security entry point to SDNY, and typically required less than 5 minutes.

Cell phone GPS location data is also available but may not be completely accurate as some tampering seems to have occurred in some of the data. Please also verify the accuracy of the enclosed NYT articles as I am sometimes the subject to disinformation as well.

As before, I do not intend to be melodramatic, but I believe there is some effort being made to create political instability in the United States. A natural appearing method of death is completely consistent with the use of BRMT, the brain hijacking/hacking I have previously described.

## *Ivana Trump's Death Is Ruled Accidental*

Ms. Trump, an ex-wife of former President Donald J. Trump, died by blunt impact injuries, according to New York City's chief medical examiner.

Ivana Trump, the ex-wife of former president Donald J. Trump, died accidentally of blunt impact injuries to her torso, according to New York City's chief medical examiner.

The office, which announced its determination in a news release on Friday afternoon, said it would have no further comment on the death of Ms. Trump, 73.

Two law enforcement officials with knowledge of the matter had said on Thursday that the police were investigating whether Ms. Trump had fallen down the stairs at her Upper East Side home. One of the officials said there was no sign of forced entry at the home.

Ms. Trump and Mr. Trump, who had three children together, married in 1977 and divorced 13 years later. During their marriage, they formed a quintessential 1980s power couple and reigned jointly over New York's tabloid culture. She was credited with giving him the nickname "The Donald."

Ms. Trump commanded almost as much media attention as her husband in their time together, helping to define an era of gaudy excess that Mr. Trump later used to position himself as an outsize television personality before his 2016 run for president.

As Mr. Trump built his real-estate business, Ms. Trump was his behind-the-scenes partner and among his closest confidantes. She chose the pink marble and gleaming brass of Trump Tower on Fifth Avenue and advised him on his decision to go into the casino business in Atlantic City, N.J.

She took particular pride in raising the couple's children, Donald Jr., Ivanka and Eric, writing in her book "Raising Trump" that "the credit for raising such great kids belongs to me."

Ms. Trump's death led the office of New York's attorney general, Letitia James, to say on Friday that it was postponing a deposition of the former president scheduled for next week as part of a civil investigation into whether he and his company had fraudulently inflated the value of his assets. Similar interviews scheduled with Ivanka Trump and Donald Trump Jr. would also be postponed, a spokeswoman for Ms. James said.

## *Ivana Trump, Ex-Wife of Donald Trump and Businesswoman, Dies at 73*

She helped build his real estate empire, though she was better known for being one half of the quintessential 1980s power couple.

Ivana Trump, the glamorous Czech American businesswoman whose high-profile marriage to Donald J. Trump in the 1980s established them as one of the era's quintessential New York power couples, died on Thursday at her home in Manhattan. She was 73.

Mr. Trump announced her death in a statement on Truth Social, the conservative social media platform he founded.

The New York City police were investigating whether Ms. Trump fell down the stairs at her townhouse on the Upper East Side, according to two law enforcement officials with knowledge of the matter. One of the officials said that there was no sign of forced entry at the home and that the death appeared to be accidental. A spokeswoman for the city's chief medical examiner's office said it would investigate the death.

Throughout their marriage, Ms. Trump commanded almost as much media attention as her husband as they helped define the 1980s as an era of gaudy excess among the elite, an image that Mr. Trump used to fuel his turn as an outsize television personality before his 2016 run for the White House.

It was Ms. Trump who rechristened her husband “the Donald,” a moniker that became a fixture in New York's tabloid press, where she was a regular and boisterous presence. Every bit as ambitious as her husband, she liked to brag that “in fifty years, we will be the Rockefellers.”

Where her husband was brash and often uncouth, Ms. Trump came across to the city's moneyed elite as charming and sophisticated, opening doors to rarefied social circles that Mr. Trump could then barrel through.

She was more than a socialite: Though Mr. Trump often bragged about his business prowess, Ms. Trump played a critical part in building his real estate empire, beginning soon after their marriage in 1977.

Often described as detail-obsessed and a workaholic, she worked alongside her husband on several of his early signature projects, like the development of Trump Tower in Manhattan and the Trump Taj Mahal casino in Atlantic City, N.J.

She was the vice president for interior design for his company, the Trump Organization, and managed one of his most prized properties, the Plaza Hotel, all while raising their three children.

The couple's divorce in 1990, driven in part by Mr. Trump's affair with Marla Maples, whom he later married, provided tabloid fodder for weeks. In a deposition, Ms. Trump accused him of raping her, though she later said that she had not meant the word literally.

The divorce made Ms. Trump something of a heroine for spurned wives everywhere — she even had a cameo in the 1996 film "The First Wives Club," in which she tells a group of disgruntled divorced women, "Don't get mad, get everything!"

She used her business prowess to great effect as well. She developed a line of clothing, jewelry and beauty products, which she promoted through outlets like the Home Shopping Network and QVC. She invested in real estate, domestically and in Europe, and wrote several books, including "The Best Is Yet to Come: Coping With Divorce and Enjoying Life Again" (1995) and, most recently, "Raising Trump" (2017), a memoir of her marriage to Mr. Trump.

In a family statement posted on Facebook, her children, Eric, Donald Jr. and Ivanka Trump, wrote, "Our mother was an incredible woman — a force in business, a world-class athlete, a radiant beauty, and caring mother and friend."

And on his social media platform, Mr. Trump wrote of her, "She was a wonderful, beautiful, and amazing woman, who led a great and inspirational life." He added, "Rest In Peace, Ivana!"

Ivana Marie Zelnickova was born on Feb. 20, 1949, in Gottwaldov, Czechoslovakia, now known as Zlin and located in the Czech Republic. Her father, Milos Zelníček, was an electrical engineer, and her mother, Marie (Francova) Zelnickova, was a telephone operator.

Athletically gifted as a child, Ivana was particularly adept at skiing and competed with the Czech junior national team, an experience that allowed her to see at least some of the world beyond her small town. (Although Mr. Trump liked to say that she was an alternate on the Czech Olympic ski team, there is no proof that this was the case.)

She attended Charles University in Prague and received a master's degree in physical education in 1972.

She was briefly married to Alfred Winklmayr, an Austrian ski instructor, in what she later termed a "Cold War marriage," which allowed her to receive an Austrian passport and move to Canada. She said that they never lived together and that the marriage was "dissolved" in 1973.

In Canada, she worked as a ski instructor and as a model promoting the 1976 Olympics in Montreal. It was while working at a reception in New York that she met Mr. Trump, who at 29 was just beginning to plot his rise to the top of the Manhattan real estate world.

The two married less than a year later in a ceremony officiated by Norman Vincent Peale, the author and Protestant clergyman.

One of Mr. Trump's first big projects was redeveloping the aging Commodore Hotel, adjacent to Grand Central Terminal in Midtown Manhattan. Ms. Trump, who was then working on her interior design license, jumped in alongside him. At first she oversaw plumbers and electricians, and later, near the end, she passed judgment on "every pillow, every table and chair, and every brass column," as she told *Vanity Fair* in 1988.

The hotel reopened in 1980 as the Grand Hyatt, a glitzy marker of a new decade of rapid development and material excess, qualities that would become synonymous with the Trump brand.

Ivana soon became an equal if behind-the-scenes partner in Mr. Trump's business. She emphasized opulence: It was she who chose the pink marble and gleaming brass of Trump Tower, on Fifth Avenue. Though she insisted that her husband was the boss, it was also clear that she was among his closest confidantes — advising him, for example, on his decision to go into the casino business in Atlantic City.

She held even more sway over the growing Trump household. In the introduction to "Raising Trump," she bragged about Donald Jr., Ivanka and Eric and minced no words about who did what in their upbringing.

"I believe the credit for raising such great kids belongs to me," she wrote. "I was in charge of raising our children before our divorce, and I had sole custody of them after the split. I made the decisions about their education, activities, travel, child care and allowances. When each one finished college, I said to my ex-husband, 'Here is the finished product. Now it's your turn.'"

The couple used their wealth to take on the New York social scene, but they ended up projecting themselves far beyond it, into the TV sets and reading material of Americans far from the skyscrapers of Midtown. They became fodder for gossip columns, *People* magazine profiles and even "Saturday Night Live" sketches.

And as the couple rode high toward the end of the 1980s, with a fortune estimated at \$3 billion, she coyly batted down speculation about an imminent run for the White House by her husband.



"It's not for the next 10 years, definitely not," she told Vanity Fair. "There is so much to do. We have invested in this town close to a billion dollars. We can't just put it in escrow and go to the White House. It would go down the drain in a second. It's too young, too new. But in 10 years Donald is going to be just 51 years old — a young man."

A year later, however, their marriage began to implode as rumors swirled about Mr. Trump's relationship with Ms. Maples. The Trumps were seen fighting in public, and Mr. Trump reportedly locked her out of her office at the Plaza Hotel.

After almost a year of gossip and legal posturing, a court granted the couple a divorce in December 1990 on the grounds of cruel and inhumane treatment by Mr. Trump. But a bitter settlement fight ensued when Ms. Trump insisted that he owed her half of his fortune — not knowing, perhaps, that he was close to bankruptcy at the time.

Ms. Trump developed a following of sorts: Fans held candlelight vigils outside the Plaza and waited for hours to get a glimpse of her leaving home or court. Liz Smith, the venerable gossip columnist, became a sort of Ivana whisperer, filling her articles with chunks of dirt about Mr. Trump and helping to establish Ms. Trump's post-divorce image as a strong woman unfairly wronged.

The couple finalized the settlement in 1992, largely along the lines of their last prenuptial agreement. She received \$14 million, their 45-room mansion in Greenwich, Conn., an apartment in Trump Plaza on the Upper East Side, and access to their Mar-a-Lago mansion in Florida for one month a year. She also received \$650,000 a year to support their three children.

Ms. Trump bought her Upper East Side townhouse, just off Fifth Avenue near Central Park, after the divorce and decorated it in her own ostentatious style.

"My home reflects my style perfectly," she wrote in "Raising Trump." There was the marble staircase, heading up to the "white piano room" on the second floor, followed by a "leopard sitting room" another flight up.

She began to build her own business empire, this time around fashion and beauty, and, more important, sought to construct an identity separate from her famous ex-husband's.

"You don't have to put down the second name," she told a reporter from The New York Times in 1995. "Ivana is what the people call me."

While developing her clothing and jewelry business, she hired three secretaries to help her handle mounds of fan mail, which she tried to answer personally. She became a regular on daytime talk shows and was always happy to make a TV or movie cameo, her high pile of blond hair and her still-pronounced Czech accent instantly recognizable.

Despite her admonition in "The First Wives Club" to "take everything," she largely spared Mr. Trump from further public embarrassment.

"This is not a revenge book for Donald," she told The Times about "The Best Is Yet to Come," her 1995 book. "This is an advice book for women. I threw in some of my experiences, but 90 percent is the stories of the women. The last thing I wanted to do is bring Donald in."

She married two more times. Her marriage to Riccardo Mazzucchelli, an Italian businessman, in 1995, ended in divorce two years later. She married the Italian actor Rossano Rubicondi in 2008, in a ceremony at Mar-a-Lago, with Mr. Trump in attendance. That marriage lasted less than a year.

Along with her three children, Ms. Trump is survived by her mother and 10 grandchildren.

Although she said little about her ex-husband's presidency, Ms. Trump occasionally rankled Melania Trump, who married Mr. Trump 15 years after he and Ivana Trump were divorced — with Ms. Maples, his second wife, sandwiched uncomfortably in between.

During an appearance on “Good Morning America” in 2017, Ms. Trump said she was “basically first Trump wife,” adding, “I’m first lady, OK?” — an apparent malapropism that drew a sharp response from Melania Trump’s spokesperson.

# Sables and Minks and Chinchillas Galore: Ivana Trump's Opulent Style

Dennis Basso, a longtime friend and furrier, recalls his many collaborations with the first Ms. Trump.

“Ivana Trump’s look wasn’t for everyone,” the designer Dennis Basso said Thursday afternoon, a few hours after Ms. Trump’s death was announced by former President Donald J. Trump, her ex-husband, in a statement posted on his social networking platform, Truth Social.

But it was, for the decade in which she and Mr. Trump first made their public mark, the epitome of a certain go-go 1980s New York style. One caught by Tom Wolfe’s “The Bonfire of the Vanities” and defined by chinchilla stoles, leopard-print shirtdresses, and Upper East Side ready-fitted trousers in soft colors. One in which your limo could never stretch too long, your hair and shoulder pads could never be too big, or your furs too fabulous.

And for nearly 40 years, even as styles changed drastically, Ms. Trump and Mr. Basso remained as two of the most consistent proponents of that paradigm.

Mr. Basso, 68, said he first met Ms. Trump in September 1983, when she came to his debut show at the Regency hotel on the Upper East Side of Manhattan.

She sat in the front row of his show that day near Joan Collins, another diva of the decade, then came backstage. “She said with that fantastic accent: ‘Dahling, I really don’t know you. But we’re going to be friends,’” Mr. Basso recalled. “I thought: ‘Oh, my God. Like, how could this be?’”

Trump Tower had recently opened near Bergdorf Goodman. Not everyone was enamored of the couple inhabiting the triplex at the top, but it was hard to argue that they did not perfectly capture the “greed is good” ethos of the era.

The day after Mr. Basso's debut show, Ms. Trump materialized in his Seventh Avenue showroom and marveled at the size. "It's smaller than my dressing room closet" was how she put it, Mr. Basso recalled.

But by the time she left, he had an order for seven magnificent fur pieces.

"One was a pale silver silk shantung maxi-coat lined in deep, deep sheared magenta fur," Mr. Basso said. "She bought a chinchilla coat, a sable jacket, a big cashmere evening wrap. Remember the year! If you said you bought that now, it would be, like, 'Have you lost your mind?'" But it was the height of all that glamour. Everybody was on that bandwagon."

The relationship between Ms. Trump and Mr. Basso was by no means exclusive. Most of her suits and evening gowns came from Arnold Scaasi, Oscar de la Renta, Bill Blass, Lacroix, Halston and Versace.

But because Ms. Trump was “living in her own movie,” as Mr. Basso put it, and because she saw the most important scene as being the one in which she steps out of the car to make a grand entrance, outerwear became the mainstay — usually fur — and he was the guy to get it from.

At first, Ms. Trump bought off the rack from Mr. Basso. Then, things got collaborative.

“We couldn’t have made the shoulders bigger or fuller,” Mr. Basso said. “She always wanted to show her waist. She would call and say: ‘I love that. Can I have it in purple?’ ‘I love that. Can I have that in green?’ One year, around Christmastime, she called and said: ‘I’m in Aspen. I want a red sheared mink ski suit.’ Not being a great skier, I said, ‘But when you fall, it’s going to get wet.’”

Mr. Basso paused for effect, then added: “She said, ‘Dahling. I don’t fall.’”

So off Mr. Basso went, and soon enough, Ms. Trump was sailing down the slopes in it, as self-confident and unapologetically opulent as always.

Did she usually pay for her clothes?

“Always,” he said, though he added that she wasn’t shy about invoking the “friends and family” discount.

Which was fine with him. "This was a symbiotic relationship in which no person got more than the other," he said.

The business Ms. Trump generated for him as both a muse and a supporter — in addition to her friendship, she hosted Basso fashion shows at her husband's Taj Mahal hotel in Atlantic City — was "huge," Mr. Basso said.

Tastes changed some in the early 1990s. Minimalism and PETA were not friends of furriers.

But Ms. Trump had grown up in Czechoslovakia, shortly after it became a communist dictatorship. Once she got to the United States and became wildly rich, she had little interest in making herself over in existential Helmut Lang and deconstructed Martin Margiela.

"She came to America from a communist country," Mr. Basso said. "She was going to say her piece."

This included when Mr. Trump left her for a younger woman in 1990: Marla Maples.

Soon enough, the tabloids her husband had used to build buzz for him and his properties became weapons Ms. Trump bludgeoned him with. She made the 1990 Met Gala her liberation celebration, complete with an actual makeover.

The hot-rolled-to-the-heavens hairstyle was gone. In its place was a Brigitte Bardot-inspired bouffant. The dress was a form-fitting black off-the-shoulder gown. Her date that evening was Boaz Mazur, the movie-star-handsome Oscar de la Renta sales director.

"She was really able to dust herself off and keep going," Mr. Basso said, going on to recall the line she later delivered while making a cameo appearance in "The First Wives Club": "Don't get mad, get everything!"

In 1992, Ms. Trump was granted sole custody of her children with Mr. Trump — Ivanka, Eric and Donald Jr. — and signed the deed for a \$2.5 million townhouse on East 64th Street.

One morning, Mr. Basso picked up The New York Post to find a story that said the townhouse had been robbed.

He said that after his initial horror upon learning of the robbery, he was shocked to read that what was missing was an astronomically expensive coat from his label. "It was hanging in my office," he said. Between her move out of Trump Tower and the renovations of her new home, he said, "one of her assistants sent it over for safekeeping."

After that, Ms. Trump walked in fashion shows for such friends as Thierry Mugler, and even closed Mr. Basso's 1995 collection at the Pierre. Joanna Lumley mimicked Ms. Trump's look while playing a killer cougar on the British sitcom "Absolutely Fabulous."

The show was shown in the United States by Comedy Central and became a camp classic that cemented Ms. Trump's haughty-queen image — and ability to laugh at her own legend.

Of Ms. Lumley, Ms. Trump said, "She was good, but I could have done it better," Mr. Basso recalled.

From there, Ms. Trump got to work on House of Ivana, a beauty-products and clothing company that was run briefly by Riccardo Mazzucchelli, a suave Italian executive who two years later became Ms. Trump's next husband.

Like the one who came before him, Mr. Mazzucchelli had a personality that was combustible and a father from whom he inherited much.

(According to the The Daily News, Mr. Mazzucchelli was a founder, along with his father, who worked in mining, of an "architectural planning and engineering firm that devised infrastructures for cities in Nigeria, Uganda and other African and Middle East countries.")

Naturally, Mr. Basso was on hand when Ms. Trump married Mr. Mazzucchelli in 1995 at Le Cirque in New York. And naturally, he was there for her during the tabloid divorce that followed less than two years later.

"We were friends in good times and bad," he said. "We used to say, not every day is Christmas." (Mr. Mazzucchelli died in 2017.)

In the 2000s, Ms. Trump's life mimicked her "Absolutely Fabulous" alter ego.

She began dating a dashing Italian actor named Rossano Rubicondi, who was 23 years her junior, and she got a two-hour special on Oxygen called "Ivana Young Man."

Friends cautioned that the age difference could become an issue.

But, Mr. Basso said, Ms. Trump once again had the perfect one-liner: "I'd rather be the nanny than the nurse."

In 2008, she married Mr. Rubicondi at Mar-a-Lago, the Palm Beach, Fla., club that Mr. Trump calls home.

Ms. Trump's close friend Nikki Haskell was a bridesmaid. Ms. Haskell's date was Mr. Basso, and the chocolate wedding cake was 12 feet tall and flown in from Germany, according to People magazine.

Mr. Basso said it was probably the oldest wedding party in history. And, "it was so much fun."

But soon after that, it began to look as if all was not well with Ms. Trump.

In 2009, Ms. Trump divorced Mr. Rubicondi. That year, she was escorted off an airplane after a reported expletive-filled tirade delivered to children who were playing in the aisle of first class.

But Mr. Basso said that as she portrayed things with him, all was well. Ms. Trump, he said, wanted most of all to be known as a good mother. And her relationship with her ex-husband Mr. Trump had been friendly in recent years.

Still, Mr. Basso admitted, he saw a little less of Ms. Trump in the last few years.

This was partly because of the pandemic, but also because of more enduring changes to the social landscape. "Le Cirque, Mortimer's, Gino's, the Four Seasons," he said. "They no longer even exist."

Still, Ms. Trump never dropped out of touch with Mr. Basso and his husband, Michael Basso. "I spoke to her two weeks ago, my husband was texting with her last week, and we saw her maybe a month ago for dinner at Cipriani," he said.

As he remembered it, she showed up on time and was in fine form. "This was a sudden surprise," he said of her death. "I'm a little down. I'm a lot down."

21 This letter repeats the content of the indirect threat portion of the July 18, 2022 letter and adds  
22 below that some historical context. It discusses the currently escalating indirect threat environment of  
23 my personal situation. **Most importantly for senior management, the first Addendum provides**  
24 **additional information on past events which had the potential for mass casualties.**

### 26 ***Repeated Contents***

27  
28 “On July 16, I attended a play called 1+1. The event was to take place at the Chain Theater  
29 Mainstage. Upon arrival, I was directed to the double glass doors immediately to the west of the  
30 building entry by the person at the door who said that the elevator was not functioning. The plot  
31 concerned two men and a woman, an aspiring actor waitressing her way to planned stardom in Los  
32 Angeles. One male played a manipulative porn producer who lured the woman into a drug-filled  
33 relationship/porn production. They both made money, he left, and gained respectability after a time.  
34 She was left pregnant, unknown to both at the time he left.

35 Confronted in the second act, he told her was now married and off drugs expecting a child with  
36 his new wife. He offered her a small bit of the cash he had made as he had cashed the royalty checks  
37 from the porn, noted that she was still an addict, had no resources, was practically homeless, and made  
38 some take-it or leave-it threats.

39 The other man was the woman’s boss, had encouraged her acting interests while she was a food  
40 server, semi-secretly doted on her, and took her and her child in after she was abandoned by the other  
41 man. In the final scene, the reformed porn producer enters the man’s restaurant, where he is shown a  
42 picture of the restaurateur’s daughter, the child the reformed porn producer had fathered, who views  
43 it without comment or surprise, then asks about the child’s mother. The restaurateur tells him the

woman died about six months before. Dramatically delivered, a relatively mundane drama plot line all in all.

#### **Increasingly Explicit Content of Indirect Threat and Related Civil Rights Issues**

What is interesting about this scenario is the lead-in and lead-out scenes played out to me enroute to and from the theater. The bus ride in was considerably delayed. I spent about 38 minutes from 6:24pm to 7:12pm waiting for a bus (NJT Route 158) which supposedly arrives about every 30 minutes at 6:44pm and 7:13pm on Saturday evenings. As is frequently the case, maximum delays enroute on the bus and substantial blocking and slow walking on the 8<sup>th</sup> Avenue sidewalks were experienced without it seeming too unusual. I have lived here for about 15 years and know the typical Saturday Summer evenings with tourists on the sidewalk experience well.

I arrived at the theater (more likely an adjacent theater in the adjacent building to the west with scaffolding above the sidewalk) and walked up three floors up as directed, arriving at about 8:06pm. Upon entry to the theater, a lone tall, slim 30 something white female wearing a slit dress (typical bait presented frequently during nearly all visits to NYC) was directly in front of me seated alone next to the wall. I turned right at the aisle, walked down a few steps, and chose a seat in the front row to the left.

During intermission, the lone voice I heard clearly was that of a male behind me saying to someone words to the effect of watch yourself, don't go too far. After the show, I descended the stairs and noted two uniformed NYPD officers as I exited the glass doors. I turned left on the sidewalk and passed an NYPD van and two marked patrol cars, walked north on 9<sup>th</sup> Avenue. On my 9<sup>th</sup> Avenue walk from 36<sup>th</sup> to 40<sup>th</sup> there were the usual pickets, some blocking and obstructing on the sidewalks, some usual muttering I walked by.

A group of 5 or 6 gay men crossed 40<sup>th</sup> directly ahead of me. I turned right on 40<sup>th</sup> and walked to 8<sup>th</sup> Avenue, then north on 8<sup>th</sup> to the South PABT building. I visited the rest room and made it to Gate 301 just before the bus left the gate. Later, on the bus an older Hispanic male looked in my general direction, made a gesture toward a young male wearing tight white shorts as the young man exited the bus. Just another day in my New York City experiences since 2007.

The one notable difference is that some scenes of sexual conduct acted out by the restaurateur, including masturbation and internet adult porn image viewing and video interactions were driven by BRMT hijacking in my own personal life from 2011-2019 (with some limited exposure into 2021) were included in the first act of the play, and the indirect threat noted above was delivered out loud at intermission. Otherwise, the police powers treatment was typical of my overall experiences on a daily basis, particularly in my frequent visits to New York City.

It is highly probable that this was an in-house production for my benefit with an audience comprised of police personnel. I have experienced this same in-house police powers entertainment on other prior visits, though certainly not all visits to theaters, comedy, and bar entertainment venues in NYC. Since my income is limited to Social Security these days, my access is typically via ClubFreeTime.com. The version of that site which I can access appears to be managed, as do most other websites I use, by police powers agency or agencies, including, of course, most if not all social and dating activities."

## ***New Content Below***

### **Sequential Context of Indirect Threats of Violence**

Richard III is currently playing at Delacorte Theater in Central Park. I attended on June 21. As you probably know, it is about a man who murders his way through friends and relatives to become King, then perishes at the hand of an invading King. As with 1+1 on July 16, the external sequence is the more interesting element. During the performance, there were some muffled sounds like shots, then screaming, then a series of sirens, followed by about 2 dozen people silently exiting from the audience in my northeast portion of the seating area over about ten minutes as the play continued. When I exited there was, of course, no crime scene tape to be found anywhere, no other sign of an increased police presence in the area. Most likely this was a staged sequence of faked events, including what could reasonably be interpreted as undercover audience members responding to the staged external event.

So, it seems we have yet another sequence of perceptibly increasing indirect threats coming from NYPD and its allies within the federal government who manage and control the BRMT sequence. Unless, of course, the United States has ceded control of this at least formerly ultra-secret unacknowledged BRMT brain hijacking/hacking system to NYPD, which seems rather unlikely.

### **Some Related History**

This indirect threat sequencing is basically the same as the sequence I experienced in 2005. First, a little history of this period.

I was starved out of my long-time residence in Kirkland between late 2002 and 2004/2005 by a cross-country coordinated program using Technology Sales Leads bogus sales leads operation in Boston, MA (likely an FBI operation). I traveled to various FBI field office territories for fake sales calls which, together with a \$165,000 bad check scam run out of Chicago (ShipNow, see blue paginated page 10 of Document 1-5 DC US District Court Complaint 22-cv-996), consumed the limited resources of my consulting business Performa. (See DC US District Court Complaint 22-cv-996 blue paginated Document 1 pages 54-55 and Document 1-5 pages 9-11.)

Once I was no longer able to afford the mortgage payments, I was forced to sell the house and settle with my ex-wife. I moved to an apartment in Kirkland, WA. The notable aspect of living in that apartment complex was that the parking lot was full day and night, the cars rarely moved, and I saw very few other residents during my months there. Either the units were empty or nearly everyone in the complex was a hermit who had no need to work, eat, or entertain themselves outside their apartment. My interpretation of this bizarre scenario in plain sight is that this was where the dozens of people who coordinated and observed my movements in the prior years had lived before they removed this team in anticipation of my programmed departure.

During Summer 2005, I met for 10 or 15 minutes in person with an attorney in the US Attorney's office for Western Washington as I handed over a complaint letter for service on FBI, having been so directed by the security guard at the Seattle FBI Field Office. I also handed a letter to Rep. Adam Smith at the Westin Seattle valet parking portico and delivered one to Rep. Jay Inslee's office in Montlake Terrace, WA. I sent complaint letters to FBI, DOJ, IRS and EOP in DC, some of which were acknowledged as received, some never acknowledged as received. In September 2005 I hand delivered letters to DOJ,



FBI, and IRS headquarters locations, and to the Executive Office of the President at the New Executive Office Building as well as several members of Congress, including Cantwell, Murray, and Specter.

My documentation of these events through late 2005, including original notes and receipts is likely in the hands of FBI or another federal agency as it was shipped back and forth between my parent's residence in Pierce County, Washington and my Cliffside Park, NJ and Ramsey, NJ residences. It was likely intercepted and copied or photographed during those shipments. BRMT is likely what caused me to discard the original banker's box of documents in a dumpster in the months before my November 2018 move from Ramsey, NJ to Edgewater, NJ.

No action was taken, no response or acknowledgement was received in 2005 nor at any time since, from any of these parties. Events and indirect threats continued to spiral aggressively through 2005, and my situation become increasingly tenuous. This led to my flight to Boston from the Seattle area on December 23, 2005, as I was clearly being driven to homelessness and destitution. I decided to avoid endangering other family members by remaining in the Seattle area, making them alternative targets so the involved police and intelligence powers could more easily coerce me by going after them.

After about 4 months in a Boston area hotel, I exhausted my resources and entered the Pine Street Inn homeless shelter system where I remained until my fake employment from August 2007 to June 2008 by "Establish Inc," supposedly a logistics consulting firm in Fort Lee, NJ. While there, I "worked" on fake software projects at PPG headquarters in Pittsburgh, PA, and for Clipper Windpower, a now defunct wind power manufacturer, in Carpinteria, CA and Cedar Rapids, IA.

I filed a Complaint in US District Court in Newark, NJ, in Summer 2010 (10-3204-SDW-MCA filed June 23, 2010) modeling it on a Complaint I had found online. A few days after that filing, my landlord informed me I was being removed and replaced as a tenant at my Cliffside Park, NJ apartment and replaced by another person. I again became homeless, was misdirected to a non-existent shelter from a full shelter in Hackensack, then after one night in a South Hackensack low-end motel, I called 911 on myself, reported my situation accurately to the responding EMTs in the presence of a South Hackensack police officer, and was involuntarily committed to a locked hospital psych unit at Bergen Regional Medical Center in Paramus, NJ. I later provided a copy of my Complaint to a psych nurse on the unit who gave it to my doctor.

I remained there in various locked psych units with little access to the outdoors, exercise, or other people, and with no visitors for six months. It was only after I renounced my previous accurate statements in the Complaint and to the EMTs and admitting doctors on this matter (which at that time I did not understand as well as I do today), that the attending psychiatrist would consider my release. Otherwise, I would likely still be there in long-term "care."

With approval from my doctor after renouncing the facts, I entered a housing assistance program which transitions mentally ill to residential housing. On March 31, 2011, I moved to a shared apartment in Ramsey, NJ where I remained until November 2018, when I received a Section 8 housing voucher for my current residence in Edgewater, NJ. The official transition from the transition assistance program Advance Housing is formally underway now as indicated on the enclosed email. I provided various independent psychiatric evaluations taken recently online in my DC US District Court Complaint 22-cv-996 Exhibit 1 (blue paginated Document 1-1, pages 1-48).

During my drafting of this letter on July 19, I encountered a tall, thin homeless appearing male character on my way back from the Acme Supermarket a little before 11AM. This is the same sort of visual messaging I saw in my other previous neighborhood in Kirkland while living in the apartment there. In that case, it was a man who was driving a very old American car intended to make it seem he was living out of his car.

As a solitary scene, it would not mean much to the average passer-by. But as part of an on-going series of similar psychological operations sequences undertaken every time a subject is in a public place, it eventually cannot go unnoticed. Since these scenes occur in fairly prosperous suburban and edge-city areas, rather than on the streets of New York City, for example, they are intended to convey a targeted message to the subject. Yet another example of the types of psychological operations undertaken in an on-going effort to psychologically panic and drive the subject to act out. Psychologically coercive operations which are an important part of the program I have nicknamed "Liberty For Just Us et al."

#### **Other Patterns of Harassment Being Repeated**

Just to demonstrate that no harassment by these police powers teams is too small, I have attached a July 19, 2022, letter to CapitalOne which includes reference to a form of malicious hack which requires access to the financial systems used by major financial institutions. The issue in question is a returned \$8.00 ACH payment rejected by Wells Fargo and returned to CapitalOne as indicated in the second screenshot. The Wells Fargo account number shown on CapitalOne's system was correct when copied directly from the Wells Fargo webpage using copy and paste commands to add it as an external account for payments to CapitalOne. It was still correct on July 19, 2022, when checked, as shown in the first screenshot (correct account 9749). A hack of the CapitalOne system or of the ACH payment system used to transmit transactions between banks would be required to change the account number used in the ACH to the incorrect number shown in the second screenshot (incorrect account 2974) and properly rejected by Wells Fargo.

Here is a little further color related to these harassing programs. A prior starve out campaign involving BRMT induced oxytocin (the "love" hormone in the brain) was used to facilitate a \$6,000 online romance scam while I lived in Ramsey from 2011 to 2018. While there, I also used about \$5,000 to \$7,000 of personal Social Security and credit card funds in late 2017 and early 2018 to add an over-stove microwave and replace various badly outdated appliances and moldy furniture at my shared residence, presuming I would be there considerably longer. These expenditures were followed rather quickly by the award of a Section 8 housing voucher, now being used to pay some of the rent at my current residence in Edgewater.

It is very likely a police powers cutout was substituted for a real representative of United Way in the Summer 2018, so I was unable to borrow the \$2,000 security deposit required to move to Edgewater. So, it had to come out of pocket. My Social Security monthly stipend was about \$1,750 per month at the time. And, of course, I then had to spend a considerable sum to furnish my new vacant residence. In June 2022, a past due \$5,000 credit in collection from that 2017-2018 period was used to obtain a default judgement in Bergen County Superior Court. I then changed banks several times before realizing my current Social Security payments cannot be garnished using this default judgement. Neither American Express nor Discover, the major banks I opened a checking account at, was able to maintain an accurate account balance. All this was coincidental or carefully timed to minimize my available funds and maximize my debt load. Given the history of pattern repetitions, I leave that conclusion to you.

205 Neither American Express nor Discover Bank provided accurate real-time balances (extremely  
206 unusual for any major financial institution), so I was forced in one case to wait on hold for 5 hours over  
207 two days to get my account unfrozen and an accurate balance at Discover Bank. I moved my Social  
208 Security ACH several times until I found a bank which provided reasonable online access, an online bill  
209 payment system, and providing accurate real time balances. As a former Deloitte Financial Services  
210 specialist in the 1980s who worked with the FDIC, major banks, and community banks, I find the service  
211 levels experienced extremely peculiar.

212 Apparently Wells Fargo is an institution my police powers handlers find acceptable, so there  
213 have not yet been any further issues in this particular area. Many others, of course, as mentioned in this  
214 and other letters – but not this one at present. One more illustration of how these efforts impacted me  
215 personally – my FICO 8 score in October 2005, even after an extended period of financial distress – was  
216 770. The FICO 8 score range is 300 to 850. It has been as low as the high 300s in recent years as a result  
217 of the much more aggressive malign actions undertaken against me.

## 218 219 ***Summary***

220 My primary point here regarding my own situation is to reinforce the repetitive nature of the  
221 current indirect violent threat and harassments environment and the similarities to prior episodes over  
222 the past several decades. These police powers and intelligence operations are now engaged in yet  
223 another long duration repeat cycle. Where this cycle leads is unclear. Previous episodes had no verbal  
224 content, it was entirely visual.

225 Repeat episodes of explicit indirect visual threats of violence have now been escalated to  
226 include explicit indirect verbal threats of violence as well.

227 As to others, I continue to be extremely concerned and highly confident that there are people in  
228 similar and worse circumstances because of this malign coordination among various police powers and  
229 intelligence operations, their alumni who otherwise benefit in some direct or indirect way, their criminal  
230 connections, and their political connections. Their underlying rationale in my situation is to perpetuate a  
231 decades-long cover-up of BRMT and the vast sequence of malign acts against me and others.

232 I certainly do not condemn legitimate justice and national security operations but not all police  
233 powers and intelligence operations are for the purpose of enforcing our laws, securing justice, or  
234 protecting legitimate politically-neutral national security interests. Some merely use color of law to  
235 perpetuate cover-ups of institutional corruption, anti-democratic political aspirations, and criminal  
236 activity.

237 Those wrongly executed by others using staged accidents, manufactured scenarios, or other  
238 natural appearing events in field operations; those wrongly incarcerated using psychological and/or  
239 financial coercion against targeted subjects lacking extreme emotional stability; those who have  
240 experienced extreme and persistent psychological operations and been injured; and persons otherwise  
241 emotionally or financially destroyed by these predatory acts ALL require justice and a full accounting for  
242 these corrupt abuses under color of law.

243           Without fear or favor, these institutions must be held to account for their premediated and  
244 predatory actions.

## **Addendum – Past Mass Casualty Event Potential**

Bio Lab warehouse fire in Conyers, Georgia – my brief research of news article summaries conducted this week on this May 25, 2004 event indicate that it had the potential to be a mass casualty event. While Bio Lab claimed use of bromine as the primary pool chemical they manufactured and sold when communicating with me, this fire involved 250,000 pounds of dry chlorine pellets. Chlorine combusts to chlorine gas like that used in chemical warfare during World War I. Area evacuations potentially saved the lives of thousands of people. (See Bio Lab on page 2 of the “Possible Cross Connections” enclosure in my July 12 letter.)

US Airways flight 1549 departing LaGuardia on January 15, 2009, carried 150 passengers and 5 crew members to an emergency landing in the Hudson River. This event was forecast in the sequence of “movie trailer” scenarios run and described in my May 16, 2022 letter.

It is notable that the Bio Lab fire occurred in the leadup to the reelection of President Bush. The US Airways 1549 incident occurred 5 days before the end of his second term during some high level maneuvering related to the naming of the incoming national security team. No mischaracterization of the President’s motives is intended.

However, we understand the public and international perception of the United States and its national security posture can be manipulated and profoundly influenced by mass casualty events. Given this fact set, and the various front running “movie trailer” scenarios I have witnessed and reported in my letter series, these scenarios raise suspicions of a potentially deadly sequence of internal political meddling and sabotage, not random accidents or coincidentally timed incidents.

This behavior would be consistent with the expressed opinions of some, including members of the police powers, intelligence, and military community. A few of these people would have or had direct or command access to BRMT, which can hack/hijack the brains of humans and other animals. These attempted mass casualty events may well have been a leading edge reflection of the anti-democratic attitudes and approaches which are more openly expressed today. I recognize this is speculation but do not believe it can simply be ignored as a fringe hypothesis given the tenor of our times.

## **Addendum – Additional Morphological Comparable**

It is possible that the person Identified as Zoe Schumaker in my July 15, 2022 letter may also have been the Women’s Tennis Coach and my tennis class instructor at Washington State University sometime between Fall 1974 and Spring 1977. The relevant date would be indicated in my undergraduate transcript. My WSU student id was 10756-743 I believe. Schumaker and the tennis coach were similar in stature and physical appearance but, as before, this is for evaluation only not a positive identification.

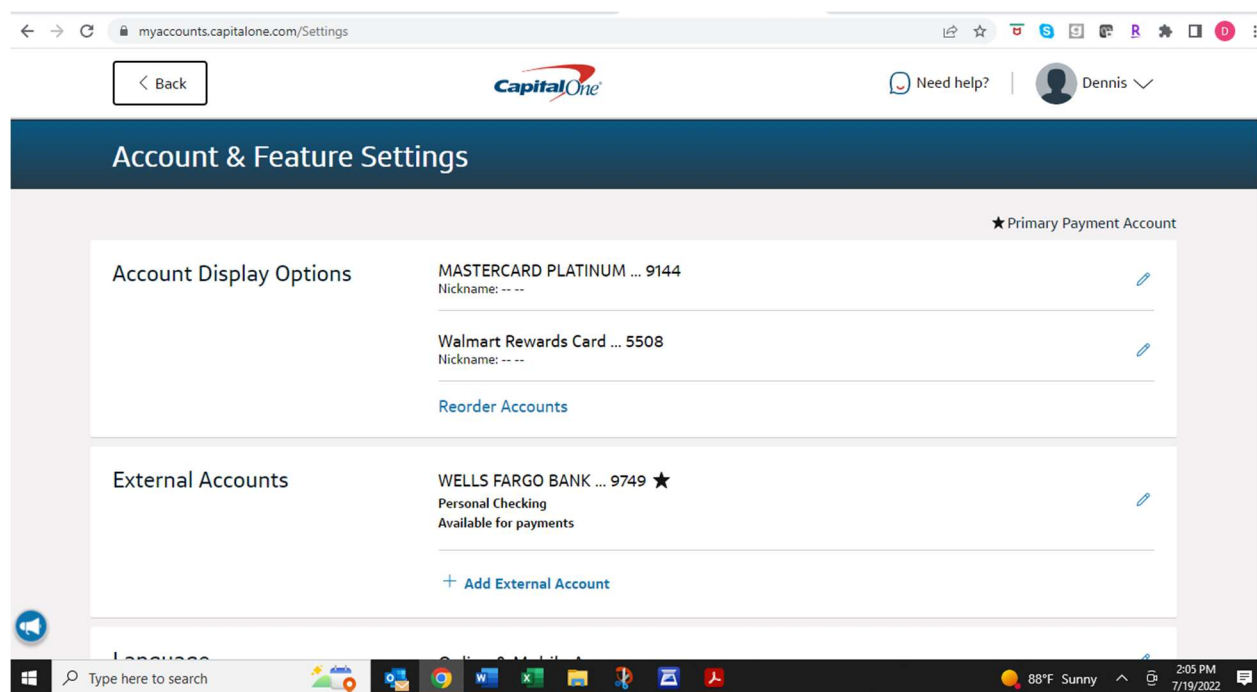

22 **Brain Computer Interface Receives FDA Approval For Initial Phase of Commercialization**

23  
24 A brain computer interface system requiring physical implantation has been FDA  
25 approved for human trials as documented in the enclosure. This system, developed since 2012  
26 by Synchron, in Brooklyn, New York, can be used to manipulate external hardware such as  
27 artificial prostheses, smartphones, and computers simply by the act of thinking. Its capabilities  
28 offer a practical, though more primitive, version of the technology I call BRMT (Brain Remote  
29 Management Technology). BRMT is used by defendants for brain hijacking/hacking as  
30 extensively discussed in other letters and the DC US District Court Complaint 22-cv-996 (blue  
31 paginated Document 1 pages 32-36).

32  
33 This clearly demonstrates that a covert ultra-secret system like BRMT, which has  
34 potentially benefitted from billions of dollars of investment in research, development, and  
35 deployment as the ultimate national security weapon, and is in its fortieth to fiftieth year of  
36 continuous improvement and use, is not a mere fantastical delusion.

43 The most directly relevant category is neuroscience, though other research domains  
44 related to bio-systems, leading edge computing and communications systems, artificial

intelligence, neural networking, deep learning and visualization, and very large scale systems integration are also relevant to developments of this type of technology.

Brain computer interfaces and similar devices have not previously appeared in any of my extensive web research on this class of devices, despite my persistent efforts to locate this type of technology. It is extremely probable that this prior cloaking during my web searches is due to defendants' active hacking efforts to hide such technology from me. Had I been able to locate this information, it would have been used, perhaps in 2012 or so, but most certainly in my 2020 and 2021 research, and in my September 2021 Complaint and the seven later DC Complaints. It plainly illustrates the technological feasibility of systems like BRMT to technologically uneducated District Court judges. Combined with my attempts to contact computational neuroscientists, which were also disrupted by wire fraud, this documentation may well have persuaded the District Court to admit my Complaint in September 2021 rather than to peremptorily dismiss it as fantastical. Witness tampering and wire fraud are two offenses that spring to mind immediately, though there may well be others, of course.

Please note that my understanding of the BRMT system has significantly improved since the drafting of the 2010 Complaint. The physical description of BRMT in 10-2034, at that time named by me as "Biomedical Manipulation Device" is inaccurate and ought to be disregarded. An active electronic physical device implanted in the body is not required to perform the BRMT functions described in the 2022 Complaint 22-cv-996 in DC US District Court. Further, many of the defendants named in the enclosed NJ Complaint 10-3204 would be more properly considered as witnesses or, in some cases, future plaintiffs rather than defendants. The most accurate description of BRMT is included in blue paginated Document 1 pages 32-36 of Complaint 22-cv-996 filed in DC US District Court.

### **Long Cycle Personal Economic Instability Repeatedly Engineered by Defendants**

In 2009, Chalom, the landlord, asked me to fix up the Cliffside Park apartment I lived in. Since I was on unemployment assistance after being terminated from my wire fraud enabled fake employment at Establish Inc in Fort Lee, NJ in the Summer of 2008, I could not turn down this work without losing my eligibility for unemployment benefits. I spent hundreds of hours and thousands of dollars to improve the unit, replacing floors, walls, cabinets, counters, and sinks, then was reimbursed \$5,200 for about \$13,000 of remodeling materials, supplies, labor, and related expenses. Since I was, by defendants' design, again unemployed and tapped out financially; and was told, by the landlord after the fact, that NJ law required a written contract for any project over \$5,000; I did not legally contest this outcome.

As stated in my July 20, 2022, letter, I filed a Complaint in US District Court in Newark, NJ, on June 23, 2010 (10-3204-SDW-MCA) modeling it on a Complaint I had found online. A few days after that filing, landlord Chalom sent me a certified letter at my Cliffside Park, NJ apartment, presumably giving me notice to vacate the apartment at the end of August.

88 I did not receive the letter due to a conflict with the clerk at the USPS Cliffside Park, NJ  
89 Post Office, who alleged the signature provided did not properly match the name on the letter.  
90 I hastily left the Post Office after being pushed toward anger by the clerk's refusal and BRMT-  
91 stimulated frustration. My intentional departure without the letter after this person's refusal of  
92 my electronic signature was to avoid any potential conflict with this person, most likely a postal  
93 inspector or other police powers official, so the certified letter remained there until returned to  
94 sender.

95  
96 On October 1, 2010, I left my Cliffside Park, NJ apartment for the last time, for my  
97 second episode of homelessness since 2005. I took a shoulder bag and a roller bag, caught a bus  
98 to Hackensack, and walked to the homeless shelter there. They told me it was full and directed  
99 me to a nearby overnight shelter which permitted people to stay one night at a time, similar to  
100 the daily lottery system I had previously experienced in my first months at Pine Street Inn in  
101 Boston. Except for one thing. Despite being given very explicit instructions about its location  
102 and street address, I found it did not exist. So, I made my way to the Hackensack Police station  
103 and was directed, after a 30 or so minute wait as the only person in the outer lobby by an  
104 apparently otherwise occupied desk sergeant sitting at the desk, to a low-budget motel 2 miles  
105 away in South Hackensack.

106  
107 The following morning, I had exhausted my funds, was in personal psychological crisis  
108 enhanced by BRMT induced fear and anger, so I called 911. The dispatcher sent the South  
109 Hackensack Police and EMTs. I described BRMT as best I understood it at that time (see 2010  
110 Newark District Court Complaint 10-3204) to the EMTs, was transported and held for about 12  
111 hours in the Emergency Room with a local police officer outside my door, then was involuntarily  
112 committed to Bergen Regional Medical Center Behavioral Health facility (psych unit) on  
113 October 2, 2010. I remained there until March 31, 2011, in various locked psych units.

114  
115 So, I was unable to pursue my Newark US District Court Complaint 10-3204 and was  
116 forced to voluntarily withdraw the Complaint. This can be interpreted as either my sensible  
117 judgement given my circumstances (in a locked psych ward involuntarily committed and  
118 involuntarily medicated) or as defendants' carefully timed planned removal to my second  
119 homeless episode or an alternate form of detention for six months. Either way, it seems the  
120 purpose was continued evasion of legal accountability while acting under color of law.

121  
122 The careful timing of my 2010 removal after the Complaint was filed conforms to the  
123 repeated asset stripping pattern of defendants, perpetuating involuntary servitude and other  
124 constitutional and civil rights violations since at least the 1980s.

### 125 126 **Current Inquiry Underway Regarding Homeless Cycle Repeat**

127  
128 I am currently conducting an inquiry to determine if my Section 8 Housing Choice  
129 Voucher renewal application may have been deliberately misdirected. I received the routine  
130 reapplication some weeks ago and returned it as directed. However, the application was mailed  
131 to a non-standard address as directed in the cover letter. The correspondence was typical of

prior renewal correspondence except for that detail. As I checked this out, there is no indication on the website accessible to me of the closure of the office I would normally return correspondence to. So, I may have received fraudulent instructions regarding the return. This may result in the loss of the Section 8 subsidy I receive and force me again from my home, leaving me with no housing yet again. The waiting list is currently closed and it took years once I was able to apply to the list to secure a Section 8 voucher.

### **Institutional Failures Empower Criminal Conduct Against People**

I note again here there was never any official written response to my prior meeting and letter served on FBI in the US Attorney's office in Seattle; to my personal delivery to Rep. Adam Smith at the Westin Seattle, to Jay Inslee's Montlake Terrace, WA office; nor to my mailed FTCA letters to the agencies and EOP in Summer 2005; nor my in-person deliveries of those same letters in DC between September 6- 9, 2005, to the headquarters of DOJ, FBI, and IRS, the Executive Office of the President, and several Congressional offices, all during the week leading to Sunday, September 11, 2005.

Sadly, this corrupt pattern – defraud, delay, deny, repeat, with other programmed destructions and humiliations thrown in - was already rather familiar by 2005. I had experienced this same cycle in my 30s, in my 40s more than once, and in my 50s more than once. Since that time, the cycle has repeated in my early 60s. It may well repeat yet again as the overall set of malign behaviors have never ceased. In each of these cycles, the relationships and assets I had worked for have been repeatedly stripped away.

The defendants' goal of course, is perpetuated subjugation, penury, and servitude, making it extremely difficult to pursue a civil remedy against the defendants' egregious behaviors under color of law, much less support any criminal complaints against this interlocking set of institutionally corrupt defendants and their allies among the general public.

I'm not including stunts and silliness undertaken by the public on the streets here in NJ and NYC. Some of these are initiated by the general public and/or coordinated among off-duty police powers personnel for various political purposes or as mildly harassing objections to opinions I hold about certain police powers conduct, the usefulness of vaccines, and certain political behaviors and conduct. That happens all the time, I'm quite used to it.

But the civil and criminal violations pattern, first formally communicated to the agencies in 2005, and incorporating more than 30 types of violations of constitutional rights, civil rights, and laws, clearly documented in both the NJ US District Court Complaint 10-3204 and in the DC US District Court Complaint 22-cv-996, are pervasive, perpetuated violations of law.

As we know, criminal behavior is emboldened by the lack of consequences and accountability for criminal acts. *United States v Reynolds* (1953) has been the key in my situation since the beginning, whether it was the first obvious Greenwater, WA area encounter in 1972, or sometime earlier or later. The defendant agencies have hidden behind a national

security exemption by engaging me as the subject with secret and ultra-secret intelligence and military technologies under color of law. Then along comes 9/11/2001, and institutional incompetence is rewarded with enhanced powers against the People under counter-terrorism laws, functionally enabling terrorization of citizens, while emphasizing jointness (for example, with NYPD, which is well known for its patterns of civil rights and criminal violations, in an acknowledged JTTF investigation), by mere reclassification – whether as a national security risk, or for their Muslim faith, or whatever other excuse is contrived. The perfect answer for self-exculpation under color of law, get another agency involved, engineer the subject’s situation, and work jointly toward the outcome you want.

### **The Inevitable Logical Conclusion of Durable Patterns of Facts and Evidence**

This leads those of us similarly situated to the well-reasoned and inevitably logical conclusion, based upon long-running patterns of facts and evidence, that institutional non-compliance with law and due process is acceptable for federal police powers agencies in these United States. And, if it serves their purpose, they will employ jointness mechanisms like JTTF, and a dose of “need-to-know,” seasoned with criminal penalties for identifying undercover personnel, to incriminate whomever they so choose. It not every operation, but here it is.

One merely need be pre-designated as the subject/victim of corrupt intent under color of law. For example, neither FBI, nor CIA, nor any government employee, ever received any sanction for their decades-long institutional abuses of citizens such as Cointelpro and MKUltra. Felonies committed, evidence destroyed, lives destroyed, murder perhaps sanctioned or at least reasonably foreseeable in these programs. Nevertheless, the FBI Director retired with honors, the CIA Director confirmed as an Ambassador and shuffled out of the country. Institutionally authorized corruption rewarded, non-compliance implicitly endorsed. By the Executive, including the Department of Justice; by Congress for whatever length of time they choose; and by the Courts abrogating responsibilities they hold under the Constitution to some bizarre, blind, perpetual trust in the Executive. Constitutional violations of all three branches sacred duty to protect the People who created and empowered them, and of the Constitution to which all swore a solemn oath. Constitutionally proper or amorally, technocratically correct?

*United States v Reynolds 1953* is the best governmental defense for criminal conduct against the People ever contrived. USAF perjury in an affidavit cited national security to hide negligent maintenance of a B-29 flying despite an emergency airworthiness directive. The US Attorney failing to carefully examine the facts, the District Court failing as well. Appeals brought the Executive a blanket exemption from review, bought the government a broad-gauge exemption from its practical responsibility and liability for actions and failures, called sovereign immunity, but employed more like imperial impunity. Offenses against the government, such as those of individual government employees Aldrich Ames (CIA) and Robert Hanssen (FBI) were met with life in prison as they should be. Apparently “national security” is far too important to protect the People from institutionally acceptable crimes against the People under color of

218 national security. Or perhaps there is a simpler explanation, mere corruption of the criminal  
219 legal process.

220  
221 Since at least the 1980s, the defendants have simply consumed massive amounts of  
222 taxpayer resources in my situation alone. Cumulative direct expenditures by now in my case are  
223 doubtless in the tens to hundreds of millions of dollars among federal, state, and local police  
224 powers agencies. These public funds have repeatedly been spent arranging my penury and  
225 servitude over the past forty-plus years, in planning and implementing defendants' cycles of  
226 criminal acts under color of law so long as they can be engineered to look like natural  
227 consequences. It takes considerable effort, financial and technical resources, and personnel to  
228 perfect and perpetuate these schemes. But with a trillion dollars available for allocation across  
229 military, intelligence, and police powers operations at the federal level; secrecy and need to  
230 know hierarchies; and blanket exemptions from review hiding nearly all visible traces, it has  
231 been repeatedly pulled off to great effect.

232  
233 Over the decades, as the corrupted lower ranks are promoted to become the corrupt  
234 upper ranks, defendants perpetuate these schemes at taxpayer expense for their own self-  
235 exculpation. They perpetuate and endlessly repeat entrapment and incrimination attempts,  
236 desperately seeking some way to cause the victim to act out along the way. Physical or  
237 technical violation – it doesn't matter, just something, anything.

238  
239 Blame the victim – the perfect crime. Sort of like perpetual motion (at taxpayer  
240 expense) except, of course, it's perpetual corruption (at taxpayer expense).

241  
242 If there is some alternate well-reasoned and logical conclusion based upon this decades  
243 long, durable pattern of facts and evidence, I look forward to learning it.

P.S. – The durable answer to institutional corruption is to empower a separate agency, outside the control of those with police powers and intelligence powers to watch those watchers. To receive federal funds, the civilian, military, or intelligence operation must allow complete and total access to their systems and personnel, to examine patterns and practices, to protect whistleblowers, and to encourage others to come forward. Place this agency under its own governance structure with the full force of the legal system behind it to minimize political interference with the mission. Stagger terms of the governance structure members and do not permit crossover from this agency into police powers organizations to eliminate the appearance of headhunting or other bias. Budget it at about 10% of total expenditures in these domains.

Will the agencies and unions protest, drag out their PR machine, and insist they are always and forever the good guys? Sure. Who wants independent institutional accountability if you've never had it in any systematic way? The mob certainly preferred J. Edgar Hoover's decades long insistence that organized crime did not exist. The country will watch the mess unfold over a decade or so as things seem to be getting worse, just like when an organized crime syndicate encounters the justice system.

This is the only authentic, durable way to clean this mess up and keep it clean. Internal accountability systems have clearly and repeatedly failed in this mission. Who bites the institutional hand that feeds you? MKUltra and Cointelpro prove this. Rape in the military proves this. All these institutional corruption scandals have proven one thing. Decades of institutionally accepted abuse, with little or no redress, penalties, or time served by anyone, may someday result in a review by someone, eventually, maybe, if enough people die or enough people bring pressure on that specific institution. But it's spasmodic, episodic, and frequently ineffective. Then it needs to be done over again after another cycle of abuses is exposed, then another, then another.

Clearly worthless; sending exactly the wrong message; empowering and implicitly authorizing further institutionally endorsed offenses against the People. These types of offenses continue today at all levels of government. We have far better, more independent systems for the protection for People's money than we do for People's lives at the hands of the institutionally corrupt. Particularly those who can invoke the cloak of national security to sustain abuses while claiming absolute immunity for acts that clearly and repeatedly demonstrate imperial impunity. In 2020, FDA awarded the stentrode™ the Breakthrough Device Designation. In 2021, Synchron became the first company to receive an FDA IDE to conduct trials of a permanently implantable BCI.

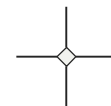

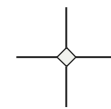
