Daniel – It will be significantly more difficult to fill orders with cherry-picked cuts from the carcass, particularly with Berkshires in short supply. We would strongly prefer they continue to accept 6-way cut carcasses. If they have a strong and continuing demand for Berkshires, we would be willing to sign a multi-year contract with them to supply these hogs once we get past the trial order. Given our sourcing challenges on this item as of this moment, it is unlikely we will be able to source 5-10 containers per month in the short run.

They had also mentioned a variety of other products suitable for beef and dairy. They are working a new supercarb product for dairy with Organic Valley now. Very nice people, worth a discussion. FYI – We are shipping \$3MM of beef and pork to China over the next month. If our trial orders go well, we can expect volumes to increase by 5-10 times in 2.5 to 3.5 months later for regular orders. Then it will take about 60 days to get everything in place in Missouri to commence organic finishing operations. So, we are 5-6 months out from the first days of finishing operations most likely.
