Re: Proposal to Purchase approximately 3,559 acres, more or less, in Lake County, Oregon.

Dear Mr. Brandon Hutchison:

This letter ("Letter") is intended to summarize the principal terms of a proposal being considered by Sheldon Beef Inc, ("Buyer") regarding the possible acquisition of approximately 3,559 acres, more or less, in Lake County, Oregon. The possible acquisition is referred to as the "Transaction." Buyer and Sellers are referred to collectively as the "Parties."

#### 1) Acquisition of Real Property and Improvements.

- (a) Subject to the satisfaction of the conditions described in this Letter, at the closing of the Transaction, Buyer would acquire directly, or through a subsidiary to be formed, all the real property and improvements thereon for the total proceeds of \$3,350,000.00.
- (b) The Buyer will issue a Secured Subordinated Note to Sellers for \$2,250,000.00, at 6.50% per annum simple interest only, paid monthly in arrears, with all remaining interest and the full amount of the principal balance of the Secured Subordinated Note to be repaid three (3) years from the date of the Closing. Said Note shall be secured by a second lien interest in all real property and improvements.
- (c) The Buyer will make a Cash payment of \$1,100,000.00 at Closing.
- 2) Proposed Purchase and Sale Agreement. As soon as reasonably practicable after the execution of this Letter, the Parties shall commence to negotiate a Purchase and Sale Agreement (the "Agreement") relating to Buyer's acquisition of the real property and improvements, to be drafted by Buyer's counsel. The Agreement would include the terms summarized in this Letter and such other representations, warranties, conditions, covenants, indemnities, and other terms that are customary for transactions of this kind and are not inconsistent with this Letter.
- **3) Buyer's Conditions.** Buyer's obligation to close the proposed Transaction will be subject to customary conditions, including:
  - a) Buyer's satisfactory completion of due diligence;
  - Buyer's receipt of cash proceeds from financing transactions in an amount necessary to finance the Transaction, pay related fees and expenses, and provide adequate ongoing working capital, on such terms and conditions satisfactory to Buyer;
  - c) the Seller's approving the Transaction;
  - d) the Parties' execution of the Agreement and any ancillary agreements;
  - e) the receipt of any regulatory approvals and third-party consents, on terms satisfactory to Buyer;



- f) there being no material adverse change in the Assets;
- g) Buyer's satisfaction as to its ability to assume and/or transfer all material permits related to the on-going operations of the Assets.
- **4) Sellers' Conditions**. Sellers' obligation to close the proposed Transaction will be subject to customary conditions, including:
  - (a) Subject to prior disclosure and consent by Seller during due diligence, Buyer shall assume all contracts used by Sellers in the operation of the Assets that cannot be terminated prior to closing without cost or penalty to Seller.
- 5) Title Insurance. The Parties would obtain title insurance from AmeriTitle Title Insurance Company located in Lakeview, Oregon (the "Title Company"). The Title Company closing costs would be split equally between the Parties. Seller would pay the premium for coverage up to \$3.35 million under a standard owner's policy. Buyer would be responsible for any extended coverage or endorsements requested by Buyer.
- **6) Due Diligence.** During the Exclusivity Period, Sellers will authorize Buyer, and its advisors, full access to the facilities, records, key employees, customers, suppliers, and advisors of the Seller to complete Buyer's due diligence review. The due diligence investigation will include, but is not limited to, a complete review of the financial, legal, tax, environmental records and agreements related to the Assets, and any other matters as Buyer's accountants, tax and legal counsel, and other advisors deem relevant.
- 7) Covenants of Sellers. During the forty-five days following the signing of the Purchase and Sale Agreement (such period, the "Exclusivity Period"), Sellers will maintain its properties and other assets in good working condition in a manner consistent with past practice (normal wear and tear excepted) and use its commercially reasonable efforts to maintain the assets in good condition in accordance with past practice.
- 8) Exclusivity. In consideration of the expenses that Buyer has incurred and will incur in connection with the proposed Transaction, Sellers agree that during the Exclusivity Period, neither it nor any of its representatives, officers, employees, directors, agents, stockholders, subsidiaries or affiliates (the "Seller Group") shall initiate, solicit, entertain, negotiate, accept or discuss, directly or indirectly, any proposal or offer from any person or group of persons other than Buyer and its affiliates (an "Acquisition Proposal") to acquire all or substantially all of the Assets, whether by merger, purchase of stock, purchase of assets, tender offer or otherwise, or provide any non-public information to any third party in connection with an Acquisition Proposal or enter into any agreement, arrangement or understanding requiring it to abandon, terminate or fail to consummate the Transaction with Buyer. Immediately upon execution of the Purchase and Sale Agreement, Sellers shall, and shall cause the Seller Group to, terminate any and all existing discussions or



negotiations with any person or group of persons other than Buyer and its affiliates regarding an Acquisition Proposal. Sellers represent that no member of the Seller Group is party to or bound by any agreement with respect to an Acquisition Proposal other than under this Letter.

- 9) Termination. This letter will automatically terminate and be of no further force and effect upon the earlier of (i) execution of the Agreement by Buyer and Sellers, (ii) mutual agreement of Buyer and Sellers, and (iii) the expiration of the Exclusivity Period. Notwithstanding anything in the previous sentence, Sections 9, 11, 12, 15, and 16 shall survive the termination of this Letter and the termination of this Letter shall not affect any rights any Party has with respect to the breach of this Letter by another Party prior to such termination.
- **10) Bid Expiration.** This offer and Exclusivity Period will remain in effect until 5:00 pm, MDT time, on the 45th calendar day after execution by both parties, unless withdrawn by Buyer prior to that time.
- 13) GOVERNING LAW. THIS LETTER SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH INTERNAL LAWS OF THE STATE OF OREGON, WITHOUT GIVING EFFECT TO ANY CHOICE OR CONFLICT OF LAW PROVISION OR RULE (WHETHER OF THE STATE OF OREGON OR ANY OTHER JURISDICTION) THAT WOULD CAUSE THE APPLICATION OF LAWS OF ANY JURISDICTION OTHER THAN THOSE OF THE STATE OF OREGON.
- **12) Confidentiality.** This Letter is confidential to the Parties and their representatives.
- **13) No Third-Party Beneficiaries.** Except as specifically set forth or referred to herein, nothing herein is intended or shall be construed to confer upon any person or entity other than the Parties and their successors or assigns, any rights or remedies under or by reason of this Letter.
- **14) Expenses.** The Parties will each pay their own transaction expenses, including the fees and expenses of advisors, incurred in connection with the proposed Transaction.
- **15) No Binding Agreement.** This Letter reflects the intention of the Parties, but for the avoidance of doubt neither this Letter nor its acceptance shall give rise to any legally binding or enforceable obligation on any Party, except with regard to Sections 7 through 16 hereof, which shall be binding on the Parties. No contract or agreement providing for any transaction involving the Assets shall be deemed to exist between Sellers and Buyer and any of its affiliates unless and until the Agreement has been executed and delivered.



**16) Miscellaneous.** This Letter may be executed in counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one agreement. The headings of the various sections of this Letter have been inserted for reference only and shall not be deemed to be a part of this Letter. Neither this Agreement nor any of the rights, interests or obligations hereunder may be assigned, in whole or in part, by operation of law or otherwise, by any Party without the prior written consent of the other Party.
