Good day –

I am sharing with you here my personal opinion about adverse experiences with court administration within the geographic boundaries of the District of Columbia within your administrative purview under SCOTUS Rule 10. This is not directly related to any matter currently before any court. It is a federal courts administrative matter only as presented here.

As the Court's Clerk's Office has obstructed these types of direct personal communications to you on two occasions to date (in their correspondence dated August 16 and August 30, 2023), I note here again that these personal opinions are offered in accordance with my First Amendment right to comment directly and without interference to public officials on matters of personal interest, including on government operations.

Personal Opinion on Matters of Court Administration

In the course of my attempts to litigate the BRMT and related racketeering criminal conduct in a civil matter for myself and others similarly situated, I noted deficiencies in court administration in the District of Columbia circuit between 2021 through 2023. Thirteen judges misapplied case law in *sua sponte* discretionary dismissals of *in forma pauperis pro se* litigation which is properly brought before these courts at both the district and circuit levels.

Since I encountered this pattern of practice at the district and circuit levels on eleven occasions, I believe this administrative problem of abuse of professional discretion (without proper reference to the standards imposed in *Denton*) likely also has and may continue to deprive others with *in forma pauperis pro se* complaints properly before these courts of their constitutional rights.

I bring this to your personal attention in this manner because even your own Court's Clerk operation has twice stymied and obstructed my personal communications with you as a government official under the First Amendment right to communicate my opinion directly regarding improper government operations (the initial July 25, 2023 letter was delivered to Chief Judge Boasberg and Chief Judge Srinivasan without incident) which impact other individuals as well by mischaracterizing my communications as improper Article III

communications, which they are not. I am more than willing to provide documentation of this obstructed path of personal correspondence at any time.
