All records from January 1, 1975 to the present, specifically including, without limitation,

Department of the Air Force: USAF/Boeing Decatur, Alabama Delta IV rocket plant design and construction and involving the Requester's employer, CNA Industrial Engineering, Bellevue, Washington. Any and all investigative records or reports related to Requester from 1990 to 2005, involving Requester as may relate to his family ties to USAF veterans and Officers supporting the USAF Boeing AWACS program. Any and all records of entry to McChord Air Force Base between 1990 to 2005.

Department of the Army: All records from January 1, 1975 to the present, specifically including, without limitation, contracts, bid inspection visits, and site inspections at Fort Lewis, Washington for environmental services between June 1990 and December, 1993.

Department of the Navy: Records dating to 1975 related to any DON contacts with Dennis Sheldon , including any and all paper and electronic records related to initial effort, including initial application, medical physical, tests, interviews by junior Naval officers, to enroll in the DON AVROC program in about 1975, any investigations, undercover operations, national security operations, and counter-terrorism operations. The Seattle FBI Field Office would be the primary source of original contact with the subject. Naval facilities subject visited, was in close proximity to, and/or worked in, between 1990 and 2002 included Keyport Torpedo Maintenance, Puget Sound Naval Shipyard, NAVFAC offices in Kitsap County, Puget Sound Naval Shipyard & Intermediate Maintenance Facilities (PSNS&IMF), Naval Undersea Warfare Center Keyport (NUWC), Naval Air Station Whidbey Island (NASWI), Naval Station Everett (NSE), Naval Radio Station at Jim Creek, Navy Acoustic Research Detachment (ARD) at Bayview, Idaho, as well as a 2002 Port of Seattle Pier 91 visit to complete an asbestos survey of a decommissioned Navy supply vessel to be used for Navy target practice. I have also visited Rocketdyne Folsom re F-35. My firm, CNA Industrial Engineering, was also involved in reviewing multiple satellite failures on orbit at Hughes Aerospace, potentially involving DON or NSA asset deployment. One incident in 2002 involved placing subject adjacent to an alleged nuclear submarine pump, a very highly classified piece of submarine technology, while the PSNS team touring with me left the area for 10 plus minutes. Subject was then being influenced by other deeply classified technology to lift the tarp covering the object on a pallet covered by a green canvas tarp. This technology has subsequently been used to attempt to modify subject's behavior to, among other things, open passenger aircraft doors during flight operations, assault children, etc.

Multiple Departments: I have also visited Rocketdyne Folsom re F-35 in 2004. My firm, CNA Industrial Engineering, was also involved in reviewing multiple satellite failures on orbit at Hughes Aerospace, potentially involving DON, NRO, and/or NSA space-based asset deployments around 2000-2001.

**Defense Counterintelligence and Security Agency:** As relates to any and all inquiries above conducted by this agency.

On knowledge and belief, these incidents and projects were national security elements of an FBI plot against the subject which later escalated to counter-terrorism. Recent counter-terrorism operations against the subject in the New York City and northern New Jersey areas have been confirmed by the NYPD. These operations also involve cooperative law enforcement agencies in various states across the US and other countries mentioned above, as well as US agencies involved in monitoring the domestic and international activities, travels, and communications of US persons in and with foreign countries such as China, Russia, Qatar, Israel, the Palestinian territories, etc., such as CIA, State, and/or NSA. Subject attempted to engage in both domestic and international commerce over the past 5 decades. Disruption of family life, commerce, and human autonomy, as well as all aspects of civil and Constitutional rights were experienced as elements of this and related US agencies disrupted subject. Full and complete disclosure of any and all such records in electronic form is requested. Various international visits and communications are covered by a separate FOIPA request to NSA. Subject is Indigent, lives on \$1738 social security retirement, and requests waiver of any and all associated fees.

This is in response to your 8 Dec 21 Freedom of Information Act (FOIA) request. The Air Force Personnel Center (AFPC) received your request via the electronic Public Access Link (E-PAL) on 8 December 21, and assigned case number is 2022-00990-F. Your request seeks releasable information regarding Michael Cunha as follows:

"Confirmation of the status of Michael Cunha (possible alternate spellings). Cunha was a Resident Assistant in Perham Hall, Washington State University, Pullman, WA when I was a sophomore in the 1974-1975 school year. Mr. Cunha was then reputedly in the USAF and bound for medical school to serve as a Doctor of Psychiatry. At the time, it appeared Mr. Cunha was in his early 20s. Mr. Cunha is potentially an important witness in special operations misconduct in the intelligence apparatus of USAF, other DOD elements, and other federal intelligence operations which violate the Constitutional and civil rights of US persons. Requester has no knowledge of any potential deployment location of Mr. Cunha and requests that the search be conducted so as to maximize the possibility of locating Mr. Cunha and confirming period he served in USAF. (Date Range for Record Search: From 09/01/1974 To 12/01/2021)".

AFPC sent you an electronic message on 10 Dec 2021, requesting a response from you by 23 Dec 21. This message concerned additional information from you (**provide Mr. Cunha's SSN and date of birth**) required to clarify and perfect your FOIA request.

AFPC has received your email response but the clarification information was not provided to perfect your FOIA request. Therefore, we are closing your FOIA case, as of the date of this letter, in according with DoDM 5400.07\_AFMAN 33-302, Section 6.3b.(6) **Not a Proper FOIA** Request for Some Other Reason which states, "The requester has failed unreasonably to comply with procedural requirements, other than fee-related requirements, imposed by this issuance".

This letter acknowledges receipt of your Privacy Act (PA) request dated October 05, 2021 and is an interim response. You requested:

All DIA investigative records, entry records, and related correspondence, including
correspondence (electronic and otherwise) with the FBI and/or elements of the Department
of the Navy, related to Requester's visits to Puget Sound Naval Shipyard in the first three
calendar quarters of 2002 related to a NAVFAC engineering study and equipment
reconfiguration project at the shipyard conducted in the Fall of 2002 by CNA Industrial
Engineering, Inc., Bellevue, WA.

All DIA investigative records and intra-agency and inter-agency correspondence (electronic and otherwise) related to material handling design engineering and supervision of material handling equipment procurement and installation, as related to the design and construction of the Boeing/Air Force Delta IV rocket assembly plant in Decatur, Alabama between June 30,1995 and its completion and startup by Boeing in 2002. CNA Industrial Engineering Inc was a subcontractor on this project under The Austin Company.

We received your request on October 12, 2021 and assigned it case number PA-00007-2022. Please use this number on all future correspondence with us regarding your request.

We are unable to respond to your request within the statutory 30 days' response period due to one or more of the following reasons, which are defined in the statute as "unusual circumstances": (I) the need to search for and collect the requested records from field facilities or other establishments that are separate from the office processing the request; (II) the need to search for, collect, and appropriately examine a voluminous amount of separate and distinct records which are demanded in a single request; or (III) the need for consultation, which shall be conducted with all practicable speed, with another agency having a substantial interest in the determination of the request or among two or more components of the agency having substantial subject-matter interest therein.

At this stage of processing your request, we cannot provide an estimated date of completion. As analysis and processing of your request continues, a case officer will better be able to provide an estimate, and at that time, we will provide you with a further interim response.

We typically process requests in the order of receipt. Our backlog currently is in excess of 1,900 requests. The time it takes to respond to a request will vary depending on the complexity of the request

and any backlog of requests already pending. If your request is complex, a case officer may contact you to discuss options for expediting your request, including: (I) narrowing the scope or focus of your request or increasing its specificity; (II) specifically describing record(s) you are looking for with additional descriptive details; and (III) including specific event-related information.

We regret that there is currently a substantial delay in processing requests and solicit your patience and understanding. We will process your request as soon as possible.
