Eli McWhinney spoke to the gallery on behalf of the ZBA. He started off by introducing himself. On behalf of the board, he again reviewed the process it will take for this application by the Legion. The first board is in front of the ZBA, in regard to the variance for road frontage. The town requires 200 feet and the application is asking it to be set back to 105 feet. If the ZBA approves this variance, it will then go in front of the Planning Board for a Special Use Permit. Then if the Planning Board recommends it to the County Planning Board for comments. At that time comments come back, and the Planning Board would recommend it to the Town Board who has final approval.

Eli then went on to express how the ZBA would like to hold another Public Hearing in August for the Legion's request. The board would like another hearing because we only just received the site plan at the June 17<sup>th</sup> meeting and the last Public Hearing for this project was in April. We want to allow all community members an opportunity to view and hear the new plans. The map we received in June amended the original application. New mailings would need to be sent out

by the Legion for this new public hearing by certified mail or door to door communication. Provided those community members with copies of the new plans and blueprints.

The board thanks Mr. McWhinney for being here and communicating to the gallery.

Mr. Swan expresses that he has a lawyer and would like contact information for Mr. McWhinney to pass on to his lawyer.

Mike Pfohl made a motion to set the date of the Public Hearing for the Legion application. It was seconded by Walt Youngers.
