Solar Project

Farmer, Roger Almeter, asked about the solar project proposed by ConnectGen. A brief explanation was given for the need to draft a new solar law. Our current solar law only permits commercial solar farms on Industrially Zoned property. Town Attorney David DiMatteo is working on a draft version that should be available soon for the Town Board's review. Mr. Almeter expressed his apprehension of turning agricultural land into solar farms. He also expressed his opinion that these farms would change the character of the Town. There was a short discussion between resident Deanne Siemer, Roger Almeter and the Town Board regarding what needs to be done with the proposed new solar law.
