Supervisor's Report

Supervisor Becker reported the following:

<u>County Spending – Coronavirus</u>

The County has spent over \$1.5 million on procuring PPE in response to the coronavirus pandemic. This is all unfunded expenditures. The County is in the position where cuts have to be made to departments. Councilman Kirsch asked if there is federal funding for the County. Supervisor Becker responded that it is possible. Senator Schumer was in Attica today speaking at the Attica High School regarding school relief. There is \$36 billion slated for NYS.

Wyoming County Treasurer Report Regarding Collection and Tabulation of Sales Tax Supervisor Becker forwarded a report via email to board members detailing how sales tax is

calculated and distributed to Counties in NYS.

Java/Sheldon Youth Soccer

Although the Sheldon swim program was cancelled this year due to COVID-19 the Java/Sheldon youth soccer program is continuing. There are 100 kids signed up. Sheldon will pay their portion of the soccer program at conclusion of the season.

Byrncliff Open Swim Program

Byrncliff reached out to Supervisor Becker and offered to host an open swim program for Sheldon families. The day of the week would be either a Wednesday or Saturday for four hours (1-5pm or 2-6pm). Cost to the Town would be \$60.00 per hour. Program would run 6-7 weeks. It would cost approximately \$2,000.00 for the Town to offer such a program. Masks would be required any time not in the pool. Pre-registration would be required and there would be a limit of 20 people.

A motion was made by Vince Kirsch and seconded by Mike Armbrust to authorize the Town Supervisor to sign a contract with Byrncliff for an open swim program for Town of Sheldon residents at the cost of \$60.00 per hour.
