# NYS Ag & Markets Report on Municipal Shelter

The yearly municipal shelter inspection report was submitted by the NYS Department of Ag & Markets - all boxes marked satisfactory. The Town Clerk and the Town Supervisor noted what a great job Justa Goodell does for the County and the great condition of the shelter.

# Reports

The Town Supervisor financial reports, Town Clerk report and Town Justice reports were distributed.

### **Open Public Hearing to Consider Improvements to the Town of Sheldon Varysburg Water** District

At 7:03 p.m. a motion was made by Joe Meyer and seconded by Mike Armbrust to open the public hearing for consideration of proposed improvements to the Town of Sheldon Varysburg Water District.

Ayes: (4) Becker, Kirsch Meyer, Armbrust Nays: (0) Absent: (1) Fontaine Motion Carried.

### Public Hearing – Varysburg Water Improvements

Supervisor Becker reviewed the need improvements to the Varysburg Water District. Supervisor Becker noted the following:

- The engineering plans submitted by Barton & Loguidice were shown to those in attendance and will be available via PDF once authorization is received from the engineering company
- Photos that showed damage to the equipment and facilities from chlorine exposure were shown
- Photos of the water tank were shown
- The 2 inch pipe on School Street needs to be replaced to at least 8 inch
- The projected cost of the project is \$2,619,000.00
- A WIIA grant could cover 60% of the cost
- Currently, the Town has a 39 year loan with USDA that equates to approximately a \$40,000.00 per year payment. \$26,000 of the \$40,000 is interest. The interest rate is 3.1%
- With approximately 152 EDUs this equates to approximately \$285 per EDU on tax bills
- Freedom Park Trailer Park in Varysburg was at 21 EDUs and will now be at 23
- Varysburg Hotel is billed for 4 EDUs
- Sheldon Elementary has been reduced from 14 EDUs to 2 pending the sale of the school to Lisa Reinig and Mike Flatt
- In response to a resident asking where the 12 EDUs that were reduced for the new owners of Sheldon Elementary go, Supervisor Becker replied that the cost will be shared by the remaining EDUs. He explained that the decision to reduce the EDUs for the school was mathematical the water usage for 2 adults will be much different than 100 children and staff. Councilman Armbrust noted that there may be additional EDUs added if the district extends to more customers such as the Boxlers and possibly other residents. Councilman Kirsch noted that the new business at the School site will not be rented out and will not be a place where people are coming in and out frequently. Kirsch continued that if the business plan changes in any way, then the applicants need to come back for permission from the Town Board.
- Supervisor Becker explained that there is only one meter at each location (one meter at the Trailer Park, one meter at the fire hall, one meter at the Church and one meter at the park) There may be multiple EDUs but only one meter.
- Supervisor Becker shows a map of the water district and explains that the district also includes some residents from the Town of Orangeville.
- If the Boxler business on Route 20A signs on for service they will be billed for more than one EDU
- At 7:30 p.m. Supervisor Becker asked if there were any other comments from the public on the Varysburg Water District. There were none.

- Supervisor notified the Board that they believe they found the water leak today. The District had been losing close to 50,000 gallons of water a day. The leak was across the street from Dollar General and the Fire Hall.
- Supervisor Becker noted that the Town paid the engineer \$25,000 for this engineering report and for their work in applying for a grant and potentially a USDA loan.

### <u>Resolution of the Town Board of the Town of Sheldon Approving a Proposed Increase of</u> and Improvement to Town of Sheldon Varysburg Water District

**WHEREAS**, the Town of Sheldon owns and operates the Varysburg drinking water district – a water system that consists of two (2) wells, a water treatment building, one (1) water storage tank, and approximately 2.5 miles of distribution water main; and

WHEREAS, various components of the existing water system are in need of significant rehabilitation or replacement due to age-related deficiencies or that said components no longer meet current health standards; and

**WHEREAS**, at the request of the Town Board of the Town of Sheldon, Barton & Loguidice has prepared a map, plan and report with regard to the Sheldon Varysburg Water System Improvements dated June, 2023, and the same has been filed with the Town Clerk; and

**WHEREAS,** the Town Board of the Town of Sheldon met at the Town of Sheldon Town Offices on the 19<sup>th</sup> day of July, 2023 at 7:00 p.m. for the purpose of conducting a public hearing on such proposed water improvements and to hear all persons interested in the subject thereof concerning the same; and

WHEREAS, in accordance with Town Law §202-B, the Town of Sheldon shall undertake certain capital water improvements for the Town of Sheldon Varysburg Water District; and

**WHEREAS**, the Town of Sheldon wishes to install a new water main to replace the outdated and undersized water main currently in use by the Town; and

WHEREAS, the Town further wishes to replace both well pumps, construct a new well house, rehabilitate the existing water storage tank, and acquire original furnishings, equipment, machinery or apparatus, and other incidental improvements that may be required for such water improvements; and

**WHEREAS,** the estimated maximum aggregate cost of said improvements is estimated to be \$2,619,000.00

WHEREAS, the improvements have been identified through public interest and the Varysburg Water District has ample capacity available to continue providing water to this district and proposed improvements; and

WHEREAS, the "Notice for a Public Hearing" with regard to the proposed water improvements was duly published and posted according to law, and said Town Board did, at the time and place specified, duly met and considered such proposal and heard all persons interested in the subject thereof, who appeared at such time and place, concerning the same; and

**ON MOTION OF** Vince Kirsch, which was duly seconded by Mike Armbrust, **NOW, THEREFORE, BE IT RESOLVED**, by the Town Board of the Town of Sheldon, in the County of Wyoming, duly convened, that it be and hereby is determined as follows:

(1) The Notice of Hearing was published and posted as required by law and is otherwise sufficient;

(2) That all the property and property owners, within the district of the proposed water improvements are benefited thereby;

(3) It is in the public interest to make the improvements; and be it

**FURTHER RESOLVED**, the water system improvements will serve approximately 150 Equivalent Dwelling Units (EDU's); and be it

**FURTHER RESOLVED**, the debt service for improvements are based on Equivalent Dwelling Units and the Town of Sheldon anticipates securing grants from the USDA Rural Development to partially fund the project through grant, while the remaining share will be paid for by a USDA Rural Development Loan in addition to all other local, state or federal funding; and be it

**FURTHER RESOLVED**, the total capital cost (estimated maximum amount) for the Town of Sheldon Varysburg Water System Improvements is \$2,619,000.00 which amount is to be financed by the issuance of serial bonds in an aggregate amount not to exceed \$2,619,000.00, such amount to be offset by any federal, state, county and/or local funds received including, but not limited to, a USDA Rural Development loan; and be it

**FURTHER RESOLVED**, the payment of debt service will be made by levy and collection of special assessments from the several lots and proceeds of lands within the Varysburg Water District which for the Town Board shall determine and specify to be specifically benefitted

thereby, so much upon and from each as such shall be in just proportion of the amounts of benefit conferred upon the same, to pay the principal of and interest on said bonds, as same shall become due and payable.

#### **Bond Resolution – Varysburg Water**

Councilman Joe Meyer presented the following resolution and duly moved that it be adopted and was seconded by Councilman Mike Armbrust:

BOND RESOLUTION DATED JULY 19, 2023 OF THE TOWN BOARD OF THE TOWN OF SHELDON, NEW YORK, AUTHORIZING GENERAL OBLIGATION SERIAL BONDS TO FINANCE WATER SYSTEM CAPITAL IMPROVEMENTS WITHIN THE TOWN, AUTHORIZING THE ISSUANCE OF BOND ANTICIPATION NOTES IN CONTEMPLATION THEREOF, THE EXPENDITURE OF SUMS FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the Town of Sheldon Varysburg Water District is a water district of the Town of Sheldon, New York, duly established by the Town Board pursuant to the Town Law and, pursuant to a resolution adopted on July 19, 2023, the Town has duly authorized additional facilities therein pursuant to §202-b of the Town Law; and

WHEREAS, the Town, acting as lead agency under the State Environmental Quality Review Act and the applicable regulations promulgated thereunder ("SEQRA"), has completed its environmental review and, on July 19, 2023, has duly adopted a negative declaration and has determined that the implementation of the type I action as proposed will not result in any significant adverse environmental impacts ; now therefor, be it

RESOLVED BY THE TOWN BOARD OF THE TOWN OF SHELDON, NEW YORK (hereinafter referred to as the "Town"), by the favorable vote of not less than two-thirds of all of the members of such Board, as follows:

<u>Section 1</u>. The Town of Sheldon shall undertake certain capital improvements consisting of the acquisition and construction of water improvements for the Town of Sheldon Varysburg Water District, duly authorized pursuant to Section 202-b of the Town Law, to include the installation of new water main to replace outdated and undersized water mains currently in use, addition of isolation valves to facilitate future shutdowns for water main repair, addition of sample and flushing points to better maintain chlorine residuals in the system, the replacement of both well pumps in kind, the construction of a new well house, and rehabilitation

of the existing water storage tank, and the acquisition of original furnishings, equipment, machinery or apparatus, or the replacement of such equipment, machinery or apparatus, and other incidental improvements that may be required in connection therewith for such construction and district use (hereinafter referred to as "purpose"), and general obligation serial bonds in an aggregate principal amount not to exceed \$2,619,000 of the Town are hereby authorized to be issued to finance said purpose, and bond anticipation notes in anticipation thereof (and renewals thereof) of the Town are hereby authorized to be issued to finance said purpose.

Section 2. The estimated maximum aggregate cost to the Town of Sheldon of said purpose, which may include preliminary costs and costs incidental thereto and costs of the financing thereof, is estimated to be \$2,619,000, and said amount is hereby appropriated therefor. The plan for financing of said purpose is to provide all of such maximum cost by issuance of bonds or bond anticipation notes as herein authorized, to be offset and reduced dollar for dollar by the amount of grants received, if any.

<u>Section 3</u>. It is hereby determined and declared that (a) said purpose is one of the class of objects or purposes described in Subdivision 1 of Paragraph (a) of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of said purpose is forty (40) years, (b) the proposed maximum maturity of said bonds authorized by this resolution will be in excess of five years, (c) current funds required to be provided prior to the issuance of the bonds or notes herein authorized, pursuant to Section 107.00 of the Local Finance Law, to the extent applicable, if any, will be provided, (d) the notes herein authorized are issued in anticipation of bonds for an assessable improvement, and (e) there are presently no outstanding bond anticipation notes issued in anticipation of the sale of said bonds.

<u>Section 4</u>. The bonds and notes authorized by this resolution shall contain the recital of validity prescribed in Section 52.00 of the Local Finance Law and such bonds and notes shall be general obligations of the Town and all the taxable real property in the Town is subject to the levy of *ad valorem* taxes to pay the principal thereof, and interest thereon, without limitation as to rate or amount, subject to applicable statutory limitations, if any, sufficient to pay the principal of and interest on said bonds and notes.

Section 5. It is hereby determined and declared that the Town reasonably expects to reimburse the general fund, or such other fund as may be utilized, not to exceed the maximum amount authorized herein, from the proceeds of the obligations authorized hereby for expenditures, if any, from such fund that may be made for the purpose prior to the date of the issuance of such obligations. This is a declaration of official intent under Treasury Regulation  $\S1.150-2$ .

Section 6. The power to further authorize the sale, issuance and delivery of said bonds and notes and to prescribe the terms, form and contents of said bonds and notes, including, without limitation, the consolidation with other issues, the determination to issue bonds with substantially level or declining annual debt service, all contracts for, and determinations with respect to, credit or liquidity enhancements, if any, and to sell and deliver said bonds and notes, subject to the provisions of this resolution and the provisions of the Local Finance Law, including without limitation, the authority to determine whether to accept bids electronically to the extent allowed by the Local Finance Law, and the power to contract and issue indebtedness pursuant to §169.00 of the Local Finance Law, if applicable, is hereby delegated to the Town Supervisor, the Town's chief fiscal officer. The Town Supervisor and the Town Clerk or Deputy Clerk are hereby authorized to sign by manual or facsimile signature and attest any bonds and notes issued pursuant to this resolution, and are hereby authorized to affix to such bonds and notes the corporate seal of the Town of Sheldon.

<u>Section 7</u>. The faith and credit of the Town of Sheldon, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds and notes as the same respectively become due and payable. Such bonds and notes shall be payable from a levy on real property in such district benefitted or user charges therefor, in the manner provided by law, but if not paid from such source, all the taxable real property in the Town is subject to the levy of *ad valorem* taxes to pay the principal thereof, and interest thereon, without limitation as to rate or amount, subject to applicable statutory limitations, if any, sufficient to pay the principal of and interest on said bonds and notes. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year.

<u>Section 8</u>. This resolution, or a summary hereof, shall be published in full by the Town Clerk of the Town of Sheldon together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the Town, in the manner prescribed by law. The validity of said bonds or of any bond anticipation notes issued in anticipation of the sale of said bonds may be contested only if such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or the provisions of law which should be complied with, at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

Section 9. This resolution shall take effect immediately upon its adoption. Ayes: (4) Becker, Kirsch Meyer, Armbrust Nays: (0) Absent: (1) Fontaine Motion Carried.

# **Open Public Hearing – Harris Corners Fire Contract**

At 7:45 p.m. a motion was made by Mike Armbrust and seconded by Joe Meyer to open the public hearing for the Harris Corners Fire contract. Ayes: (4) Becker, Kirsch Meyer, Armbrust Nays: (0) Absent: (1) Fontaine Motion Carried.

- Supervisor Becker asks why the Department is requesting an 8% increase for two years. Nick Kirsch replies that the price of fuel, the increase in cost for turnout equipment, increase in cost of repairs necessitates it.
- Supervisor Becker asks what the Department is asking from the Town of Bennington. Nick Kirsch replies that they are requesting the same amount as asked from Sheldon – an increase of 8% for 2024 and an additional 8% for 2025. Supervisor Becker explains the issue that occurred last year with Strykersville Fire when Sheldon approved the increase but the Town of Java did not. The Town of Sheldon then had to rescind it's approval as it would not have been fair to the taxpayers in the Sheldon portion of that fire district to pay a higher percentage of fire tax than their Town of Java counterparts. Supervisor Becker informs Harris Corners that we need confirmation that Bennington and Sheldon will be paying the same rate.
- The Board expressed their support of the 8% increase but will wait for confirmation from Bennington before accepting the contract

# <u>Close Public Hearing – Harris Corners Fire Contract</u>

- Ms. Reinig and Mr. Flatt replied that they intend to hold a sale open to the public on weekends up to twice a month
- Councilman Meyer asked if there would be any staff hired or sub-leasing to which Ms. Reinig replied that no, there would not be any sub-leasing or employees.

• Resident Bob Graham of Varysburg commented that he hopes the Board would allow some flexibility regarding UPS deliveries as deliveries don't always arrive before 5pm.

# Supervisor's Report

At 8:40 p.m. Supervisor Brian Becker reported on the following:

### Wyoming County Hospital

The hospital has applied for critical care designation which will allow the County to be paid additional money from Medicare and Medicaid.

#### Bill in NYS Assembly & Senate

Supervisor Becker informed the Board of a bill in the NYS Assembly and NYS Senate that would change local elections from odd years to even years (excluding Justice positions). The bill has not been signed into law by the Governor. Councilman Meyer noted that the Town Board passed a Local Law to have the Town of Sheldon's Supervisor and Town Clerk positions on opposite years to prevent losing both officials in the same year, which he stated would create bedlam. Supervisor Becker will keep the Board apprised if this bill becomes law.

### **County Run Ambulance Services**

Brian Meyer, Director of Emergency Services for Wyoming County has proposed a County run ambulance service. The project would have a projected start up cost of \$2.7 million and an annual cost of \$700,000. Supervisor Becker noted that the project was up for a vote in the public safety committee at the County and it did not obtain the needed votes for acceptance. Supervisor Becker blames Albany for the lack of trained EMTs in the area stating that the 200 hours of trainings and certifications is too cumbersome. He noted that even military and nurses are not exempt from the required trainings. He also noted that the certificate of need is archaic.

#### 9:00 p.m. Attorney DiMatteo Relinquishing Town Prosecutor Duties

Attorney DiMatteo informed the Board that his office will no longer be doing Town prosecutor work for any Towns in the County. The Board thanked Mr. DiMatteo for his years of service.

The variance requires a side and rear setback that will not meet the 25' requirement. The Town of Sheldon Zoning Board of Appeals will meet on Thursday, July 20, 2023.

- <u>Hugh Steves (333 Route 20A)</u> submitted an application for a variance to erect a 11 x 20 storage shed which will not meet the 25' setback requirement. The applicant requested to place the storage shed 10' from the neighboring property line. The Town of Sheldon Zoning Board of Appeals will meet on Thursday, July 20, 2023.
- <u>Bernice Perl /James Hopcia (Humphrey Road)</u> submitted an application for a land separation that would result in a barn/garage located 20' from a property line instead of the required 25' per Sheldon Zoning Law. The Town of Sheldon Zoning Board of Appeals met on June 22, 2023. The Town of Sheldon Planning Board will meet on Wednesday, July 11, 2023.
