Wyoming County Community Hospital

The Emergency Room was full last week. There were two recent COVID deaths. The nursing home has lowered occupancy rates due to short staffing. The South Buffalo Mercy Hospital strike has also had an effect.

Judicial Consolidation

Supervisor Becker noted that this item will be removed from the agenda going forward. The consolidation will not proceed.

Surplus Equipment

Highway Superintendent Ricketson reported that the surplus equipment (snow blower and paver) has not been posted on Auctions International yet. Auctions International now requires that their company take the photos. They will come out the day before Thanksgiving to take the photos.

Local Law - Tax Override - Public Hearing

At 7:43 p.m. a motion was made by Jim Fontaine and seconded by Joe Meyer to open the public hearing for Local Law 1-2021 Override of the Tax Levy.

Supervisor Becker noted that he disagrees with the Town Attorney on the Town's need to pass this local law. Supervisor Becker believes the overall Town budget not just an individual district would have to increase by over 2% to necessitate a need for the override law. Attorney DiMatteo will look into the issue. Supervisor Becker notes that there will be no Town taxes in 2022.

Varysburg Water Update

HMR Inc. has not worked on the chlorinator yet. Deputy Supervisor Armbrust had signed the contract last month.

CDBG Community Development Block Grant

Nothing new to report.

ARPA American Rescue Plan Act Funding

Nothing new to report. The Board needs to determine how to use the funding. Supervisor Becker reported that the County is purchasing new sheriff vehicles and that the County Highway Department is purchasing an excavator. Supervisor Becker has some emails to review on how/when we need to spend the funds and will report back next month.

Spectrum Update – Town Hall Internet

The Town Supervisor and Town Clerk met with Justin Niebel and other Spectrum representatives this week. The Town currently pays \$398/month for internet and phone service. The quote received from Justin is \$394/month and would greatly increase internet speed. The Board had a few questions that they would like forwarded to Spectrum before they approve the switch.

Strykersville Fire Contract

A motion was made by Vince Kirsch and seconded by Joe Meyer to authorize the Town Supervisor to sign the one-year contract with the Town of Java and the Strykersville Fire Department. The 2022 amount for the Town of Sheldon is \$37,550.00.

Adoption of Local Law 1-2021 entitled, "Override the Tax Levy Limit Established in General Municipal Law § 3-c."

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, Chapter 97 of the Laws of 2011 – "The Property Tax Cap" added a new section 3-c to the General Municipal Law that provides that the amount of real property taxes that may be levied by or on behalf of any local government shall not exceed two percent (2%); and

WHEREAS, in order to adopt a budget that requires a tax levy that is greater than the tax levy limit for the coming fiscal year, only if the Town Board first enacts, by a vote of sixty percent (60%) of the total voting power, a local law to override such limit for such coming fiscal year only; and

WHEREAS, notice of said public hearing was duly advertised in the Batavia Daily, the official newspaper of said Town; and

WHEREAS, said public hearing was held on November 17, 2021 and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed local law, or any part thereof; and

WHEREAS, after due consideration and discussion the Town Board has decided to adopt said proposed local law.

NOW ON MOTION OF Joe Meyer, which has been duly seconded by Mike Armbrust, therefore, be it

RESOLVED, that the Town Board of the Town of Sheldon feels it is in the best interests of the Town of Sheldon to adopt Local Law No. 1 of 2021 entitled, "Override the Tax Levy Limit Established in General Municipal Law § 3-c."; and be it

FURTHER RESOLVED, that the Town Clerk be and she hereby is directed to enter the adoption of said local law in the minutes of this meeting and give due notice of the adoption of said local law to the Secretary of the State of New York.
