The Zoning Board of Appeals meeting was called to order at 6pm by Chairman Walt Youngers. He lead us in the pledge to the flag.

Board member Harvey then addressed the gallery. He started by saying that based on the renderings of the proposed use of the 9 acres, it provided the board with more insight. Due to the fact we didn't know the initial plans we would like to bring in the town attorney. We need clarification of our current laws with club and community center vs what is proposed by the Legion's plans.

Lorne Lemieux spoke to the club will be members only but they also want to provide a community space for non members of the Legion. Ray Swan wanted Lorne to provide the qualifications for a veteran. Lorne said it is anyone who has a DD240 and their wives can be members of the auxiliary and sons can be members of sons of the Legion.

Mike Pfohl made a motion to table the Legion variance till the town attorney can provide the board with some clarification and guidance on the current zoning law. It was seconded by Barb Logel.

Bill Harvey read the definition of Club from the current zoning laws and were to locate the local law, 6090. Legion wants to pack a large project into a narrow lot. It's a complex situation.
