## **County Administrator**

## **Reisdorf Brothers/Town Property**

On July 31, 2024, the Town Supervisor, Town Clerk, and members of the Water Advisory Board: Dave Thornton, Thane Wright, Bob Lakas met at the Varysburg Fire Hall for training on how to conduct a door to door income survey presented by Jesse LaVigne from RCAP. The group then broke up and went door to door in the hamlet of Varysburg conducting surveys. The hope is that with a robust return of surveys, the water district will be eligible for a CDBG grant.

## <u>Varysburg Water – Boxlers</u>

At last month's board meeting, Supervisor Becker indicated that the Boxler's were no longer interested in extending the water district lines to their business. However, the Boxler's have again reached out to Supervisor Becker.
