## **Tournament Responsibilities**

### **Host Club Provides**

(If applicable)

- Secure Location for The Tournament.
- Have Workers to Prepare and Change Targets if needed.
- Have Shooting Lanes Clearly Marked with Target Number.
- Provide practice Targets (indoor) for free or for sale, but available on location.
- Glue Targets on Cardboard (field).
- Have Adequate/Good Lighting.
- Have Shooting Stakes Clearly Marked With Target Number.

### **IFAA Organization Provides**

- Provide Trophies and Patches for State Shooters.
- Provide Classifications for indoor. Outdoor follows local club classifications.

### **Tournament shoot fees**

#### **All state shooters must have an NFAA Membership**

- 18 Years and older \$35
- Young adults and youth \$25
- Family rate \$95
- Guest-Non-Competitive fees are optional and up to the hosting club for indoor shoots.
- Additional shooting fees for the marked and unmarked 3-D local shoots being held in conjunction with the state shoots are up to the hosting club. It is the recommendation of the IFAA that the shooters are given the opportunity to shoot either the state, local or both as each shooter feel's is appropriate.

### **Regulations for submitting a State Tournament Bid**

- 1-**The club submitting the request must be a current NFAA charter club in good standings and with current insurance.
- 2.** The “Bid” refers to the estimated amount of shooters you anticipate on having.
- 3.** The Vegas Tournament will be held in January with the Nampa Bow Chiefs in conjunction with the S/W Shoot-out money Shoot. And is not eligible for a Bid at this time.
- 4.** The Indoor 5 Spot will alternate locations. It will be held in February or March at least one week prior to the National Indoor tournament. You must submit a request by November 1<sup>st</sup> the prior year. Any club who has not hosted it will get first consideration. If no new club is requesting it, all clubs who have submitted a bid will have equal consideration. The IFAA will let the hosting club know no later than November 31<sup>st</sup>.
- 5.** The Marked yardage 3-D and the 3-D shoots are up for Bids to all Clubs, and may be held any time from April to June. Although they may not be held on the same date to give everyone the opportunity to attend all state shoots. You must submit a request by November 1<sup>st</sup> the prior year. Any club who has not hosted it will get first consideration. If no new club is requesting it, all clubs who have submitted a bid will have equal consideration. The IFAA will let the hosting club know no later than November 31<sup>st</sup>.

**6.** The Field shoot currently has been held in July at the Grangeville Field range by the Camas Prairie Bowmen. But this is also up for bid to any club who has a sanctioned and approved Field course. It should be held in June or July. You must submit a request by November 1st the prior year. Any club who has not hosted it will get first consideration. If no new club is requesting it, all clubs who have submitted a bid will have equal consideration. The IFAA will let the hosting club know no later than November 31<sup>st</sup>.

**7.** If no clubs have submitted a bid for one or more of these tournaments we as a IFAA Board will address that in our annual meeting in January.

**8.** In regards to the Indoor 5 spot, the marked yardage, & 3-D shoots. They can be hosted at any location that is appropriate for that type of tournament/Shoot that the hosting club chooses. This gives all Idaho clubs the chance to host a State tournament.

Note: Starting 2020 we are in a two-year trial to have all club submit a bid by November and then the Nampa Club will hold a random draw separately for each tournament for all clubs who have submitted a bid for that specific tournament. After the two years IFAA will reevaluate that process.
