## **Position Summary:**

The Doctor of Medical Dentistry provides comprehensive dental care to patients at PHCS's Hopkinsville location. This role focuses on the evaluation, diagnosis, and treatment of oral health conditions, while promoting preventative care and oral hygiene. The dentist works as part of a multidisciplinary healthcare team and ensures that care is delivered in accordance with established guidelines and regulations.

## **Key Responsibilities:**

- Conduct dental examinations to assess the health of teeth and gums, diagnose conditions, and develop treatment plans.
- Educate patients on proper oral hygiene and preventive care techniques.
- Treat conditions affecting the teeth and gums, including performing restorations, extractions, and other necessary procedures.
- Discuss treatment options with patients to determine the most appropriate course of action based on individual needs.
- Administer injectable medications as authorized by credentialing through PHCS's Professional Staff Organization (PSO).
- Accurately input prescription data and treatment notes into the electronic medical record (EMR).
- Interpret and evaluate dental x-rays and other diagnostic images.
- Refer patients to specialists, such as orthodontists or oral surgeons, when advanced care is needed.
- Ensure dental equipment is properly maintained and sanitized.
- Collaborate with other healthcare professionals as part of a multidisciplinary team.
- Participate in team meetings and staff conferences.
- Perform additional duties as assigned by leadership.

## **Credentialing and Compliance:**

- Maintain a collaborative agreement with a physician as required for prescribing medications in accordance with Kentucky State Statutes.
- Adhere to all applicable professional, ethical, and legal standards of care.

## **Qualifications:**

- Doctor of Dental Medicine (DMD) or Doctor of Dental Surgery (DDS) degree.
- Board certified or board eligible.
- Valid DEA license.
- Licensed to practice dentistry in the state of Kentucky.
- Valid driver's license and proof of current auto insurance.
- Must pass a criminal background check and sexual offender registry check.
- Documentation of a negative TB skin test within the past 12 months.
