PRINCIPLE RESPONSIBILITIES:

This position will be based in Princeton but have regional responsibilities for nursing staff and duties below. This position will have some direct care nursing responsibilities as well as programmatic oversight. This position will be directly responsible to the CEO of PHCS. Duties include:

- 15) Order appropriate/necessary clinical/medical supplies and equipment and ensure proper functioning and availability.
- 16) Ensure that proper billing procedures and documentation requirements are followed by supervisees.
- 17) Monitor and provide responsibility for the Corporation's infection control policies and processes.
- 18) Monitor and provide responsibility for the Corporation's Vaccination Program including response to pandemic.
- 19) Participates in required HRSA trainings and completes reports on time.
- 20) Collaborate closely with the CEO and administrative staff.
- 21) Produce monthly clinical operation reports.
- 22) Empower the clinical operational team with the leadership and resources they need to successfully complete operations initiatives.
- 23) Positively represent the company at all times through a success-oriented and professional demeanor.
- 24) Provide a vision of clinical growth and improvement/
- 25) Partner with other employees to accomplish short and long-term operational goals, particularly supervisors.
- 26) Measure and report on clinical operational performance and develop plans to improve relevant key performance indicators.
- 27) Collaborate with administrative team for the implantation and supervision of employee incentive/enhancement programs to improve productivity.
- 28) Perform other duties as required/assigned

Prefer a Registered Nurse with Bachelor's degree, or an Associate's degree R.N. with at least three years supervisory experience in a healthcare setting. Requires experience in supervising program operations. Must hold an active Kentucky nursing license, have a valid driver's license, proof of automobile insurance, and reliable transportation. Must pass a Criminal Records Check and a Sexual Offender Registry Check. Must present proof of a recent (less than 1-year-old) TB skin test.
