- o Lana Robinson printed out a Revenue and Expense Department report for council to show each department in general and how much of their budget has been used. Lana Robinson has been working with the Library on their CDBG Grant which a public hearing needs to be done and needs to be posted seven days prior and a resolution needs to be signed and passed. Mayor Bryan Blankinship has a letter of recommendation to sign for the grant. The library would like to reach the 30% match and is almost there. The library will be coming to ask if the city would like to add funds to the grant. Suggested to do the hearing for the library on August 20th for the CDBG Grant. The company that prepares the budget did state we will not be exceeding the RNR.
