At 5:30 PM, The regular meeting was called to order by Mayor Bryan Blankinship.

Janice Fine made a motion to amend the agenda to reflect adding agenda request for C & L Tires. Kathy Miller seconded the motion. Motion carried.

Adam Clark made a motion to amend the agenda to reflect the bill amount of \$36,686.32. Pam Koerner seconded the motion. Motion carried.

Employee Handbook-


- The council went through section G-O of the employee handbook.
