

**CITY OF SEDAN
MINUTES OF OCTOBER 5, 2022**

The Sedan City Council met for the council's regularly scheduled meeting, on October 5, 2022, beginning at 5:33 PM, with Mayor Jack Warren presiding. Council members present: Bryan Blankinship, Jesse Kate Buck, and Sharon Payne. Brett Dickens and Jaime Morris were absent. Employees present: Sherry Miller, John Miller, and Ralene Davis. Guest present: Ashley Kunath and Adley Pappan, with Sedan FFA. Melodee Wolfe, representing SAEDC.

Jesse Kate Buck made a motion to approve the agenda. Bryan Blankinship seconded the motion. Motion carried.

A motion to approve the minutes from the regular meeting held on September 21, 2022, was made by Bryan Blankinship, and seconded by Jesse Kate Buck. Motion carried.

A motion to approve the bills in the amount of \$82,159.71, was made by Bryan Blankinship and seconded by Jesse Kate Buck. Motion carried.

Public Forum: None

Ashley Kunath and Adley Pappan, representing Sedan FFA, spoke with the Council about having a Suicide Prevention Event on either October 17 or 18, from 6:45 – 8:00 PM. They plan to line the sidewalks downtown with luminaries, to remember teenagers who have died by suicide. Jesse Kate Buck made a motion to approve the event. Bryan Blankinship seconded the motion. Motion carried.

Ralene Davis spoke with Council about audit management items. No action was taken; items discussed were tabled until the next council meeting.

Bryan Blankinship made a motion to approve a sewer reduction in the amount of \$76.55 for account #894. Sharon Payne seconded the motion. Motion carried. Jesse Kate Buck made a motion to approve a sewer reduction in the amount of \$42.71 for account #416. Bryan Blankinship seconded the motion. Motion carried. Sharon Payne made a motion to approve a sewer reduction in the amount of \$501.04 for account #482. Jesse Kate Buck seconded the motion. Motion carried.

Sherry Miller advised Council that there will be a new lead and copper plan (LRCC), that will be in effect October 16, 2024.

Jesse Kate Buck made a motion to allow John Miller to purchase 2 tires from Main Street Auto. The cost per tire is \$178.63 making the total cost \$357.26. Bryan Blankinship seconded the motion. Motion carried.

John Miller advised Council that he needs one more load of blacktop.

At 6:04 PM, Sharon Payne made a motion to adjourn the meeting. Jesse Kate Buck seconded the motion. Motion carried and the meeting was adjourned.
