### ORDINANCE NO. 911

An ordinance providing for the billing and collection of utilities, including water and sewer services and rates, for customers of the City of Sedan, Kansas; and revoking Ordinance #852, #868, #904 and #910 and all other ordinances or parts of ordinances in conflict herewith:

Be it Ordained by the Governing Body of the City of Sedan, Kansas, to-wit:

### SECTION I

All water customers, whose service is within the city limits of the City of Sedan, Kansas, shall be supplied through the meters, and said customer shall pay for the water used by them each month. Rates are uniformly applied to all parties. The following rates, fees, and charges shall apply, effective on the January 1, 2018 water bills:

> The 1st 1,000 gallons \$35.50

The 1st 1,000 gallons
All usage over 1,000 gallons \$ .01 per gallon

Additionally, the following rates, fees, and charges shall apply, effective on the January 1, 2019 water bills:

> The 1st 1,000 gallons \$45.50

The 1st 1,000 gallons All usage over 1,000 gallons \$ .01 per gallon

All water customers, whose service is outside the city limits of the City of Sedan, Kansas, shall be supplied through the meters, and said customer shall pay for the water used by them each month. Rates are uniformly applied to all parties. The following rates, fees, and charges shall apply, effective on the January 1, 2018 water bills:

> The 1st 1,000 gallons \$41.88

All usage over 1,000 gallons \$ .0125 per gallon

Additionally, the following rates, fees, and charges shall apply, effective on the January 1, 2019 water bills:

> \$51.88 The 1st 1,000 gallons

All usage over 1,000 gallons \$ .0125 per gallon

#### SECTION II

All water bills for the previous month shall be due on the first day of the following month, and if not paid on or before the 15th day of the following month, a late penalty of 10% of the total bill shall be added to said bill. Services will be disconnected if payment has not been received on or before the 25th day of the month in which payment is due.

All new residential customers must pay a \$50.00 non-refundable connection fee; business customers must pay a \$75.00 non-refundable connection fee. Any customer who has had service with the City in the past, and left the City owing a balance on their old account, must pay their previous account balance along with a \$50.00 nonrefundable connection fee.

Any customer who no longer has active service, but has had an active account in the past, and whose account was in good standing, must pay a \$25.00 non-refundable connection fee. If a customer has service currently, and moves their service from one house to another will be charged a \$5.00 transfer fee.

A \$25.00 disconnect fee will be assessed on any account that has been disconnected due to non-payment. Whenever a customer vacates a residence and fails to notify the City by signing a written disconnect notice, a \$25.00 disconnect fee will be assessed. If a customer has been disconnected for any reason, services will be restored when the customer pays a \$25.00 reconnect fee, along with the past due amount and all associated penalties and fees.

# SECTION III

All users of the City of Sedan sewage disposal system, who are <u>within the city limits</u> of the City of Sedan, Kansas, shall pay for such services on a monthly basis. Sewer service fees shall be added to the water bills, with the rate to be based upon the amount of water used by that customer. Rates are uniformly applied to all parties. The following rates, fees, and charges shall apply, effective on the January 1, 2018 sewer bills:

The 1st 1,000 gallons

\$ 8.50

All usage over 1,000 gallons

\$ .00375 per gallon

All users of the City of Sedan sewage disposal system, who are <u>outside the city limits</u> of the City of Sedan, Kansas, shall pay for such services on a monthly basis. Sewer service fees shall be added to the water bills, with the rate to be based upon the amount of water used by that customer. Rates are uniformly applied to all parties. The following rates, fees, and charges shall apply, effective on the January 1, 2018 sewer bills:

The 1st 1,000 gallons

\$10.63

All usage over 1,000 gallons

\$ .00469 per gallon
