### **AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF SEDAN, KANSAS, AND INCORPORATING BY REFERENCE THE “STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES,” 52<sup>nd</sup> EDITION, 2025**

*Be it Ordained by the Governing Body of the City of Sedan, Kansas:*

#### SECTION I

There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the city that certain standard traffic ordinances known as the “Standard Traffic Ordinance for Kansas Cities,” 52<sup>nd</sup> Edition, 2025, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. One copy of the Standard Traffic Ordinance shall be marked or stamped, “Official Copy adopted by Ordinance No. 952,” and to which shall be attached a copy of this ordinance (Ordinance No. 952) and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge, and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of the Standard Traffic Ordinance similarly marked, as may be deemed expedient.

#### SECTION II

Ordinance No. 943 is repealed.

#### SECTION III

This ordinance shall be published in the Prairie Star, the official city newspaper, on the 14<sup>th</sup> day of August, 2025, and shall be in full effect on August 14<sup>th</sup>, 2025.

*Be it Ordained by the Governing Body of the City of Sedan, Kansas:*

#### SECTION I

There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the city that a certain code known as the “Uniform Public Offense Code for Kansas Cities,” 41st Edition, 2025, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. One copy of the Standard Traffic Ordinance shall be marked or stamped, “Official Copy as adopted by Ordinance No. 953,” and to which shall be attached a copy of this ordinance (Ordinance No. 953) and filed with the city clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge, and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of the Uniform Public Offense Code similarly marked, as may be deemed expedient.

#### SECTION II

Ordinance No. 944 is repealed.
