

THE 98 LUNARA EMBLEMS

PAYMENT STRUCTURE

1st Installment — \$29 EMBLEM JPG ID (2-Year Certification)

Non-refundable.

This payment activates the EMBLEM's identity, certification, and placement within the Universal Love Network.

Sales Tax Handling:

BBGC applies its Texas 8.25% sales-tax exemption certificate to nullify sales tax.

If the exemption is not applied, add \$2.39 (total \$31.39).

2nd Installment — \$69 EMBLEM Leadership Upgrade

Includes the Pillar Talks PDF + Scrollstream MP4.

This payment activates the EMBLEM's leadership presence and regional visibility.

Sales Tax Handling:

BBGC applies its Texas 8.25% sales-tax exemption certificate to nullify sales tax.

If the exemption is not applied, BBGC covers the tax for both installments at the time of purchase.

Combined Total (with BBGC covering tax):

\$98 flat for both installments.

★ Accepted Forms of Payment

The Lunara EMBLEMS Payment System accepts the following secure payment methods for both installments and upgrades:

1. Personal Check

Accepted from any U.S. bank.

2. Business Check

Accepted from registered companies and organizations.

3. Bank Wire — Canada / International Only

For EMBLEMS located outside the United States.

4. Cashier's Check

Issued by any U.S. bank or credit union.

Cash Payment Options (Synergy-Synced)

All cash payments must exclude \$1 bills to ensure clean counting and verification.

5. Cash — 1st Installment \$30 (no \$1 bills)

Covers the \$29 EMBLEM JPG ID + rounding for clean cash handling.

6. Cash — 2nd Installment \$70 (no \$1 bills)

Covers the \$69 Leadership Upgrade + rounding for clean cash handling.

5A. Cash Upgrade — Full Payment \$100 (no \$1 bills) Covers both installments in one payment.

6. Zelle® — 361-563-7978 (U.S.A. Only)

 **International Payment Protocol Statement (Bank Wire Required)**

All Canada and International payments must follow the Bank Wire Protocol.
