- 2. **Article I, General Information, Subsection D, Scope of Services, 2.0, Pre-Design Planning**, is hereby amended to add Item 2.11 EXISTING APPARATUS BAY TRUSS, to read as follows:
 - "2.11 EXISTING APPARATUS BAY TRUSS. Existing apparatus bay trusses are compromised. Verify that Design Team addresses associated repairs in design documentation."
- 3. Article I, General Information, Subsection D, Scope of Services, 3.0, Design Phase, 3.7, Sustainability, is hereby amended to add the following sentence as the last sentence of that subsection:

"District desires to incorporate infrastructure to allow charging of electrical powered vehicle apparatus in the future."

- 4. Article II, Proposal Instructions, Subsection E, Proposal Contents, 3- Project Manager, is hereby amended to add a (d), as follows:
 - "(d) Confirm that OR/PM Lead Personnel will remain on the Project until final completion, unless a replacement is requested or approved by the District."

III. PROJECT MANAGEMENT SERVICES CONTRACT - APPENDIX A

The District hereby makes the following amendments to the Project Management Services Contract, attached as Appendix A to the Request for Proposal:

1. Coverage limits set in **Section 7, Insurance Requirements, 7.1 Insurance Coverages**, **subsections a through d** are hereby amended to reflect the following required limits:

- a. Workers' Compensation and employer's liability insurance per ORS Chapter 656. The employer's liability limit shall not be less than \$500,000 per occurrence.
- b. Commercial General Liability Insurance, applicable to all premises and operations, including Bodily Injury, Property Damage, Personal Injury, Contractual Liability, Independent Contractors, Products and Completed Operations, Broad Form Property Damage (including Completed Operations), and coverage for explosion, collapse, and underground hazards, with limits of not less than \$1,000,000 per occurrence.
- c. Business Automobile Liability Insurance, applicable to owned, non-owned and hired automobiles, with a limit of not less than \$500,000 combined single limit each accident, \$1,000,000 aggregate.
- d. Professional Liability Insurance, applicable to all acts and omissions of Consultant and its consultants at all tiers, with limits of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate.
- 2. **Exhibit C, Scope of Services, 2.0, Pre-Design Planning**, is hereby amended to add Item 2.11 EXISTING APPARATUS BAY TRUSS, to read as follows:
 - "2.11 EXISTING APPARATUS BAY TRUSS. Existing apparatus bay trusses are compromised. Verify that Design Team addresses associated repairs in design documentation."
- 3. **Exhibit C, Scope of Services, 3.0, Design Phase, 3.7 Sustainability**, is hereby amended to add the following sentence as the fourth sentence of that subsection:

"District desires to incorporate infrastructure to allow charging of electrical powered vehicle apparatus in the future."

All unamended provisions within the RFP and Contract remain in force and unchanged by this Addendum 1.
