### FEES AND RETAINER

USSolutions, LLC shall be compensated for all services rendered Client at the hourly rate of \$65.00 with mileage billed at \$0.45/mile. Any expenses incurred during the investigation are billed at cost +2%. A retainer of \$600.00 is required prior to the start of any investigation. USSolutions, LLC will work the case until the retainer is exhausted and provide a preliminary report with an estimation of additional cost expected. Balance will be due every 30 days or upon completion of work. In the event the case is completed under the retainer amount, the client will be refunded the balance within 30 days. In the event client cancels the contract prior to completion of work, the minimum charge will be \$250.00.

### COURT APPEARANCES

If any agent of USSolutions, LLC is called as a witness for disposition or Court, the cost will be a minimum of \$250.00. If the Court appearance or disposition requires more than four hour's time, the Client will be charged \$75.00 per hour and \$0.45 per mile without waivers.
