**ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM**

I HEREBY ASSUME ALL THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING IN THIS ACTIVITY OR PROGRAM, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I certify that there are no health-related reasons or problems that preclude myself or my child to participate in this activity or program.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by program organizers and sponsors of the activity or program in which I and/or my child may participate, and that it will govern my actions and/or my child's actions and responsibilities at said activity or program.

In consideration of my application and permitting me and/or my child to participate in this program, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me or my child including traveling to and from this activity, THE FOLLOWING ENTITIES OR PERSONS: American Homesteading Foundation, Inc. ("AHF") and/or their trustees, officers, employees, volunteers, representatives, and agents, the activity or program organizers, activity or program sponsors, activity or program volunteers.

(B) IDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE, the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this activity or program, whether caused by the negligence of release or otherwise.

I acknowledge that the AHF and their trustees, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, act, or failures to act of any party or entity conducting a specific event or activity on behalf of the AHF.

I acknowledge that this activity or program may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, and organizers of the program, and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during this activity or program.

I understand that at this program or related activities, I and/or my child may be photographed. I agree to allow my and/or my child's photo, video or film likeness to be used for any legitimate purpose by the program organizers and assigns.

I understand that at this program or related activities, that no organizer of this event, committee member or volunteer has undergone an official background check.

The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

PARENT/GUARDIAN WAIVER FOR MINORS (Under 18 years old)

The undersigned parent and natural guardian do hereby represent that he/she is, in fact, acting in capacity, has consented to his/her child or ward's participation in the activity or program, and has agreed individually and on behalf of the child or ward, to the terms of the accident waiver and release of liability set forth above. The undersigned parent or guardian further agrees to save and hold harmless and indemnify each and all of the parties referred to above from all liability, loss, cost, claim, or damage whatsoever which may be imposed upon said parties because of any defect in or lack of such capacity to so act and release said parties on behalf of the minor and the parents or legal guardian.
