CENTRAL OFFICE NEWS

Tish Collins. Chief Executive Officer

Registrations for the Triennial World Conference are coming in at a steady pace and we are ready for more! Additional accommodation options are being added to our website and, I am pleased to say a couple of the hotels in Melbourne have reduced their rates for us. It promises to be a wonderful conference in a fascinating city, and an ideal opportunity for many to meet up with family and friends.

Recently we have taken on an intern for the summer. Emily is helping with redacting and trimming what we keep in some of the old files in the archive. ACWW history is important to us but we have been advised to securely dispose of some old personal data that really should not be kept. Obviously, this is being done responsibly and within the parameters of our legal requirements. The Board met in March appreciated the situation and the GDPR consultant working with us on a pro-bono basis addressed the Executive Committee in June and answered their questions. There is an article later in the magazine telling you all about it.

I have spoken at a number of WI meetings around the UK recently and was joined by our Projects Development Administrator Viktoria Dimitrova for a coffee morning near Salisbury, hosted by the Wiltshire WI. I am pleased she had such a great reception for her first public speaking engagement. Whilst the Executive were meeting in June, the World President and the Deputy World President joined me at an evening meeting of a WI in Surrey where we spoke of ACWW and the Global Survey. A guick reminder – if you have not yet done the Global Survey please do it today and encourage 10 others to do it too! It is quick and easy, and found at www.ifrw.org.uk

As an agricultural economist by training, I was pleased to represent ACWW at the FAO 31st Session of the Regional Conference for Europe and Central Asia. The theme was sustainable agriculture and food systems in Europe and Central Asia in a changing climate; with a second major topic of E-agriculture. I also attended the side meetings on gender and migration in Central Asia, food losses and waste, and organic agriculture. In addition to networking and gathering information I was able to raise the Global Survey at this meeting of ministers and ambassadors.

The data packs I gathered will be useful to inform the infographics being prepared for resources, which are being added to our website for members to download.

Speaking of infographics I hope you agree that the quality and timeliness of materials coming out of Central Office have improved greatly over the last couple of years. Since the middle of May there has been a concerted effort to attract interest in ACWW and our policies through the use of social media as well as more conventional methods; which is proving successful. Whilst the staff all continue to be 'attached' to specific Committees there is much a more interactive and 'team' approach to cross cutting themes which is stimulating the generation of new materials, which in turn should assist member societies in their campaigning work.

The audit of the accounts progressed well this year and we are aware this needs to be even quicker next year to have the accounts ready for the Triennial World Conference. Our internal financial systems have had a thorough health check over the past eighteen months and are in good shape to go forward.

There is still some work to be done to complete the transition from the old registered charity and the new Charitable Incorporated Organisation status and we are receiving assistance from the accountants and legal professionals for this. The Bye-Laws were revised and approved by the Board in March.

Later in the magazine you will find information about the Women Empowered Fund (WE Fund). This is designed to be a more sustainable way of funding projects and meeting the wishes of donors. It calls for donations to six priority focus areas – such as education and capacity building, or sustainable agriculture; information about each project funded in each area will be available to donors so they can see at a glance what they have supported and will receive updates and final reports. This replaces the current system of project 'pledges' although there are still some pledges due to be completed over the next year or so. More details are given in the article, and will be expanded upon in the future.

ACWW ADVOCACY RESOURCES

How we can help you to help your Community

Since our founding in 1929, one of the central strands of ACWW's work has been ensuring that the voices of women in rural communities around the world can be heard by those who take decisions and make policies which affect those women.

Last issue we included a major feature about our presence at the 62nd Session of the Commission on the Status of Women in New York. This issue's focus on our advocacy work is intended to show how we can support you, our members, in your efforts to improve the lives of women in your communities.

What is Advocacy?

We define Advocacy as the activities undertaken to influence policy makers and decision takers at the local, national and international levels. ACWW facilitates our members in advocating for the issues that affect them, and raises awareness of the challenges faced globally by women in rural communities.

How are ACWW policies decided?

Every three years our Member Societies have the opportunity to present either Resolutions or Recommendations to the Triennial World Conference.

The gathered delegations from all over the world then vote to either accept or reject these proposals. If accepted, they become official ACWW policy and all Member Societies have a constitutional obligation to work towards achieving the stated goal or changes.

Resolution or Recommendation?

ACWW Resolutions seek to change or have influence on global issues, and so Member Societies are mandated in our constitution to take action and make effort to work towards their achievement.

Recommendations may be more local issues, or topics that aren't expected to affect all Member Societies. The policy is therefore intended as guidance for those who feel they can work on the issue.

In both cases, ACWW will provide resources to support action. If you are producing materials, we can also share these for you.



What about the SDGs?

The Sustainable Development Goals, were adopted in 2015 to replace the Millennium Development Goals. We often refer to them as the 'SDGs', and they are a central part of our work.

All projects funded by ACWW relate to the SDGs, and our advocacy work is also focused on helping achieve them.

Going forward, you will see small coloured boxes on many ACWW publications. These will show you the specific SDGs that a project, appeal or meeting is focused on and help you guide supporters when they ask what ACWW does.



How is ACWW helping?

ACWW's Central Office team has prepared a significant number of resources relating to the Resolutions and Recommendations passed at the 28th Triennial World Conference in August 2016. These have been published in *The Countrywoman* and on our website at www.acww.org.uk and variously shared using our social media channels.

We have also created a Strategic Advocacy Plan which was approved by ACWW's Executive Committee in June this year. This is a model for promoting activity amongst our Member Societies, and supporting their actions on ACWW's policy issues. Some examples of these are shown on the next pages. These are being released over the next year, as part of mini campaigns and will be featured in this magazine, on our website and social media platforms as well as being distributed directly to members via our email mailing list.

You can read more about this on the next pages, and if you'd like to join our mailing list, please email info@acww.org.uk to request being added. Your email address will be held securely and treated in line with data protections laws and policy.

So how does this work?

You can access these new resources in several different ways, which are outlined below. You are also very welcome to copy, share and reproduce these resources. All we ask is that you do not edit or remove any part of the document, but share it in its original form.

You can share these documents online, email them to your networks or colleagues, or print them off and distribute them at meetings. Our website includes PDF files (for easy sharing), and PNG files (for professional printing or sharing online).

Remember that ACWW is a network of organisations with a collective goal and intent. You, our members, make an impact. These resources are intended to help you in lobbying for change in your communities and countries; its not possible that each and every one will appeal to you, but we will be covering a broad range of topics. This will also take into account the UN International Days and other global observances and celebrations.



WOMEN AS AGENTS OF CHANGE

IN WATER SECURITY & SANITATION

About 157 million people in the Eastern and Southern Africa region are not connected to a clean and safe water distribution system, and thus need to use external water sources.

The burden of fetching drinking water from outdoor sources tends to fall disproportionately on girls and women.

Surveys from 45 developing countries show that in almost two-thirds of households without a drinking water source on the premises, it is women and girls who collect water.

Around 247 million people have no access to improved sanitation.

In countries such as Eritrea, Ethiopia, and Somalia, well over half of the population has to practise open defecation.

WHY A GLOBAL SURVEY MATTERS

How it works, how you can help, and why you need to

In the last issue of *The Countrywoman* you will have read about the International Forum on Rural Women and the Global Survey of the Living Conditions of Rural Women. This is ACWW's initiative to address the 'data gap' in the SDGs, and to better understand the challenges our members (and, of course, non-members) face living in rural communities.

We want to make it clear that whilst ACWW is collaborating with other non-governmental organisations like the World Association of Girl Guides and Girl Scouts, Soroptomist International and the World Association of Industrial and Technological Research Organisations, we believe that every single ACWW Member Society and Individual Member has a crucial role to play in the success and effectiveness of this survey. If you are not sure how or why, please read on!


How does it work?

The survey includes 95 questions that broadly cover the living conditions of women in rural communities. Of course, the questions are not exhaustive, there are many others that could be asked, and there are even some that may not seem relevant to you. Don't forget that to get meaningful results, we need to ask everyone the same questions and this will always create a little overlap or gaps.

There are some that you may struggle to answer, or to answer in a way that you feel fully answers them. This is inevitable, and our only advice is to take the questions at face value - they are indeed often more simple than we would have liked, but if you take them as you read them, you should have no problem.

The survey closes on 31 December 2018, and we will then process the results. We will be working with a group of researchers who have volunteered their support, and intend to have initial results ready for discussion at the Commission on the Status of Women in March 2019. The full results package will be published in time for the Triennial World Conference in Melbourne, Australia in April 2019.

Once the results are published, they will be distributed to Member Societies, local and national governments, UN Agencies. The intention is to inform and influence policy makers and decision takers.



What do you need to do?

The easiest way of completing the survey is to visit the Survey website directly from a computer, tablet or iPad, your smart phone or any other device with access to a web browser. You can also visit the ACWW website, and will find a helpful 'pop up' that offers you the chance to take part. You can find it at:

If you don't have access to a computer or smart phone, please contact ACWW Central Office and we will happily send you a paper copy. You could also ask a family member, neighbour or friend to help you complete the survey on the website.

Please remember that the survey is on a secure website, and that your answers are anonymous throughout - at no point are you asked to identify yourself or your address.

How can you help?

We need as many results as possible for the Survey to be effective. The survey is available in many languages, with more coming all the time. This helps accessibility, but we need your help to reach people.

Whether you host a 'Survey Party', take it to your local branch meeting, get your friends and family to take part, or distribute it to your mailing lists and at events, every new person responding is helpful. If you have ideas for sharing the Survey, please go ahead!

If you regularly attend a group or organisation, you could take your tablet or laptop along and get everyone to fill in the survey, or perhaps take it to your local Country Fair, State Conference, or national event. It doesn't matter where you live, we need worldwide responses.

FAO IN VORONEZH, RUSSIA

ACWW attends the Regional Conference for Europe and Central Asia

The United Nations Food and Agriculture Organisation (FAO) organises regional conferences to better engage with States Parties (the different countries with UN membership) and to address specific issues. In May 2018, they held the Regional Conference for Europe and Central Asia in Voronezh in the Russian Federation.

This was primarily a regional conference of Ministers of Agriculture and Ambassadors. ACWW was one of a very limited number of NGO's in consultation with the FAO invited to attend as observers; and, ACWW was one of only two NGO's that did attend. There were also representatives from the Civil Society Organisation *Via Campesina*, familiar to our Agriculture Committee. As a break with tradition, observers were also invited to address the main session.

The Conference focused on sustainable agriculture and food systems in Europe and Central Asia in the context of climate change.

There has been an increase in the number and intensity of climate related natural disasters. For example, in Central Asia the agriculture sector struggles with recurring drought and rising surface temperatures, whilst in the Western Balkans the prevalent problem is alternating cycles of floods and droughts. In forests, warmer temperatures have led to the multiplication and spread of invasive pests, which cause extensive damage to crops and increase the risk of food insecurity and poverty.

FAO is working with many countries at different levels to make agriculture and farmers more resilient to climate change by using such techniques as drought-resistant crop varieties, sustainable water and land management and, increasingly, an agro-ecological approach. FAO is also assisting several countries to gain access to environmental climate-related finance such as the Green Climate Fund (GFC) and the Global Environmental Facility (GEF).

FAO Director General Jose Graziano da Silva was recently asked what impact the US decision to withdraw from the Paris climate agreement would have? He replied that it was a major concern. Every nation in the world had signed the Paris Climate Agreement. Scientists overwhelmingly confirm that climate change is occurring at an accelerated pace and is mainly caused by human actions in the form of greenhouse gas emissions. This is adversely impacting global food and nutrition security by extreme weather events, pest and parasite infestations, and

increased prevalence of drought. The United States has been at the forefront of climate action, a wealth of top-level climate research has been conducted there and Mr da Silva and FAO hoped the US would reconsider their decision to pull out.

The other main issue under discussion was E-agriculture, or applying information and communication technologies to agricultural sectors — including crops, livestock, fisheries and forestry. It embraces the whole food system, and includes established and more innovative technologies such as mobile (cell) phones, radio and television, and the use of drones to detect pests and plant infestations and the use of satellites to estimate soil moisture and surface air temperatures.

FAO is promoting the use of technologies and helping create a policy where technology is available to everyone especially small-holders and family farmers. There should not be 'winners and losers'!

Asked about progress towards the SDGs in Central Asia the Director General said that remarkable progress has been made, yet challenges remain. Speaking on SDG 2 (Zero Hunger), the good news was that between 2005 and 2016 the prevalence of undernourishment in Central Asia dropped from 12.9% to 8.3%. However, 5.6 million people in the region remain undernourished, including Tajikistan with over 30% undernourishment.

FAO priorities in the area are focussed on empowering small holder and family farms, improving their livelihoods, strengthening resilience to climate change and crises, reducing poverty, improving trade in food products, market integration, and ensuring sustainable management of natural resources.

Global hunger is on the rise again after declining for over a decade, affecting 815

million people (2016), or 11% of the global population; this is 38 million more than in 2015, largely due to violent conflicts and climate-related shocks around the world. Preliminary data shows that another increase will be recorded for 2017.

Sixty per cent of all undernourished people now live in countries affected by conflict. Impacts on food security range from the destruction of farms or food stocks to disruptions to food supply systems or markets that also drive up food prices.

Conflict continued to be the main driver of acute food insecurity in 18 countries – 15 of them in Africa or the Middle East. More than 20 million people in North-East Nigeria, Somalia, South Sudan and Yemen are at risk. Climate disasters, mainly drought, were also major triggers of food crises in 23 countries – two-thirds of them in Africa and were responsible for pushing some 39 million people into acute food insecurity.

Today the world tends to still produce food mainly based on the principles of the Green Revolution - production based on high-inputs, at high environmental cost. This results in soil, forestry, water, air quality, and biodiversity degradation. According to the FAO, this focus on increasing 'production at any cost' has not been sufficient to eradicate hunger, despite the fact that more is now produced than is required to feed everyone. The world is also facing huge problems of obesity and related health resource issues. Mr da Silva said the world has reached a tipping point; that we need to promote a transformative change in the way we produce and consume food. We need sustainable food systems that offer healthy and nutritious food and protect the environment for future generations. Investments in agriculture, fisheries and forestry and spending on research need to be stepped up in order to build sustainability. FAO are looking at integrated systems of crop-livestock and crop-aquaculture, conservation, nutritionsensitive agriculture and sustainable forest and fishery practices. These will help farmers, ecosystems and communities adapt to, mitigate and build resilience to climate change and meet country-specific and global needs.

ACWW CEO Tish Collins reports from the FAO Regional Conference in Voronezh. ACWW's consultative status with UN Agencies is crucial to our advocacy work, and represents our members on the global stage, ensuring their voices can be heard.

WHAT IS GDPR?

Protecting our members, and updating policies for ACWW

You may recently have seen, heard, or read about something called the General Data Protection Regulation, or GDPR. If you haven't, you probably saw a huge number of emails in your inbox in the middle of May, asking you to update your settings.

GDPR was agreed into European Union law in May 2016, with an implementation date of 25 May 2018. This law was intended to update international protections of personal data, and ensure that EU and EEA citizens are protected from abuse of their data. The law also incorporates regulations on how data can be shared across borders and internationally.

ACWW has been updating and implementing new policies and procedures to ensure that we comply with the new laws, but also have the highest standards of protection for our members and their data. We would like to take this opportunity to explain a little more and clarify a few things.

What is Personal Data?

Personal data is the information that can be used to identify you. In ACWW's context, this includes your name, address, contact details (telephone number and email address), information about your membership in specific societies or organisations, relationships with ACWW (how long you've been a member) and all the communications between you and us.

Why does it matter?

It is important to protect your personal data for a variety of reasons. This ranges from helping to prevent your credit cards or bank accounts being cloned or abused, or stopping endless annoying phone calls from sales companies. The law says that you have the right to privacy, and we fully support this.

What about the website?

ACWW has a duty of care to protect the data you give us, and to ensure that it is not shared in any inappropriate ways.

We will never sell your data, or share it with any commercial body outside of very specific situations. For example, when you fill out a form on our website, your data is temporarily shared with another company such as Survey Monkey Inc., which provides our form software. In a similar way, if you submit a payment form on the site then your card details will be processed by our transaction provider SquareUp. This means that ACWW will never see your card details, only confirmation that you have

paid. It also means that your card is processed under very strict conditions and in line with international laws.

In both cases, there are clear policies and agreements in place between ACWW and our suppliers, to ensure that everything is handled in the most careful, safe and secure way possible.

You will also notice that the whole ACWW website is protected by what we call SSL Certificates, which show that the site is safe to use and enter your data. This can be seen if you look in the web address bar, by the green padlock icon, and that the address is prefaced by "https" rather than just the traditional "http". We don't recommend ever putting your personal information into a website which doesn't show the green padlock.



Can you give me...?

Members sometimes ask us to pass on the email or phone number of another member so they can be in touch. Rest assured we will never do this without seeking your explicit permission in advance.

Will you contact me?

If you have given us your contact details as part of your membership, we will of course contact you with your renewal information, and send your magazine to you. From time to time, we may also send updates relating to your membership. Society Members will receive Conference Circulars and other important updates as well. Occasionally, we may send something through to you (like a copy of the new Constitution), which is a part of your membership.

If you have chosen to join our E-Mailing list, you will receive the World President's E-Newsletter. If you have received this but do not want it, or believe you never signed up, please let us know and we will immediately remove you from the list.

ENSURING THE VOICES OF RURAL WOMEN ARE HEARD

The Board considered it necessary to conduct a baseline survey of the living conditions of rural women so that the data produced could be used to influence policy makers and decision takers. It was agreed that the Survey would be developed in 2017, and launched at the Commission on the Status of Women in March 2018.

INTERNATIONAL WOMEN'S DAY 2017

A networking breakfast was held to celebrate International Women's Day on 8 March 2017 and share information about ACWW.

Over 70 people attended, including 9 Members of the UK Parliament, 5 members of the House of Lords, including a Minister of State at the Home Office, and 1 member of the European Parliament. In addition, a BBC Newsreader, a Councillor from Westminster Council, the Chair of the UK Equality & Human Rights Commission also attended.

We were pleased to welcome representatives from several diplomatic missions, including the Naval Attaché from the Republic of Cameroon, the Second Secretary of the US Embassy, and the Deputy High Commissioner of the Australian High Commission in London.







Most expenditure was incurred supporting the charitable actives of the organisation. A major re-location took place in the final quarter of the year which should result in savings and greater security in future. Although there was an operational deficit of £8,125 of expenditure over income, this was offset by gains on investments of £72,821 resulting in a net movement of funds with a surplus of £64.696 at the year end. Expenditure on project activities from restricted funds relates to projects funded in 2017, and monitoring/evaluation costs of 20%, and direct salary costs of staff working exclusively on projects. Conference income and expenditure is, by convention, concentrated in the year of the Conference.



Philippines: Water, Agroforestry, Nutrition & Development Women's Action Against Climate Change and Hunger

Completed in November 2017, ACWW Project No. 1018 brought safe water and sanitation facilities to women and families in barrios which lacked these facilities and as a result, the beneficiaries are enjoying better health, nutrition and income.

Two rainwater harvesters (10,000 litres each) were constructed, serving 311 households. 50 latrines have also been constructed for women-led households. Training in the use and care of these has been provided, although the rainwater harvesters need very little care and should last for at least 20 years. Backyard gardens have been established and 220 women and their families are participating in home gardening. They have been trained to grow vegetables and fruit using local seed varieties.

WAND initiated the creation of an association, named after the project (Women's Action against Climate Change and Hunger). This has been incorporated and registered with the Department of Labour and Employment, and will give the beneficiaries the opportunity to lobby for and access services for the continued improvement of their community.

Uganda: Kituntu Women's Association Community Managed Water for Life

ACWW Project 982 was completed in 2017, and improved water access for the community of the Kituntu Village in Uganda's Mpigi District.

3 shallow wells were constructed, providing a 30% increase in access to safe water. More than 1250 people in the village benefited from the project, and are now also encountering reduced exposure to water-borne diseases like cholera and typhoid.

We introduce Esther Chute of Nova Scotia, Canada



Mrs Esther Chute recently celebrated her 105th Birthday, and we are delighted to be able to print this article about Esther, from Judy Parks, our Canadian Friendship Links Area Coordinator.

Where does Esther live and how does she spend her days?

I visited Esther in the comfortable nursing home where she lives in a bright and cheerful room. Her dresser top was filled with recently knitted items for charity – an activity which takes up most of her time. She was also busy with the finishing touches to the tea cosy which is the provincial WI handcraft project.

She uses her walker to walk the distance to the elevator three times a day for meals downstairs, knowing well that if she starts using a wheelchair, she will be missing out on this daily way of exercise which she says is very important at this stage of her life.

To what extend is Esther still involved with the WI?

She remains a promoter of all levels of the WI and was the district treasurer until she was 100. I remember over the years how Esther would attend events dressed in the latest knitted outfit she had created-skirts and tops to match, always in a cheerful colour to match her personality! Esther has a younger sister who belongs to the WI and is also a very enthusiastic member. I spoke with her recently and she too marvels at her sister's continued health and quality of life.

Esther has been part of ACWW's Friendship Links programme for many years and she

still enjoys the letters of friendship she regularly receives from her pen friends.

Tell us about Esther's life as a younger woman.

Esther lived with her family on a farm and after her husband passed away she continue to take care of the farm and lived there for the larger part of her life. Speaking with one of her WI friends from her South Berwick branch, I was told that Esther was a consummate cook and her signature dish was baked gooseberry pudding. She grew the gooseberries herself and one day when she went out to pick some, she got carried away and picked 108 boxes! Being tired after this strenuous task, she put her head down in the garden to rest for a while. When her neighbour saw this he rushed up to her to check on her... thinking she was dead!

How did Esther celebrate her 105th Birthday

Esther requested a meal of fish and chips which her daughter happily provided. A square dance party was part of the celebration and even though she was keen to participate, her daughter convinced her to watch the proceedings instead! Her fellow WI members went to the nursing home to spend some time with her and to hand her a certificate from Nova Scotia's head office as well as a bouquet of flowers.

I wish Esther to continue to be happy and contented and to cherish the wonderful memories of 105 years – I certainly cherish her remarkable, inspirational life!

PRE-CONFERENCE CITY SIGHTS TOUR (4 April 2019) - Additional fee of £30

This tour aims to orientate you with your host city, Melbourne. The inhabitants of Melbourne love her elegant layout, her Victorian grandeur and architecture, her wide tree-lined streets, the hustle and bustle of this thriving metropolis. It includes the coach travel and tour guide, and will give you a great introduction to the city. The tall ash forests will guide you into the spectacular Blue Dandenong ranges. You'll travel through the picturesque Yarra Valley to the Healesville Sanctuary, and enjoy wildlife encounters along the way. The generous spit-roast lunch will be hosted at a regional winery, and include a sample of their wine. Your sweet tooth will be satisfied by chocolates at the Yarra Valley Choclatery & Ice Creamery, before you head to the Healesville Sanctuary which is home to over 200 species of Australian birds, mammals and reptiles. You'll be delighted with a walk around the natural bushland, and will have the opportunity to meet some of Australia's native animals.

This tour will leave the Melbourne Exhibition & Convention Centre (the Triennial World Conference Venue) at 9.30am and return at 4.30pm. The fee includes the coach journey, 2 course lunch at the Winery, and a glass of wine.

TOUR B PENGUINS ON PARADE



At dusk each evening, the Little Penguins come home to Phillip Island from the sea. You'll watch from an elevated boardwalk as they cautiously waddle from the beach to their burrows after a long day out in the water. Phillip Island is a treasure trove of Australian wildlife; you'll encounter seals, koalas, kangaroos, wallabies, birdlife and, of course, the penguins! You'll visit Churchill Island where you can explore the working farm, or enjoy ocean views from the café. At the Koala Conservation Centre you'll see koalas in their natural habitat and, before sunset, you'll head to the Penguin Parade and wander through the 'Penguin Experience' exhibit so you can learn more about them. Finally you'll walk out to Summerland Beach and take your seat for the Penguins on Parade.

You'll then visit Flavorite Tomatoes, a tomato, eggplant, capsicum and zucchini production farm. With the support of a dedicated network of growers and a few other stalwarts from the Hydroponic Farmers Federation they have taken a cottage industry to a major supermarket category. Before returning to Melbourne visit the most technically advanced dairy farm in the District to see the fascinating robotic milking on a grazing farm, and even enjoy a cup of tea!

This tour will leave the Melbourne Exhibition & Convention Centre (the Triennial World Conference Venue) at 9am and will return at 5.30pm. The fee includes the transport, visits to farms, light lunch and afternoon tea, accompanied by a member of the Country Women's Association of Victoria.

INTRODUCING THE WE FUND

ACWW's new funding programme for our Projects worldwide

We are very proud to announce our new fund, which supports ACWW Projects. Over the years, your generous support has allowed us to fund more than 1030 women-led, community based projects around the world. We want to ensure that this legacy is carried forward and that we can grow and develop our support of women's empowerment globally.

After initial applications, potential ACWW projects are shortlisted and selected by a combination of the Central Office staff and Projects Committee, and then approved by the Board. At this stage, they have become an official ACWW Project and are given a number. The most recent is Project 1041. This process will remain constant!

Previously, once a project was approved, it would be funded up-front by ACWW. We would then approach member societies with a list of projects that had recently been approved, and seek pledges to 'Adopt' the projects, with donations coming over the next couple of years. Whilst many Societies gave generously, this replenishment process meant that the Projects funds never grew or allowed for expansion. For some Societies, they were safe in the knowledge that they had a project to work towards funding, but others were disappointed that they felt they couldn't contribute to that project.

By changing how we ask for donations, we aim to improve the system, and increase the number of projects we can fund each year. This will allow more people to get involved, and ensure that we are helping as many communities as we possibly can.

At the heart of all of ACWW's activities is Women's Empowerment. Our projects are a crucial contribution to a safe, sustainable, progressive future for women and communities worldwide.



The Women Empowered Fund, known as 'WE Fund', is our new initiative to increasing the project funding capacity of ACWW, and thus the impacts we make.

There are six Priority Focus areas in which ACWW directs funding. Our goal initially is to build each of these 'pots' to £20,000 so the Projects Committee will know how much can sustainably be distributed in grants, whilst including provision for project monitoring and evaluation. As funds are committed to projects, the level on the Priority Focus pot will drop, until funds are built up again.

The new Projects page on the website shows the six pots and their current funding totals, updated each week. This will also show when funds are committed, and include all updates from project participants and beneficiaries, as well as case studies and impact assessments.

As donors, you will be able to see at a glance where money is most needed. Your group may choose to give to one Priority Focus, or to split your donations across several. You could choose to send in donations and ask for them to be directed to the pot with the lowest level of funding, or consistently fund your chosen Focus.

When you send in a donation, it will be recorded on our system, and acknowledged. When we use donations to fund a project in the Priority Focus you choose to support, you will receive an update and information about the project. As the project develops, you will continue to receive impact statements and updates, as well as information on how the project contributes to the success of the Sustainable Development Goals. Of course, if you have funded multiple Priority Focus areas, you will receive updates for each of them. If more than one project is funded from your Priority Focus, you will hear about them too!

Your Society can donate any amount to any of the six Priority Focus areas, and if you'd like a rough guide, the average ACWW project currently costs around £4,000 to complete.

The six new projects approved in March 2018 were the last to follow the old model, and have all been adopted. This way of funding projects retrospectively has been limiting the growth of our capacity.


The new WE Fund allows you to contribute to funding projects up front, receive much faster updates, and benefit from a greater understanding of the impact you are making. Crucially, as this funding is not limited to specific projects but rather Priority Focus areas, your donations will reach further and benefit people across the world. As funds are used, the pots can be replenished with donations.

We are always so grateful that those who support projects are so personally invested, both financially and emotionally, in this work. Connecting women has always been a crucial part of ACWW, and joining communities together through the Women Empowered Fund continues this work into a most sustainable, more effective, future.

Women in Conflict

The UN passed Security Council Resolution 1325 in the year 2000. It states: "The Security Council urges Member States to ensure increased representation of women at all decision-making levels in national, regional and international institutions and mechanisms for the prevention, management, and resolution of conflict"

In 2013, ACWW passed the following Resolution, in support of 1325:

"Be it resolved that the ACWW and its member organisations urge their governments to act upon, not only adopt, the UN Security Council Resolution 1325"

In 2016, the percentage of signed peace agreements containing gender-specific provisions declined to

50%, as compared to 70% in 2014

Gender gaps in humanitarian settings are glaringly evident. In conflict and post-conflict settings, maternal mortality rates are

nearly twice the global ratio, while girls are 2.5 times more likely to be out of school

VIOLENCE & TRAFFICKING

The Marta Centre is a non-governmental organization that aims to provide support to women in Latvia, especially non-citizens and migrants, women with a low income or unemployed, female victims of human trafficking and of domestic violence. On International Women's Day they called for solidarity with rural women in Latvia; several events took place on 8 March to cast some light on the problems they face. They emphasised that women from rural regions are more subject to different socio-economic risks and are less likely to be able to access quality help in cases of domestic violence or human trafficking

This call for solidarity with rural women started a wide discussion that showed Latvian society is not well informed about the struggle rural women face. However, statistics show that unemployment levels are higher than in the capital Riga. The stereotype indicates women in rural areas live more peaceful and fulfilling lives, but society refuses to notice the complex circumstances that make lives of rural women harder.

Because of the economic situation in rural regions of Latvia, it is difficult for women to find jobs commensurate with their abilities, not to mention the careers they aspire to, since the opportunity to receive higher education in rural regions is very restricted. It is also difficult to receive good quality medical care or screening or get timely help when their physical or emotional wellbeing is in danger.

The European Institute for Gender Equality has concluded that in the European Union poverty has a woman's face. Latvia is no exception. Poverty is more present in rural areas and unemployment rates are high. Women are forced to take low paid jobs closer to home or commute to larger cities. Commuting and full-time jobs are often not an option for women with children as it is still believed to be the woman's duty to take care of children and, in the case of a family split, children usually stay with mother.

Thus, women from rural regions more economically vulnerable. They are more exposed to poverty, staying in physically and/or emotionally violent relationships and they can become involved in human trafficking schemes or prostitution, as shown in the case studies on recruitment for human trafficking. Research shows that in crisis situations, where a woman has no resources or shelter, prostitution is perceived to be the only available alternative.

This research also shows that women, who are entrapped in human trafficking usually come from rural areas, then are trafficked to larger cities and then to the capital or other countries.

Marta Centre provides help to women in crisis from all over Latvia and in 2017 opened regional branch in Liepāja.

Often women are ashamed and would rather seek help further away from the city they live in as they are afraid people will judge them. In some cases, violent partners are popular in their small communities and people do not believe the victim. These are a few of the reasons that prevent women from seeking help in crisis situations or revealing their experiences and needs.

Often social workers and police in regions are not prepared or skilled enough to work with victims of domestic violence as shown in project "ONE STEP CLOSER: Coordinated Community Response to Violence against Women". Here professionals from Marta Centre interviewed women about the responses they got after involving the police in cases where their partner abused them. As a part of this project several seminars were held for the media on how to reflect on domestic violence avoiding victim blaming and sensationalism but rather putting an emphasis on understanding that it is a problem of society and what needs to be done to end it.

Society in our provincial towns and rural regions is still very judgemental; it cultivates the traditional stereotypes of women as subordinate to men and being the main care givers. In this environment women are often held back from pursuing their choices and equal opportunities. To escape difficult economic situations, fulfil their ambitions or to have some time outside work and family life, women sometime choose unconventional paths and ways to spend their time that are not accepted in society as suitable for women, so they can become social outcasts.

Frequently women become the central force in organizing cultural events and hobby groups to regain control of their lives that are usually organized around family and household and often include hard physical work in the fields or with farm animals.

The benefit of engaging in some social life is becoming well-known locally as an efficient and reliable person and can result in being elected to regional government - 39% of representatives in regional governments are women. Before the Parliamentary election in October, the Marta Centre will organize regional discussions; "My life, my choice".

These will aim to eliminate violence against girls and women in Latvia by changing attitudes of opinion leaders, experts and decision makers as well as facilitating ratification of the Convention against violence against women (CEDAW) and promoting the Swedish model of preventing sexual exploitation of girls and women. The plan is to invite politicians to discussions and help regional opinion leaders recognize which of them represent values that would help implement these aims and for people to connect directly to the people with legislative power and speak about their concerns and problems that need to be urgently addressed.

Although the Marta Centre participates in legislative processes that can help resolve some situations, the focus is still on informing people about options and ways to get help, as well as training police and social workers on how to respond in cases of domestic violence and human trafficking.

We find communication with fellow organizations is a big help shifting the focus on things that are most important for rural women.

Even though the aims are universal they should be approached through the everyday life perspective of rural women.

We all have rights to equal opportunities in life. These rights should be provided not only by constitution but also in reality – we should be able to carry out this equality regardless of our occupation. But it can only happen when we will notice that pursuing equality for women must include understanding of intersectionality, in this case by acknowledging that obstacles for women from regions often are complex and therefore harder to overcome.
