DO I NEED TO REPLY?

All Lead Delegates must be identified to Central Office by **16 February 2026**, close of business London time. If your Society does not name a Lead Delegate by this date, you will not be able to vote at the Triennial World Conference. Submissions must be sent to worldconference@acww.org.uk with "Lead Delegate" in the subject box. All emails will get an auto-reply message to confirm their receipt.

Guidance for readers

During the Triennial World Conference, there are several occasions when voting is necessary. This includes the Plenary Sessions of conference business, where Member Societies use their voting papers to indicate their votes for or against a motion, and the election of the Board of Trustees during the Conference where ballot papers are issued to the Lead Delegates of each Voting Member Society. It is therefore important that the Lead Delegate is appointed by each Voting Member Society (Categories 1, 2 and 3).

If your Society is not planning to attend the Triennial World Conference in person, they may request a Proxy Vote as outlined in the Proxy Voting Conference Information document which will be circulated to all Societies.

Official Credentials Form for Voting and Ballot Papers

Voting Member Societies sending delegations, and societies who are using a proxy voter **MUST** complete this form, which must be presented to obtain Voting Cards for the Plenary Sessions (in person during registration) and Ballot Papers for the elections of Officers and Committee Chairman (as you enter the Voting Area for the Election).2q

PLEASE NOTE: For Societies sending a delegation, the completed form must go to Central Office **AND** the Lead Delegate.

If you have requested a Proxy Voter, you must send this form to Central Office who will send a copy to the officially appointed Proxy Voter. You will be informed of who your proxy voter is, and given their contact details.
