My name is Marie Kenny. I am a wife, mother, grandmother, author, artist, pastor and lifelong volunteer – titles that reflect my passion for service and belief in collective action. As a lifelong member of the Women's Institute and a dedicated ACWW member for over 50 years, I have embraced every opportunity to advocate, lead, and support grassroots initiatives. Judith Juma is a human rights lawyer from Kenya with experience in governance and policy formulation. She has previously worked with the Kenya Law Reform Commission, Kenya's Judiciary and Tribunals, and the International Development Law Organization on access to justice programs. She has also led election observation missions during Kenya's elections and has assisted in policy and legislative proposal development for Kenya's Parliament.

In 2022, Judith co-founded a community-based non-governmental organization called the Social Justice League, which supports women in political and appointive leadership through training, advocacy against electoral-related gender-based violence and provides free legal support to rural communities in Kenya. She is passionate about empowering women and youth, and has worked extensively with rural communities as well as Kenya's indigenous and pastoralist Samburu community.

Judith first interacted with ACWW when attending her first East, West and Central Africa Area Conference after being introduced to the East Africa Women's League (EAWL) (ACWW Member Society) by her mother. Judith saw a direct connection between EAWL, ACWW and her work with rural communities in Kenya. She later attended ACWW Triennial Conference in Malaysia, which gave her insight into the history, activities and passion of ACWW and Member Societies.

In August 2024, Judith was appointed to serve as Deputy World President and Board Lead on Membership. She embraced this role with enthusiasm and a desire to connect with ACWW membership around the world. In the coming years, Judith would like to continue serving in the role of Deputy World President because she is committed to increasing ACWW's membership, engagement, and continuity to strengthen the organization's impact globally. In this role, she would like to interact more with members, understand their unique experiences and find ways to amplify local projects to ensure they have a broader reach and impact.

Elected in 2017 to 2024 Snoekie served on the MANCO and EXCO boards of the Vaalharts Water Users Association, one of the largest government owned irrigation schemes in the Southern Hemisphere. As chairman of the local Social Responsibility Committee, Snoekie has headed many successful and sustainable projects including Emerging Farmer Capacity Building workshops, Water Safety Campaigns, identifying and working with stakeholders as well as organised awareness events for the Sustainable Development Goals in rural communities for women and children.

Snoekie is a dedicated member of the Cape Woman's Agricultural Association and she holds the position of Area President of the Kimberley and District Circle of this ACWW Affiliated society. She worked in collaboration with the North West University, sharing information for a water-food-energy nexus. She is well renowned for her voluntary work within her association as well as the communities in the farming district of Vaalharts. She and her husband share a passion for farming. They are joint owners of 325 ha of pecan farms and also own Pekanhoek, a pecan processing facility which process and export in excess of 5,000 tons of pecans per season, giving employment to 84 people annually.

I am a retired naval commander and an advocate for women's equality. I have been a member of the Queensland Country Women's Association (QCWA) for 15 years. During my Royal Australian Navy career and community work, I have led and participated in many projects. I would be honoured to share my skills and experience with ACWW. On exchange with the New Zealand Navy, I developed an automated statistical reporting system for the NZ Defence Communications Network. This project and another for the Australian Navy Fleet Communications Centre, which delivered cost savings and increased efficiency, contributed to me being awarded an Order of Australia in the 1990s Queen's Birthday Honours List.

My other projects include overseeing a \$40m retention bonus for engineering sailors, and a \$75m Navy base redevelopment. In a voluntary capacity, I led the reinvigoration of the Cairns Navy Cadet Unit, a youth skills and confidence development program. I have an Arts Degree with majors in Politics, International and Asian Studies. I have travelled widely, finding the knowledge gained from my fields of study useful in understanding different cultures. In my doctoral research I documented Australian Navy women's journey towards equality identifying policy pathways to achieve complete equality. I am an international human rights lawyer and global expert on socio-economic development. I work as a consultant on issues related to women and gender equality, the right to food and food security, agricultural production systems, the environment, access to education, global health and housing. I have worked as a Special Advisor to world leaders including the former President of Ireland Mrs Mary Robinson, and the first UN Special Rapporteur on the Right to Food. I've run a global consulting practice for over 20 years, offering advocacy, policy, legal and communications advice to businesses, governments, civil society, non-governmental organisations, advocacy movements, and international experts. I've worked in the non-profit sector for organisations such as Amnesty International, and in academia as a law professor at some of the world's top academic institutions. I've also worked as the Senior Advisor on Human Rights and Inclusive Development for the New Zealand Ministry of Foreign Affairs and Trade.

I am passionate about women's empowerment, the role of women in agriculture and the environment, rural women's health and education, and communicating about these issues. I have written and edited books on the right to food, the right to health, women and the environment, and housing rights and homelessness. I have written speeches, designed and managed websites, written social media content, drafted grant proposals, and authored advocacy guides and legal correspondence. I have been board member/trustee of organisations in New Zealand, Australia and Switzerland.

I am from Rotorua, New Zealand, where my family have farmed (dry stock – sheep, deer, bull beef – and dairy) for four generations. These days, I am mostly based in Geneva, living just over the border in a rural French village, and I try to return as often as possible to New Zealand and Australia, where my family live.

I have attended several past Triennial conferences and Canada Area conferences, where I connected with many like-minded women who share my passion for ACWW.
