EVENT RULES - INITIAL EACH ITEM

- ☐ 1. Candy-collecting participants must be age 12 or younger and accompanied and supervised by a responsible adult.
- ☐ 2. Costumes, decorations, music, and conduct must be family-friendly. Costumes should permit clear vision and include reflective material, glow sticks, or a flashlight. Realistic weapons, graphic violence, and excessive gore are prohibited.
- ☐ 3. No firearms, dangerous costume accessories, open flames, fireworks, smoke devices, alcohol, illegal drugs, smoking, or vaping are permitted in the event area.
- ☐ 4. Vehicles must arrive by the organizer's announced check-in deadline. Engines must be off, parking brakes applied, and keys secured before children enter the area.
- ☐ 5. Vehicles may not move or leave the designated area until the event ends and an organizer authorizes departure, except during an emergency directed by event personnel.
- ☐ 6. Only commercially manufactured, individually wrapped candy or organizer-approved treats may be distributed. Homemade, opened, expired, or damaged food is prohibited.
- ☐ 7. Participants must keep decorations, cords, and equipment secure and must not block fire lanes, sidewalks, exits, or neighboring spaces.
- ☐ 8. Parents or guardians are responsible for inspecting all treats before children consume them. Participants should identify common allergens when reasonably possible.
- ☐ 9. Participants must follow all instructions issued by organizers, safety personnel, the property owner, or emergency responders.

SPACES ARE LIMITED. Registration is not confirmed until approved by an event organizer.
