PLANET DOOM HOUSE RULES

1. NO SMOKING IN THE BUILDING, EVER! There will be an outside designated area for smoking. If you must smoke, consider yourself "out of character" and do so out of view of the guests, behind the building.
2. Possession of alcohol and drugs is strictly prohibited. This includes working under any illegal influence.
3. Costumes are not allowed off the haunt property without prior permission from the management.
4. Grabbing or touching the guests is prohibited.
5. Sexual misconduct is not tolerated, and profanity should be avoided - especially while "in character" and in front of the guests.
6. ALL guest problems must be reported to the management immediately.
7. All costumes, masks and accessories must be turned in at the end of each night.
8. Please arrive to work on time and notify management of any upcoming absences.
9. Cell phones must be shut-off during operating hours. These items must remain out of sight. Stay in character at all times. Zombies do not use cell phones.
10. Wear appropriate attire – i.e., no white socks unless your role calls for it!
11. Actors are NOT TO BE SEEN eating, drinking sodas or smoking! Zombies do not drink bottled water or Mountain Dew – so keep food and drinks out of sight. PLEASE STAY IN CHARACTER.
YOU WILL BE EXPECTED TO PROMPTLY CLEAN UP ALL FOOD AND DRINK ITEMS WHEN YOU ARE FINISHED. Trash/recycling bins will be provided.
12. We don't do "Boo" and we don't do "RAAAR!" Let's get creative with our scares. We will provide scare actor training prior to our opening date.

PLEASE REMEMBER – EVERY ACTION WE TAKE IN THE HAUNTED HOUSE IS A REFLECTION ON THE D.A.R.E. PROGRAM. LET'S HAVE A GREAT TIME WHILE BEING COURTEOUS TO OTHERS AND PROFESSIONAL AT ALL TIMES
