



#### Feel Out Of The Loop?


Get informed. Use the internet, the library, books, and reliable sources. Not everything will come easily—you have to put in the work.

### Former WPMI Anchor - Now In Charlotte

Things will not be the same at WPMI — or for that matter, Mobile — without the presence of Kym Anderson. The veteran newscaster recently relocated to Charlotte N.C. after a nearly 18-year run at the news station. She is now at WBTV, an award-winning station legacy television station. Anderson will anchor the 4:30 p.m., 5:30 p.m., and the 'On Your Side Show" at 7 p.m. with Jamie Boles. "WBTV is owned by Gray Television," she said "It's actually the same company that owns FOX 10, so I'll be with the Gray TV family now. It's a great company. "I'll be doing early evenings, so I won't be doing late, late news. I'm really thankful about that. The 7 p.m. program I'll be doing is a super advocacy-type show to where we fight for other people and to be helpful. I'm now looking forward to getting to know the people in the "Queen City!" Charlotte has so many opportunities for growth. I'm ready for the challenge."

Anderson reflected on her time in Mobile. "Mobile embraced me from day one," she said. "The people in the city have shown true southern hospitality for not only me, but my children. For that I'm forever grateful. I've worked with some of the best people in the industry and have made lifelong friends at NBC 15. My daughter was four months old when I moved here. She's 18 now and about ready to graduate from high school."

One of the things that made Mobile memorable for Anderson, a native of Riverside, California, was the people she became acquainted with during her time in the Port City. "I grew up in Southern California, and there they don't have that Southern hospitality," she said. "It's just something about it; it's like no other. People welcomed me from the very beginning, they were very warm, very loving, and embraced not just me, but my children. When I moved here, I didn't know anybody. It was a big move, and being a younger mother with three kids, everybody just stepped in and embraced my entire family."

Prior to her stint at WPMI, Anderson, a graduate of Oakwood University in Huntsville, worked at WHNT in Huntsville, as well as

WJSU, so she had a taste of Alabama prior to moving to Mobile. "My parents went to school there (at Oakwood), and my brothers went there, along with nieces and nephews," she said.

During her time at WPMI, Anderson covered many interesting stories, particularly those who focused on people seeking help.

"There were so many, but I always liked the stories where we advocated for people and help make a difference," she said. "There was one story where we had a lady call us about her daughter running off in the middle of the night with a young man. She was afraid her daughter may have been trafficked. We were able to put her in contact with the right people who were able to find her, and she was able to get her daughter back. Many times, I advocated for stories that would help people because we know, especially with African-Americans, they're painted in a negative light. If we can shine a positive light on them, that's what I want to do."

In recent years, despite a shortage of staff, Anderson and WPMI continued to provide viewers with quality news, especially when the station now has only the fourth of the staff as other news stations in the Mobile area. And now, since she has left, she said the station will continue with the same quality of work. "We had a lot of cutbacks with the company that owns it," she said. "Since I've been employed there, the station has been owned by three different companies. Each time a company buys the station they end up having cutbacks. But even with the cutbacks, we have an amazing staff — we were the little engine that could. We just made it work and they're going to continue to make it work. They're dedicated journalists who really give 150 percent, and there's no better staff. They're really amazing. It's a miracle because that shows the dedication to that staff and the quality of that staff. Most people would not be able to handle the work that our reporters do, but we have a news director who works very hard and makes sure we don't miss anything."❖





Black on Black Crime is a cringe worthy expression from my perspective. 

The project was hailed as the first time that federal civil rights laws were used to ease the impact of environmental racism but was called an "illegal DEI and environmental justice policy" by the current administration...The Federal Railroad Administration has ruled that a project proposed by the Alabama Port Authority will not affect historic properties in Africatown. The Chickasaw Lead Line project would add a siding to an existing track but, Africatown residents and organizations are concerned about further encroachment into their community. One area has been identified as where the shipyard that built the Slaveship Clotilda was constructed...Amtrak's Mardi Gras Service will this summer serving Mobile and Coastal Mississippi to New Orleans with connections twice daily between Mobile, Pascagoula, Biloxi, Gulfport, Bay St. Louis, and New Orleans. Connections can be made to Memphis, Chicago, Atlanta, New York, Houston, San Antonio, Tucson, and Los Angeles...American Cruise Lines will make Mobile a Port of Call in March 2026 with its ship the American Symphony as part of a new Gulf Coast Cruise itinerary. The eight-day cruise travels from New Orleans to Pensacola, Florida and will include stops at several ports along the Gulf Coast...Mobile native, comedian, and TV Host W. Kamau Bell, winner of the third season of Celebrity Jeopardy, donated \$183 thousand of his winnings to teachers in Mobile and Oakland, California for classroom resources...Recently, two Alabama cities were listed in the Top Ten Cities with the Highest Obesity Rates in the Country. Birmingham was ranked 9th, while Mobile was ranked 3rd with 35% of adults classified AA obese...And finally, Feeding Alabama, encourages citizens to celebrate this Mother's Day the Strength of WIC in Alabama. #### National Gun Violence Awareness Days PROJECT WEAR ORANGE

#### "A CALL TO END GUN VIOLENCE"

The Mobile Chapter of the NAACP is hosting "A Call to End Gun Violence" in support of National Gun Violence Awareness Days on June 6th at Mobile Government Plaza, 205 Government Street, Mobile.

Every day, **125 people** lose their lives to gun violence in the United States, and hundreds more are wounded or traumatized. This June, communities across the country will come together for **WEAR ORANGE WEEKEND**, a movement dedicated to honoring survivors and advocating for a future free from gun violence. Wear Orange began in memory of **Hadiya Pendleton**, a young girl whose life was tragically cut short by gun violence in 2013. Her friends chose orange—the color hunters wear to protect themselves—as a symbol of safety and solidarity. Since then, the NAACP has championed the Wear Orange campaign as it has grown into a national movement, bringing together activists, survivors, and lawmakers to demand change.

This year, the public is invited to wear orange, attend local events, and raise awareness about the urgent need for gun violence prevention. In Mobile, the NAACP will host a Press Conference at Government Plaza on Government Street at 11:00 a.m., where community leaders, survivors, and advocates will share their stories and call for action.

#### **HOW TO PARTICIPATE**

- \* Types of Gun Deaths: More than half of firearm-related deaths are suicides, while over 40% are homicides.
- \* Youth Impact: Firearm injuries were the leading cause of death among children and teens aged 1-19 in 2022.
- \* **State Variations:** Gun violence rates vary significantly by state, with some regions experiencing much higher firearm-related deaths.





## Bobby Seale





WHITE RURAL RAGE is a "searing portrait and a damning takedown of America's proudest citizens, who are also the least likely to defend its core principles". White rural voters hold the greatest electoral sway of any demographic group in the United States, yet rural communities suffer from poor healthcare access, failing infrastructure, and severe manufacturing and farming job losses. Rural voters believe our nation has betrayed them, and to some degree, they're right. These authors explore why rural whites have failed to reap the benefits from their outsize political power and why, as a result, they are the most likely group to abandon democratic norms and traditions. Their rage, stoked by Republican politicians and the conservative media, now poses an existential threat to the United States. The authors show how vulnerable U.S. democracy has become to rural whites who, despite legitimate grievances, are increasing inclined to hold racist and xenophobic beliefs, to believe in conspiracy theories, to accept violence as a legitimate course of political action, and to exhibit antidemocratic tendencies.

#### **Madam Eula McCleany**

The Woman Who Built an Empire—And the System That Stole It A Reflection on Madam Eula McClaney's Legacy and the Cost of Unprotected Wealth

#### EULA MCCLANEY WAS A FORCE.

Born in 1914 to sharecroppers in Alabama, she picked cotton as a child and left school after sixth grade. But she never stopped learning. With just \$125 and unshakable faith, she taught herself real estate and built an empire—owning land, hotels, hospitals, and rental properties across the country.

At a time when Black women weren't even allowed in boardrooms, Madam McClaney owned entire blocks. She lived in a 22-room mansion in Beverly Hills, right next to Hugh Hefner. She invested in oil wells. She was bold, brilliant, and decades ahead of her time.

But her legacy wasn't just in what she built—it was in what she gave. Millions in donations to HBCUs, churches, cancer research, and civil rights causes. She believed in Black ownership, in selfdetermination, and in building for future generations.

And yet, in 1986, when she passed away without a will or trust, the very system she had beaten turned against her.

The State of Alabama declared her "incompetent" *after death*—a legally dubious move that allowed them to seize her assets, liquidate her estate, and erase her wishes. Her wealth, meant to uplift her family and community, was scattered. Her empire—gone.

THIS WASN'T JUST A TRAGIC OVERSIGHT. IT WAS THEFT. Disguised in legal language, it was a reminder that BLACK WEALTH IS TOO OFTEN UNPROTECTED AND UNPRESERVED, not because we don't earn it—but because we aren't taught how to defend it.

Let Madam McClaney's story be more than a footnote. Let it be a wake-up call. If you own anything—a home, a business, a savings account—you need to protect it.

Because wealth without protection is not a legacy. It's a target.

Eula McClaney built something extraordinary. Let's honor her by making sure it never happens again.



#### **Family Counseling**

The Family Counseling Center offers real solutions to real problems Mental & Emotional Wellness & Anger Counseling Lifelines counselors are trained to provide counseling as well as education. They help not only in current struggles but also in any future circumstances you may have. The thought is, by giving you the tools to handle issues that arise in your life you can work through current struggles with their help and future struggles on your own. Mental & Emotional Wellness needs can include internal or external factors:

#### <u>Family, Marital & Divorce Counseling</u>

The Family Counseling Center offers services to help couples and children through marriage and divorce problems. Family counselors are trained to help couples walk through issues that could be causing marital strife as well as provide the couples with tools to solve these problems. Their innovative program for divorcing parents provides in-depth techniques for successfully moving their families through the transition of separation and divorce. Counseling helps individuals overcome marital discord, divorce, and parent-child conflicts.

Helping Children Cope With Divorce classes, A four hour educational program about the needs of children during and after the divorce of their parents. Parents learn how to help their children through this difficult time. Topics include typical reactions of children, skills that help children cope, visitation issues and pitfalls to avoid. The Domestic Relations Judge requires divorcing parents to attend.

#### **Children & Adolescent Counseling**

What causes the need for a child to come in for counseling? A traumatic event, A misunderstood mental illness or a developmental delay, or even facing a difficult family situation. If a child experiences one or more unsettling events in their life, the stress could be more than the child could understand and handle. Lifelines' child counseling focuses on breaking down problems so the child can understand and teaching the child the tools they need to progress in their life. Often times the child feels more comfortable talking with someone besides a parent or loved one, or simply can not express what they are going through.

Consumer Credit Counseling Service provides community members in Southwest Alabama with assistance in managing personal finances, both preventative - for those wanting to avoid serious financial problems, and rehabilitative - for those who are experiencing financial problems.

#### **Budget & Debt Counseling**

Budget Counseling can assist you in developing a realistic spending plan. Credit Report Review - This can help clients better understand credit reports, identify information that is incorrectly reported, learn ways in which to improve credit scores, and to help determine if they have been victims of identity theft.

**Debt Management Program** - This program enables clients to make one payment through CCCS each month to repay unsecured debts to their creditors. In most cases, creditors are willing to reduce interest rates, and/or waive over the limit and late fees.

**Bankruptcy Counseling** - This is required for anyone filing bankruptcy. Sessions for individuals or couples are conducted one-to-one, via the phone or online. In Pre-filing counseling certified counselors assist clients in determining what options are available to them, the differences between Chapter 7 and Chapter 13, and other issues they need to consider. In Pre-discharge counseling certified counselors conduct. Online Bankruptcy Counseling Courses can be taken online.

**Student Loan Counseling** - Counseling will be provided by a certified Student Loan Counselor. Certified Counselors can provide information to assist in all areas of student loan counseling. A session will consist of a credit report pull to verify the status of the student loan debt and a review of the client's spending plan to determine the ability to pay b or seek one of the 12 repayment plans for Federal Student Loan Debt. Private student loan options are very limited but counselor can discuss what assistance is available.

#### ENDING THE HIV EPIDEMIC (EHE)

The staff of Lifelines Counseling Services provides support by offering local community programming, multi-organization community-driven projects, and coalition-led proposals from organizations collaborating to end the HIV epidemic in Mobile County.

- \* **Comprehensive HIV Innovation Programs**: The efforts supported through the program include, but are not limited to:
- Innovative non-clinical testing programs
- Innovative, supportive service programs
- Comprehensive HIV prevention programs inclusive of biomedical prevention options

#### \* Community Outreach and Education

EHE

In 2019, the U.S. Department of Health and Human Services (HHS) unveiled the EHE Initiative, a national collaborative response developed and embraced by the Center for Disease Control and Prevention, Health Resources and Services Administration, Indian Health Services, National Institute of Health, Office of the Assistant Secretary for Health, and the Substance Abuse and Mental Services Administration. The goal of EHE is to reduce new infections by 75% in the next 5 years and by 90% by 2030.

In Alabama, the EHE Initiative is a statewide effort with accelerated efforts to reduce new HIV infections within the five highest burden counties---Houston, Jefferson, MOBILE, Montgomery, and Tuscaloosa, and the 14 emerging counties---Bullock, Calhoun, Dallas, Franklin, Lee, Lowndes, Macon, Madison, Marion, Morgan, Russell, Talladega, Walker, and Winston.

To accomplish the goals of the EHE Initiative, Alabama's plan to eliminate the transmission of HIV related deaths align with the EHE pillars. The "pillars," or strategies that can end the epidemic are, Diagnosis, Treat, Prevent, and Respond. With sufficient resources, EHE's goal of reducing new HIV infections in the United States by 90% is achievable. You can find tools and resources locally through Lifelines, through the Alabama Department of Health, and the CDC.

#### **EHE PILLARS**

<u>DIAGNOSE</u> - Diagnose all people with HIV as early as possible. Knowing one's HIV status is a critical step in accessing powerful prevention and treatment tools. CDC collaborates with communities and other agencies to expand HIV testing according to CDC guidelines.

<u>Strategy</u> - To decrease the number of new HIV infections and help more people get tested and know their status.

TREAT - Treat people with HIV rapidly and effectively to reach sustained viral suppression. HIV treatment preserves the health of people with HIV and is one of the most powerful HIV prevention strategies available. People with HIV can live long, healthy lives. They will not transmit HIV through sex if they take medication as prescribed and maintain an undetectable viral load. This is known as treatment, as prevention, and is sometimes referred to as "Undetectable = Untransmittable" or U=U.

<u>STRATEGY</u> - To increase the number of people with HIV who are on treatment and who are virally suppressed.


<u>PREVENT</u> - Prevent new HIV transmission by using proven interventions, including pre-exposure prophylaxis (PrEP) and syringe services programs (SSPs). PrEP and SSPs are highly effective HIV prevention strategies. When taken as prescribed, PrEP reduces the risk of getting HIV from sex by about 99%. PrEP also reduces the risk of getting HIV from injection drug use by at least74%. Comprehensive SSPs have been shown to dramatically reduce HIV transmission. SSPs also provide an entry point accessing substance use disorder treatment and prevent overdose deaths and other infectious diseases.

<u>STRATEGY</u> - To prevent new HIV transmissions and increase access to HIV prevention services.

RESPOND - Respond quickly to potential HIV outbreaks you to get vital prevention and treatment services to people who need them. Real time cluster detection and response are key to ending the HIV epidemic in the United States. New public healthy strategies, including epidemiological approaches, help us quickly identify communities affected by rapid HIV transmission. Rapid transmission occurs when affected communities are not being reached by existing services due to structural and social factors. These factors may include stigma, discrimination, racism, poverty, and others. STRATEGY

To get vital HIV prevention and treatment services and resources to people who need them.

#### **MCHD'S INSPECTION SERVICES**

A recent report from the Centers for Disease Control and Prevention (CDC) has highlighted the contributing factors of foodborne illness outbreaks in the United States from 2014 to 2022. These outbreaks included approximately 15,000 illnesses, 800 hospitalizations, and 20 deaths. Many foodborne illness outbreaks occur because of contamination of food by an animal or environmental source before arriving at the point of final preparation. Most viral outbreaks are caused by contamination from ill food workers. Two common contributing factors to bacterial outbreaks are allowing foods to remain out of temperature control for a prolonged period along with inadequate time and temperature control during cooking.

"MHDC's Food & Lodging inspectors are present in the community partnering with eating establishments to ensure science-based food safety guidelines are followed to prevent outbreaks in our county," said Dr. Kevin Michaels, Health Officer for Mobile County. "We also offer food handler training courses to businesses and employees. Individual consumers can see how well the eating establishment performs by reviewing the numerical score posted in the business or downloading the MCHD App to their digital device and clicking on the Restaurant Rating."

#### **TESTING FOR STD/HIV PRIVATELY**

The Alabama Department of Public Health (ADPH) STD/HIV At-Home Specimen Collection initiative has been renewed. On May 01, kits will be available for order. The ADPH Division of Sexually Transmitted Disease Prevention and Control has collaborated with aware, Inc. for the ordering and delivery of the kits.

The purpose of the initiative is to promote STD/HIV testing and strengthen STD/HIV prevention efforts in Alabama. Home delivery of specimen collection kits allows people to collect a sample for a sexually transmitted infection, including HIV, in the convenience of their own home. The approach will help reach vulnerable populations and individuals in rural communities who may not otherwise get tested.

Specimen collection kits are mailed to the patient's home. The kits contain supplies to collect specimens from various collection sites. The kit is then mailed to a lab in a pre-paid envelope. #### **WIC INCOME GUIDELINES INCREASE**

Alabama's income guidelines for the Special Supplemental Nutrition Program for Women, Infants, and Children (better known as WIC) have increased, and additional people may qualify. If you are a woman who is pregnant, has had a baby within the past six months, or is currently breastfeeding, or if you are the parent or guardian of a child up to age 5, you are encouraged to contact your local county health department or WIC agency to apply.

Under the 2025 federal poverty guidelines, more families may be eligible for the program. WIC is open to participants with incomes up to 185 percent of the federal poverty level. Check the table below to see if your family may qualify:

#### FIGHT THE BITE

#### PROTECT YOURSELF FROM MOSQUITO-BORNE DISEASES THIS SEASON

As mosquito season ramps up, the Alabama Department of Public Health urges all residents to take preventive measures to protect themselves and their communities from mosquito-borne diseases such as West Nile Virus (WNV), Eastern Equine Encephalitis (EEEV), St. Louis Encephalitis Virus (SLEV), and La Crosse Virus (LCV). Mosquitoes are more than a nuisance; they can carry viruses that cause serious illness in humans. Fortunately, there are simple steps everyone can take to stay safe.

#### MOSQUITO HABITAT: ELIMINATE STANDING WATER

Mosquitoes lay eggs in standing water. One small container can produce hundreds of mosquitoes in a week. To prevent breeding:

- Dump and drain standing water from flowerpots, gutters, buckets, pet dishes, birdbaths, tires, tarps, and children's toys.
- Clean and scrub containers that hold water weekly to remove mosquito eggs.
- Cover rain barrels or water storage containers with tightly fitting ids or fine mesh.
- Fill in low spots in your yard where water can collect.

#### **BITE PREVENTION: PROTECT YOURSELF AND YOUR FAMILY**

No vaccine and no specific treatments are available for these mosquito-borne diseases. Therefore, the best defense is to prevent mosquito bites. Reduce your risk of infection with these bite prevention tips:

- Use EPA-registered insect repellents with DEET, picaridin, IR3535, or oil of lemon eucalyptus.
- Wear long sleeves and pants when outdoors, especially during Dawn and dusk when mosquitoes are most active.
- $\bullet$  Install or repair screens on windows and doors to keep mosquitoes outside.
- Stay indoors during peak mosquito hours whenever possible.

WNV is the most reported mosquito-borne disease in Alabama. WNV cycles between mosquitoes and wild birds and is primarily transmitted by Culex species. Culex mosquitoes can live and breed near our homes, and these mosquitoes along with other kinds of mosquitoes can pick up the virus and then transmit it to people, horses, and other mammals when biting during their next meal. EEEV, SLE, and LCV are also spread through the bite of a mosquito.





Sisters and brothers, I am seeing a return to the 1950s and earlier times when Trump/Republicans are praising state's schools. I am an 85-year-old Black man from Arkansas. While I was in school from elementary through high school, the books were old because they had been used by the white students. Therefore, when I hear #47 talking positive about state schools, it reminds me of his other statement, "Make America Great Again." Those words reminded me of oppression against Black people.

African Americans, I don't know how we will fare in 2025, but it is paramount that we study our history in America. We have some options confronting USES, which could benefit the Black community: (1) The Democrats are perceived as weaklings, but we can influence their actions because of the large number Blacks voters; (2) The Republicans have gone over to the dark side of racism, so it is idiotic for Blacks to support their agenda; (3) The Independent candidates face obstacles: (A) Each state has its own rules, deadlines, and signature thresholds, making it exceptionally challenging for non-mainstream candidates to gain nationwide access: (B) National debates and media coverage are largely controlled by major news networks, which tend to favor major party candidates; (C) Federal campaign finance regulations can be especially burdensome for independent candidates; (D) At the national level, the "spoiler" stigma is often amplified. Voters may be more reluctant to support independent or third-party candidates due to fears of splitting the vote and indirectly aiding a major party candidate they oppose; and (E) In presidential elections, the Electoral College system can make it nearly impossible for independent candidates to secure the electoral votes needed to win the presidency. Therefore, descendants of enslaved Africans, your history and position in America is very different from all other ethnic groups.

Black veterans, you can see where #47 is heading concerning Black people. You should consider joining an organization that has been in the struggle since 1910, and this is the National Organization for the Advancement of Colored People (NAACP). I assume that you never thought, you would encounter a president who only cares about himself. I hope that this is a wake-up for USES because we thought that old days of racism had passed. However, history is always near the disenfranchised groups, especially if they are very distinguishable from the oppressors. We should never forget again as long as we are Black, we are only a short distance from our rights being reduced. I am a member of the NAACP, and the organization has stood for rights for all disenfranchised citizens since 1910.

Joy Reid, former host, Ayman Mehyeldin and Ali Velshi were the only commentators on MSNBC who discussed how the Israelites were moving Palestinians of their land. Former President Joe Biden and Progressive on MSNBC, including Nicole Wallace. #### **Moments in Time Paulette Horton**


#### **Lillie Warren**

History was made in Mobile on February 14, 1951 when a black nurse, Lillie Warren delivered five and a half pound triplets without a doctor's help. The triplets, two boys and one girl, belonged to Mr. and Mrs. Lorenzo Francis.

In her thirty-one years of nursing, she said this was the first case of its kind. In addition to be being a nurse, Ms. Warren was an active member of Franklin Street Baptist Church where she was active in every department of the church.

She worked at what was known as the 'Old Folks and Orphans' Home' along with her mother, Mrs. Leona B. Warren. Both worked untiringly with this charitable institution, which served many frail, elderly, and orphaned individuals for many years.

The Old Folks and Orphans' Home, which was located on the corner of Mobile Street and Springhill Avenue, later became known as the U.J. Robinson Memorial Day Care Center. A public school, located on Mobile Street not far from the U.J. Robinson Center, was named for Warren's mother, Leona B. Warren. It now houses a Head Start facility.





#### **Bright Ideas?**

I've been thinking about some things over the past few weeks. You know, sometimes it's tough writing for a monthly because it can be a struggle writing about a timely subject. I say this because there's so much going on in a span of a month that by the time you get your thoughts together, the subject you want to write about is older than week-old garbage. But thanks to reading about certain things, along with keeping up with local and national news and thinking about some of the stuff I've written about in books, I'm inspired to write about something.

With the craziness going on in America right now — you know, tariffs, the erasure of Black History, defunding of universities because of DEI, and an increasing erosion of what's left of a free press — it's about time we look at making plans to get things back on track. The reason we must do this is because various plans have or are in the process of being put into place...things such as Project 2025, the Insurrection Act, etc. Just as conservatives have formed think tanks to put policies in place designed to erode what's left of this democracy (not that Black people have felt they've been part of a democracy anyway), we have to explore the option of creating think tanks of our own.

These think tanks will not be operated out of mere emotion...they will be operated based on raw data; that is, the results of harmful policies that have so far harmed people of color and poor people in general. 

But due to the influence of larger for-profit healthcare entities, this pilot program was initially restricted to Southern California, Portland, Oregon and Brooklyn, New York. It has expanded but is still restricted. This Health Plan values care coordination, chronic disease prevention, and wellness oriented.


The traditional Medicare is expensive: Part B premiums are currently \$184 per month, in addition to Part D premiums and needing a Medicare Supplemental Plan costing an additional \$200 to \$600 per month. In addition, many need the safety net of a Long-Term Care plan with an additional premium. This can average \$9,408 annually, with the average Social Security Check in 2025 being \$1,999.97. Medicare Advantage creates a low premium plan that is viable for reasonably healthy seniors. Yet the biggest complaint is access to specialist, which you need your Doctor permission to access.

Medicare and Medicaid is a challenge because of greedy lobbyists and greedier politicians. The United States is ranked poorly in global healthcare system. With all the brilliance that exists in the United States, greed exceeds. That is the true reason that healthcare is the number one cause of bankruptcies. Yet we as Constituents are to blame for listening to charismatic sound bites and allowing this to exist. We must stop believing we have politicians who look out for our best interest.
