

## **Rough Summer**

This summer has not been especially kind to Black women. Aside from Kamala Harris getting the nod as the Democratic candidate for President of the United States, July and August has been unpleasant for women of color.

In July, Sonya Massey was allegedly shot and killed by a white deputy in Woodside Township, Illinois, not far from Springfield, the state capital. The deputy, Sean Patrick Grayson, was charged with three counts of first-degree murder, along with aggravated batter with a fire- arm, and official misconduct. Massey reportedly called 911 about a possible intruder. Grayson and his partner responded and found nothing out of the ordinary after searching the vicinity. They went to Massey's residence and requested her I.D. Massey began searching for it, and while doing so, was asked to remove a pot of boiling water from a stove. At that point, Massey told Grayson and the other deputy, "I rebuke you in the name of Jesus." Things quickly escalated when Grayson threatened to shoot Massey in the face. Massey apologized, but Grayson allegedly fired his weapon three times, fatally wounding Massey.

Grayson had a screwed-up history, to say the least. He was discharged from the Army for serious misconduct and worked for six different Illinois police departments between 2020 and 2024. With a sorry track record such as that, the Sangamon County Sheriff's Office, where Grayson worked, should have never touched his application with a 10-foot pole. Grayson had issues at each of the law enforcement agencies where he worked. It should have been enough to raise several red flags. Had the Sangamon County Sheriff's Office took a good look at Grayson's military record and past employment record, there's a strong chance Sonya Massey would still be alive and not a hashtag followed by a name.

Ironically, one of Massey's ancestors, named William Donnegan, was lynched in a 1908 riot in Springfield and died in the same hospital she did. This prompted one of her relatives to say, 'The more things change, the more they remain the same."

It's mind-boggling to see how such blasé attitudes in choosing people to be in positions of law enforcement can have such deadly consequences. It's also mind-boggling how screwed-up judging can dash an Olympian's dreams. Yeah, I'm talking about Jordan Chiles, the gymnast who was screwed out of a moment of glory because of botched officiating.

In case you missed it, there was a hotly contested floor exercise during the Paris Olympics, where Chiles, Brazil's Rebeca Andrade, along with Chiles' American teammate Simone Biles, and Romania's Ana Barbosu and Sabrina Maneca-Voinea were in contention for medals. Andrade won the gold, while Biles won silver. Here, folks, is where things went off the rails. Barbosu was originally declared the bronze medal winner, but Chiles' coach protested, saying the American was given a lower difficulty score than she deserved. After a review, the judges ruled in favor of Chiles, who was originally in fifth, and her revised score gave her the bronze medal.

As such, it led to the iconic photo where Biles and Chiles paid homage to Andrade, who had recently come off her fourth ACL injury to compete. But things were about to take a wicked turn, when the Romanian delegation fired off a protest of its own, claiming Chiles' coaches filed the protest just after the one-minute window. After much back and forth, the judges reversed their decision, stripping Chiles of the bronze and awarding it to Barbosu. It turned out to be a big mess, with Chiles unjustly being dragged on social media, as well as Barbosu and Maneca-Voinea. It was so bad that Chiles decided to go off social media and Barbosu and Maneca-Voinea calling for an end to the bullying. Even Andrade was dismayed, calling the whole thing a mess.

To USA Gymnastics' credit, it had Chiles' back, supporting her during the whole fiasco and filing yet another appeal. As of this writing, Barbosu is technically the bronze medalist even though Chiles hasn't given the original bronze medal back. Many people felt the judging was messed up from the start, and in order to clean up the mess, award Chiles and the two Romanian gymnasts bronze medals. I fall in line with those sentiments. Unfortunately, I don't expect the Olympic judges to do the right thing, simply because it would be an admission they messed up.

Man, seems like sistas can't catch a break!!

## **Black Family's During Jim Crow**

On a hot afternoon in June, some 700 seated attendees of the annual summit of the conservative parents' rights group Moms for Liberty bowed their heads in prayer. The Moms had waited in a security line that spanned two floors of the Philadelphia Marriott to get there, and even during that somber moment, the giddiness in the ballroom was palpable as they geared up for the highlight of the conference: a speech by former President Donald Trump. Up at the dais, wearing a shiny green satin T-shirt that stood out against a row of American flags, Moms for Liberty advisory board member and wife of Rep. Byron Donald (R-Fla.) & Erika Donald offered an invocation. "Lord, you have elevated this organization to do your good work in this country," she said. "We're grateful that the truth is being exposed, that parents are being able to see what's really going on in education in our country." Presumably, the Donalds were referring to the litany of complaints about public schools that had emerged in the conference breakout sessions: how they were corrupting children with lessons about institutional racism, gender diversity, and sex ed. Moms for Liberty launched in January 2021 when frustration with pandemic masking rules had reached a boiling point.

On June 07, 2023, Oddette Yousef, NPR wrote, "Moms for Liberty among conservative groups named 'extremist' by civil rights watchdog. Tiffany Justice, is the co-founder of Moms for Liberty, in Vero Beach, Fla. The Southern Poverty Law Center (SPLC) has added the group to its list of antigovernment extremist entities.

More than two years into a conservative push against teaching about Black history, literature and gender identity in public schools, the Southern Poverty Law Center has concluded that a dozen so-called "parental rights" groups behind the movement are extremist. The civil rights organization particularly focuses on the largest of these, the nonprofit Moms for Liberty, in its annual Year in Hate & Extremism report for 2022, saying that it advances an anti-student inclusion agenda. The SPLC has put it and similar organizations on its list of anti-government extremist entities, drawing comparisons between them and parent groups that attempted to re-segregate public schools during the civil rights movement."

"They really are seeking to undermine public education holistically and to divide communities," said Rachel Carroll Rivas, deputy director for research, reporting and analysis at the SPLC. Carroll Rivas said her organization has received numerous calls from parents and educators who are concerned about the sudden appearance and tactics of Moms for Liberty activists in their schools."

Brothers and sisters, the Audacity of Cong. Bryon Donald, speaking about the positiveness of Black families during the Jim Crow period, while he is married to Erika Donald, a white woman and a member of Moms for Liberty.

I was born in Marion, AR, and I don't know any Black people who thought that the segregation period was a positive period for Black people. This is a typical mantra of the Republican party, trying to demonize the positiveness of the 1960s and the Civil Rights movement. Black Republicans are going to Black areas disseminating lies about the 1960s. Inform relatives and friends of this negativeness. •

### HE HIGH LINE AND OTHER RIVERFRONT IDEAS

In previous articles, I've written about the lack of a viable water-front geared toward recreation and tourism and not solely devoted to industrial usage. Recently, an announcement was made about a proposed Mobile Riverwalk complex. While I am happy that something will be coming, I am disappointed that it only encompasses one block along the waterfront just north of the convention center.

Hardly the riverwalk I envision. Since the warehouses and the land owned by the Port of Mobile seems to be so crucial to their operations, I suggested before that utilizing the space above the warehouses and the air space above the railroad to place a High Line-type riverwalk and park could be a solution.

The High Line, a linear park, located in Manhattan and built above abandoned railroad tracks, has been transformative for that section of the city. It has drawn other development to the area and provides a unique pedestrian area over several blocks. Cities across the country and in other parts of the world are covering freeways, brownfields, industrial sites, and other barriers with parkways, walking trails, and greenspaces that make a city more vibrant and more pedestrian friendly.

Developing a raised promenade above the warehouses and railroad would be a way to serve both industrial and recreational purposes. It would help tie recreational use to Water Street and connect with residential properties such as Meridian at the Port and The Gateway. If done properly it could also connect with St. Louis Street and be an entry point to that area as well.

With the new bridge coming (whenever that may eventually occur), the space underneath the bridge should be developed for recreational and entertainment usage. This could be similar to what Birmingham has done with their City Walk BHAM, underneath the I-59/I-20 freeway in the downtown area. Their complex has colorful lighting at night, a skate park, pickleball court, walking trail, amphitheater, space for food trucks, and other things to draw people to that area. If done in Mobile it could connect with existing riverfront facilities such as the Maritime Museum, cruise terminal, proposed Civic Center development and other riverfront facilities to provide a cohesive riverfront destination.

Let's keep pushing our leaders to develop our riverfront in a meaningful way to fulfill Mobile's river heritage.



Tourism could be a key component for generating revenue. The chart below highlights local southern cities and their annual tourism counts.










## W.E.B. Dubois


This book is essential reading for everyone interested in African-American history and the struggle for civil rights in America. This landmark book is a founding work in the literature of Black Protest. Du Bois played a key role in developing the strategy and program that dominated early 20th century protest by Blacks in America. In this collection of essays, first published together in 1903, he eloquently affirms that it is beneath the dignity of a human being to beg for those rights that belong inherently to all mankind. He also charges that the strategy of accommodation to White supremecy advanced by Booker. T. Washington, then the most influential Black leader in America, would only serve to perpetuate Black oppression. This book was a dramatic event that helped to polarize Black leaders into two groups: the more conservative followers of Washington and the more radical supporters of aggressive protest. &





## James Weldon Johnson


The writer of the lyrics to the Black National Anthem, Lift Every Voice and Sing, James Weldon Johnson was a leader of the NAACP who established himself as a writer during the Harlem Renaissance. This book is a fictional account of a biracial man looking over his life. The story is told in the first-person though the narrator remains unnamed and is never described physically. He tells of being born in the South and growing up in Connecticut where he learns he is a very light skinned biracial boy who some assume is White. As a young man he sets out on his own and travels to different parts of America and later Europe, recounting his experiences in Black and White society along the way.





## Michele Norris

Peabody Award Winning Journalist Michelle Norris offers a transformative dialogue on race and identity in America, unearthed through her decade-long work at the Race Card Project. She asked folks for their thoughts on Race in six words and of course the answers were challenging and complicated with over a half-million respondents. Although just six words can pack a punch, there were stories that were shocking in their depth and candor, spanning the full spectrum of Race, ethnicity, identity, and class. Event the six word responses revealed fear, pain, triumph, and even humor. Some of the respondents submitted backstories, photos, and family heirlooms: a collection much like a scrapbook of American candor you rarely get to see. •





#### THEORY ON HOW TO MAKE A BLACK ATOMIC BOMB IN **NUCLEAR PHYSICS.**

"Critical Mass" is the minimum amount of a given fissile material necessary to achieve a self-sustaining fission chain reaction under stated conditions. In short, and a little over simplified, what is the smallest amount of stuff THAT CAN BLOW UP do you hafta have to BLOW SOMETHING UP? The concept is important in nuclear weapon design. Take into account the properties of the stuff, e.g., its density, shape, enrichment, purity, temperature, and surroundings.


In a loose metaphorical way, we can refer to how to get a social movement going and keep it going. What is the smallest group of actors whose collective behavior is needed to start something?

In social dynamics, critical mass is a sufficient number, i.e., threshold, of adopters of a new idea so that the rate of adoption becomes selfsustaining and creates further growth...a chain reaction. Within social sciences, critical mass has its roots in sociology and is often used to explain the conditions under which reciprocal behavior is started within collective groups, and how it becomes self-sustaining. Critical mass is also influenced by qualitative properties such as reputation, interests, commitments, capabilities, goals, consensuses, and decisions, all of which are crucial in determining whether reciprocal behavior can be started to achieve influence.

Herbert A. Simon's essay, "Bandwagon and underdog effects and the possibility of election predictions", published in 1954 in Public Opinion Quarterly, has been cited as a predecessor to the concept we now know as Social Critical Mass. Social critical mass and the theories behind it help us to understand aspects of humans as they act and interact in a larger social setting. Certain theories, such as Mancur Olson's Logic of Collective Action or Garrett Hardin's Tragedy of the Commons, work to help us understand why humans do or adopt certain things which are beneficial to them, or, more importantly, why they do not. Much of this reasoning has to do with individual interests trumping that which is best for the collective whole, which may not be obvious at the time.

Black "Collective Action" is Black folk in "critical mass" and that small segment of a Black Collective that does the work or action required to BLOW THINGS UP!!❖


























Britannica stated, "Kwame Nkrumah (born September 1909, Nkroful, Gold Coast [now Ghana]—died April 27, 1972, Bucharest, Romania) was a Ghanaian nationalist leader who led the Gold Coast's drive for independence from Britain and presided over its emergence as the new nation of Ghana.

Kwame Nkrumah's father was a goldsmith and his mother a retail trader. He was baptized as a Roman Catholic. Meanwhile,in the Gold Coast, J.B. Danquah had formed the United Gold Coast Convention (UGCC) to work for self-government. Nkrumah as a general secretary, he addressed meetings throughout the Gold Coast and began to create a mass base for the new movement. When a split developed between the middle-class leaders of the UGCC and the more radical supporters of Nkrumah, he formed in June 1949 the new Convention People's Party (CPP), a mass-based party that was committed to a program of immediate self-government.

In the ensuing crisis, services throughout the country were disrupted, and Nkrumah was again arrested and sentenced to one year's imprisonment. But the Gold Coast's first general election (February 08, 1951) demonstrated the support the CPP had already won. Elected to Parliament, Nkrumah was released from prison to become leader of government business and, in 1952, the prime minister of the Gold Coast.

When the Gold Coast and the British Togoland trust territory became an independent state within the British Commonwealth—as Ghana—in March 1957, Nkrumah became the new nation's first prime minister. By a plebiscite of 1960 Ghana became a republic and Nkrumah became its president, with wide legislative and executive powers under a new constitution. Nkrumah then concentrated his attention on campaigning for the political unity of Black Africa, and he began to lose touch with realities in Ghana.

On February 24, 1966, while Nkrumah was visiting Beijing, the army and police in Ghana seized power. Returning to West Africa, Nkrumah found asylum in Guinea, where he spent the remainder of his life. He died of cancer in Bucharest in 1972."

#### Take Precautions to Avoid the Risk Of Rabies Infection

"Mobile County has seen an increase in animal bites over the past couple of months," said Dr. Kevin Michaels, Health Office for Mobile County. "Rabies prevention is multifaceted. It involves people taking precautions with wildlife, making sure that their pets are current on rabies vaccinations, and always reporting an animal bite or other exposures to their medical provider and ADPH.

"It is very common for domestic animals and pets to have contact with a wild rabid animal. State law requires that dogs, cats, and ferrets 12 weeks of age and older be current with rabies vaccination."

World Rabies Day is September 28. Spread the message that Rabies prevention Starts with You. Responsible pet ownership begins with vaccinations. Rabies vaccines are also available for horsesand other livestock. Vaccinating animals reduces the risk of rabies infection should exposure occur. Thus, vaccinations protect animals, as well as their owners and caretakers. Mobile County Health Department sponsors vaccination clinics on weekends for dogs, cats, and ferrets . In addition to vaccination, area residents are advised to take the following precautions to avoid possible exposures to rabies:

- · Do not handle bats.
- Do not allow pets to run loose, confine within a fenced-in area or with a leash.
- Do not leave uneaten pet food or scraps near your residence.
- Do not illegally feed or keep wildlife as pets.
- Do not go near wildlife or domestic animals that are acting in a strange or unusual manner.
- · Caution children not to go near any stray or wild animal, regardless of its behavior.


## THE CHASTANG CHRONICLES: The Old Zeno Chastang House


The house at Chastang Landing was built around 1830. It was a one-story, log-framed cottage with a dogtrot breezeway, a wood shingled roof, and functional shutters. The structure is long gone. The descendants of its inhabitants live elsewhere. The land where it sat is now owned by the Meaher family and devoid of any visual evidence of the house. But there is this photograph taken by E.W. Russell in 1937. Additional details regarding this house are speculative. However, there are two useful clues. The Works Progress Administration (WPA) worker, E. Walter. Burkhardt, an Auburn, Alabama architect with the Historical American Buildings Survey (HABS) calls it the (Old) Zeno Chastang House. And he declares it to have been built approximately 1830. In 1830, there was only one adult who went by the name Zeno Chastang in Mobile County. And that was Pierre Zenon Chastang, son of Dr. John and Louison.


I first encountered this photo about fifteen years ago while stuck at home, itching to research and unable to get to the library. I downloaded it along with the additional images and studied them meticulously. all but trying to dive into the frame, desperately wanting to touch the roughhewn wood and see the handmade shingles up close. I also wondered what was under the house. Houses on piers always have stuff under them. As I traced each board and fence paling along the front of the house, I suddenly noticed a face. To the right of the breezeway entrance, an old man sits in a chair on his gated front porch, looking away from the camera. He is watching and waiting. It is not Old Zeno. Nor is it his son, or grandson of the same name. They all died before the photo was taken. After fifteen years, I have yet to identify him. There are four supplemental photos of the back, side, and an up-close look at the siding. In these, there are four women of varying ages and a toddler. I suspect that this is the last family to inhabit this home. And, that the man peering off the porch is either Pierre Zeno Chestang, the great grandson or his brother-in-law and cousin, William Chastang. Pierre never married and lived with his sister Delores who was married to William. Whoever he is, it is as if he is prognosticating the unfortunate future of his family home.

Back in July, the Mobile River Bridge and Bayway Project got a big boost when Alabama Governor Kay Ivey announced that the U.S. Department of Transportation (USDOT) awarded a \$550 million discretionary grant for the project from the Bridge Investment Program. The grant is believed to be one of the largest federal grants ever received for an Alabama project and is the second largest in the program's history. It marks a significant milestone in the decades-long project to build a new Interstate Bridge and the Eastern Shore of Mobile County. And, it is sorely needed. Imagine driving east on Government Street toward Baldwin County any afternoon and having to deal with backed up traffic that can potentially stretch up to three miles. And the Bayway itself is no cakewalk, especially with 70,000 vehicles using it daily.

"It is a great day in Alabama," Ivey said. "This federal funding will be a game-changer, not just for Mobile and Baldwin Counties, but for our entire state and region. This is exactly how our infrastructure dollars should be spent, and I thank the federal government for their recognition of and support for this critical project."

#### FOUR INTERCONNECTED COMPONENTS COMPOSE THE ESTIMATED \$3 BILLION PROJECT:

- Mobile River Bridge: The bridge will add an alternate route across the Mobile River in addition to the I-10 George Wallace Tunnel (Wallace Tunnel), currently I-10's only route. The project will construct a new six-lane, state-of-the-art cable-stayed bridge with a minimum of 215 feet of Air Draft Clearance (ADC) across the Mobile River channel.
- Bayway: The Bayway component of the project will replace the existing four-lane I-10 Bayway bridges with six lanes, built above the 100-year storm maximum wave height.
- Interchanges: Seven interchanges along I-10 will be rebuilt, modified, or rehabilitated as part of the project Broad Street, Virginia Street, Texas Street, Canal/Water Streets, East Tunnel Portal (US 90/98), Midbay (US 90/98), and the Eastern Shore (US 90/98 in Daphne) to improve the geometrics and local connections to US 90 and US 98, downtown Mobile including

- the Convention Center and Civic Center, the Port of Mobile, and the new Mobile International Airport.
- Other Enhancements: A new intelligent transportation system (ITS), all electronic tolling facilities, and other enhancements will be included to improve traffic safety and reliability.

#### THE PROJECT IS DESIGNED TO:

- Increase capacity and traffic flow to alleviate congestion and to reduce greenhouse gas emissions.
- · Reduce roadway crashes.
- Provide a direct interstate route for the transport of hazardous material away from the central business district and disadvantaged communities.
- Improve resiliency and reduce susceptibility to sea level rise and storm surges.
- Minimize adverse impacts on the maritime industries.
- Reconnect communities by minimizing the diversion of traffic to local street networks, including disadvantaged communities and Areas of Persistent Poverty that have been impacted by past transportation projects.

Amid all of this ballyhoo, there was one interesting note: Congressman Jerry Carl and Senator Katie Britt were also present when the governor made her announcement, and both thanked the Department of Transportation for awarding the grant. But here's the kicker; both were against the Bridge Investment Program; yet they were singing praises about the project. Britt was not even a senator when the Bridge Investment Program passed in 2021, but she said she would have been a firm "no" if she had. In fact, she said she would've still been against the program, It's also interesting to note that only one Alabama federal lawmaker — Democratic Rep. Terri Sewell — voted for it.

Makes you wonder, doesn't it? What if the whole bill had failed? Then what? It would've taken even longer to get funding for the bridge, if at all. Then, there would've still been empty rhetoric about having to do something about Bayway traffic \*

Perhaps Kamala Harris has comprehended the perversity of this struggle and that in the struggle lies joy-- those are also the words of Maya Angelou.



At 6-feet-2 and with a booming but calming baritone voice, his mere presence commands attention when he walks in a room. Norvell Glover," he said about the legendary retired pastor, who served Mt. Calvary Baptist Church in Prichard for almost 50 years. Williams and his wife Theresa have been married for 40 years, and said his love for her helped him overcome the imminent danger he appeared to be in when he asked her father if he could marry her. "He was changing a tire and had this tire iron in his hand when I approached him," said Williams with a laugh. "Her father said, 'Well, now, you'd have to ask her... wouldn't you?"

From his early years he had a passionate love for God and throughout his life he has always found a way to serve God and His kingdom. He draws upon his intuition to help others in areas within the church and beyond. His academic achievements began with matriculation at Auburn University, where he majored in Business Administration. He went on to earn his Master's in Business Administration (MBA) from Troy University. Today at the age of 41, he is a District Manager for the Social Security Administration where he leads a staff of diverse employees. God has blessed him in ways with one of his greatest gifts being the strength to serve those in need. This is the backdrop that Pastor Benson uses as he dedicates his life to helping others.
