This event is open to crafters, direct sales vendors, bakers, antique vendors & more. We reserve the right to limit the quantity of each type of vendor to offer shoppers a variety of quality vendors. All spaces will be filled on a first-come-first-serve basis and all invoices are due within 7 days unless prior arrangements are made.

Setup hours for indoor spaces will be Friday, May 17, 2024, from 1 - 6 pm and from 8 am – 10 am the morning of the event on May 18, 2024. Outdoor spaces will only be allowed to set up from 8:00 am – 10:00 am the day of the event. Most indoor booths will have electricity but please indicate whether you need it on the application below so that we can create the best layout possible.
