Southgate Crossing is one of the largest Amish-built peg & beam structures in the USA. This beautiful building will be a stunning backdrop for the work of dozens of artists, fine crafters, and antique dealers. Its expansive parking lot and many amenities will make it convenient for shoppers and vendors alike. This two-day event includes Friday and Saturday for one fee. The booth fee for a 10' x 10' booth is \$130, 7'x10' is \$120 and an 8' table space is \$90. We do NOT provide tables or any structures. The event will be held on the second floor of the building and we're thrilled to have a large, modern freight/passenger elevator at our disposal at this venue.

THIS IS A JURIED SHOW which means applications will be reviewed by a panel of judges, and, upon approval of your application, a payment request will be sent via email. Direct Sales vendors and mass-produced products will NOT be accepted for this event. We are looking for fine handmade and vintage products only. *Food vendors must provide the proper permits and licensing required by the Elkhart County Health Department.*

We will be accepting 52 Participants for this year's event.

Setup hours will be Thursday, Nov. 21st, from noon - 7:30 pm and from 10 am - 4 pm on Friday, Nov 22. Most booths will have electricity, but please indicate whether you need it in the application below, so that we can create the best layout possible.
