SUMMARY DESCRIPTION OF BUSINESS

What is our Business?

QIMC is a mineral exploration and development company focused on exploring, developing and acquiring industrial mineral resources in Québec, Canada. The Issuer is currently focused on its wholly owned flagship Charlevoix silica project near St. Urbane, Québec, Canada, and has a portfolio of two other silica properties, and three properties prospective for hydrogen and helium in Québec.

Recent Developments

The following is a brief summary of the recent developments involving or affecting the Issuer:

- On May 31, 2023, the Issuer announced a significant milestone as its pilot plant operations crew
 has mobilized to the site and commenced testing at the Issuer's highly anticipated flagship
 Charlevoix Silica Project. The crew is now initiating the processing of this material through the
 pilot plant with the goal of delivering the required tonnage to HPQ Silicon Inc.
- On June 29, 2023, the Issuer announced that the first phase of 2023 pilot processing for the Charlevoix Silica Project is underway and expected to be completed in early July 2023.
- On July 26, 2023, the Issuer announced that work on the Issuers 100% owned Ville Marie property (the "Property") has commenced following up on recent field work, sampling at surface and site visits.
- On August 29, 2023, the Issuer announced that new zones of highly pure quartzite have been discovered on the Issuer's wholly owned Charlevoix Silica Project. Seven (7) samples were delivered to ALS Global's lab in Val d'Or, Québec where they underwent purity analysis. These samples were selected from various locations on the outcrops and averaged over 98% SiO₂ ranging from 97% to over 99%.
- On September 7, 2023, the Issuer announced the acquisition of the River Valley Silica Property located in the Sudbury mining division, near River Valley, Ontario, Canada.
- On September 14, 2023, the Issuer announced the mobilization of a crew to the River Valley Silica Project.
- On September 20, 2023, the Issuer announced the delivery of high purity quartz samples were delivered to HPQ Silicon Inc.
- On October 4, 2023, the Issuer announced that it has received a permit from the Québec Ministère des Forêts, de la Faune et des Parcs (Ministry of Forests, Wildlife, and Parks to further expand work on its high grade on surface Charlevoix Silica Project.
- On October 11, 2023, the Issuer announced that it has procured OptiSim Mining Solutions ("OptiSim") of Sudbury, Ontario. OptiSim's mandate is to assist in advancing the recently acquired River Valley Silica Project as the Company progresses towards high-grade silica production.

- On October 24, 2023, the Issuer provided an update on its ongoing silica projects including a site
 visit with the engineering team from OptiSim Mining Solutions, of Sudbury, Ontario for the
 purpose of preliminary quarry design, engineering, and permitting.
- On November 15, 2023, the Issuer announced that new zones of visually pure quartzite have been discovered on the Company's wholly owned Charlevoix Silica Project.
- On November 28, 2023, the Issuer announced that it has entered into a Right of First Refusal agreement with HPQ Silicon Inc. ("HPQ") which allows HPQ the Right of First Refusal to purchase the first 10,000 tons of high-grade silica material extracted from a QIMC silica project.
- On December 12, 2023, the Issuer announced that high grade silica purity results of over 99.5% have been proven at the Issuer's wholly owned River Valley Silica Project.
- On December 20, 2023, the Issuer announced that HPQ Silicon Inc. ("HPQ") has placed an order
 for high purity quartz material from the Issuer. From the Issuer's current stockpile of high purity
 samples, QIMC will provide HPQ with approximately half a tonne of high purity quartz material.
 The material will be used by HPQ in their production of engineered SiOx materials for battery
 anodes and fumed silica via HPQ's proprietary Fumed Silica Reactor
- On January 10, 2024, the Issuer provided an update on the Roncevaux Silica Property stating that samples were collected by means of existing trenches found on the property. The quartz vein is estimated to potentially be over 300m long with the width being unknown but likely 10's of metres wide (as suggested by historical work and reports).
- On March 1, 2024, the Issuer announced that Patrick Levasseur, a director of the Company, has been appointed Interim Chief Executive Officer. This appointment follows the decision from Raymond Wladichuk to resign his position as Chief Executive Officer, effective March 1, 2024.
- On April 24, 2024, the Issuer presented a strategic development of its St. Lawrence Hydrogen Project in Quebec. QIMC's areas of interest include exploration for white hydrogen and helium (from natural sources), commercialization of affordable hydroelectric technologies and local biomethane production and announced the appointment of John Karagiannidis as its new President and CEO.

p) (i) Neither the Investor, nor any beneficial purchaser, if any, nor any Subscriber Beneficial Owner (as defined below) has been subject to or experienced any event or circumstance described in Rule 506(d)(1)(i) through (viii) of Regulation D ("Regulation D") under the U.S. Securities Act, (ii) neither the Investor, nor any beneficial purchaser, if any, nor any Subscriber Beneficial Owner has been subject to any order, judgment, or decree of any court of competent jurisdiction temporarily, preliminary or permanently enjoining such person for failure to comply with Rule 503 of Regulation D, and (iii) if at any time the Investor, any beneficial purchaser, if any, or any Subscriber Beneficial Owner is deemed, directly or indirectly, to be the beneficial owner of ten percent (10%) or more of the Issuer's outstanding voting equity securities as calculated under Rule 13d-3 under the United States Securities Exchange Act of 1934, as amended, the Investor or the beneficial purchaser (as applicable) will immediately notify the Issuer if the Investor, any beneficial purchaser, or a Subscriber Beneficial Owner becomes subject to or experiences any of the events or circumstances listed in Rule 506(d)(1)(i) through (viii) of Regulation D (or any successor thereto or expansion thereof) or becomes subject to any order, judgment, or decree of any court of competent jurisdiction temporarily, preliminary or permanently enjoining such person for failure to comply with Rule 503 of Regulation D. The Investor has exercised, and will exercise, reasonable care to determine whether any beneficial purchaser and Subscriber Beneficial Owner is subject to any of the events or circumstances described in this paragraph. For these purposes, "Subscriber Beneficial Owner" means any person who through the Investor or the beneficial purchaser (if applicable) would be deemed, directly or indirectly, to be the beneficial owner of ten percent (10%) or more of the Issuer's outstanding voting equity securities as calculated under Rule 13d-3 under the United States Securities Exchange Act of 1934, as amended.
