Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all exercises safely.

St Louis Collie Club may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

Since bitches in season are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a veterinarian of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.

The club will refund all but \$10.00 of the entry fee per trial for injured dogs or handlers. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's or doctor's letter must be provided within one week of the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Exhibitors are responsible for being ready for judging when called to the ring. The judge need not wait for any dog holding up a class. St Louis Collie Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must complete back of form.

All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

Checks for canceled entries will be shredded — no check will be returned.

All dogs must be on leash or crated at all times except when in the ring. Warm-up must be done on lead.

Dogs under 6 months of age are not permitted on the show grounds of AKC events.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Exhibitors are responsible for cleaning up after their dog(s) at the show site and at all hotels, motels, and campgrounds where they are staying while competing in these trials. Dogs are to be exercised in specifically marked areas only.

St Louis Collie Club, their Board, Members, and Dog Sports at Kim's and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

DOGS NOT OWNED OR HANDLED BY EXHIBITORS ARE NOT ALLOWED IN THE BUILDING AT THESE TRIALS.

The building is available for **set up on Thursday, November 11 from 2:30 pm to 7 pm**.

Trial hours are 7:00 am to 30 minutes after the trial is completed.

No advertising flyers may be placed without permission of SLCC and Dog Sports at Kim's.

No strollers or playpens allowed in building.

Dogs may not be left in closed vehicles without proper ventilation. If dogs are found in distress, St Louis Collie Club will take appropriate action.

No dogs may be left in the facility overnight.

No professional photography or videography without permission.

No gasoline or diesel generators.

No alcoholic beverages allowed at event site.

NO SMOKING is allowed in the building or within 20' of the entrances

Transfers

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial.

Jump Height Order

Rally classes with jumps will be run short-to-tall in all trials.

Obedience classes with jumps will be run as follows.

- Saturday will run short-to-tall starting with 4" jump height except for Utility B/Preferred Utility which will start with 20".
- Sunday will run short-to-tall starting with 20" jump height except for Utility B/Preferred Utility which will start with 4".

Every effort will be made to accommodate handlers with multiple dogs in the same class.

Class Running Order

Rally Trials 1 & 2 will run concurrently as follows.

Trial 1 Master - Trial 2 Master - Trial 1 Excellent - Trial 2 Excellent - Trial 1 Advanced - Trial 2 Advanced - Trial 1 Intermediate - Trial 2 Intermediate - Trial 1 Novice - Trial 2 Novice

NO CONCESSION OR HOSPITALITY WILL BE PROVIDED. Please bring your own food and drinks. Please go outside the building to eat or drink so that you can wear your mask at all times while inside the building.

Obedience Trials 1 & 2 will run concurrently. The final schedule will not be set until entries close and individual class counts are available. Open A/B/Preferred and Utility A/B/Preferred will be scheduled in the morning and Novice A/B/Preferred and optional titling classes will be scheduled in the afternoon **if possible, based on the entry**.

PLEASE REMEMBER TO WASH YOUR HANDS FREQUENTLY AND PLEASE PRACTICE PHYSICAL DISTANCING.

People who are not feeling well and concerned about the possibility of having COVID-19

will be given a refund of all but \$10.00 for that day. No doctor's note is required. You must contact the Trial Secretary before the start of the trial. We will automatically cancel the following days runs. You will receive that same refund for each of the remaining days to get over being sick. **PLEASE STAY HOME AND KEEP EVERYONE SAFE.** People who are visibly sick and attend the trial may be asked to leave with **NO REFUND**.

The Event Committee has the right to amend the premium as needed to adhere to any changing COVID-19 guidelines or conditions. In the event we are unable to hold this trial due to changing state or local COVID-19 guidelines and need to cancel after the trial has closed, we will shred all checks.

SLCC is attempting to make this trial safe and will comply with state, local and CDC guidelines; however, your safety and good health cannot be guaranteed. Your entry into this trial indicates you are in agreement to the rules put forth for this trial and that you cannot hold SLCC responsible should you become ill following your participation in this trial.
