Two seats open on PA Superior Court in 2019, one Democratic judge up for retention



Two seats are open on the Pennsylvania Superior Court, which hears civil, family and criminal appeals. However, three candidates are seeking the Democratic nomination.

During the Primary Election on May 21, voters will only be able to only vote for two of the four candidates. The candidates still vying for the open seats include: Amanda Green-Hawkins, Beth Tarasi, Dan McCaffery.

In addition to the two open seats, voters will decide whether or not to retain three sitting judges whose current terms expire in 2020. One of the three judges up for retention, which requires a simple "yes" or "no" vote, is a Democrat: Anne Lazarus.



Philadelphia Court of Common Pleas Judge Daniel D. McCaffery joined the Army at age 18 and was chosen to attend the prestigious United States Military Academy at West Point Prep School. He later attended Temple University and Temple University Law School on a veteran's scholarship.

In 1991, McCaffery became an Assistant District Attorney in the Philadelphia District Attorney's Office. Superior Court Judge Anne Lazarus was elected to the court in 2009, with her term beginning in January 2010. Her first term will expire in January 2020, so she will also be on the ballot for a retention vote, where voters simply vote yes or no to keeping a judge on the court.

Lazarus received her B.A. degree in psychology from the State University of New York at Stony Brook and her J.D. and LL.M. from the Temple University Beasley School of Law.

Prior to becoming a PA Superior Court judge, Lazarus served on the Philadelphia County Court of Common Pleas from 1991 to 2010. She served as legal counsel to the Philadelphia Orphans' Court from 1980 to 1991.

Judge Lazarus has received various awards, including the Sandra Day O'Connor Award from the Philadelphia Bar Association, Legal Service for the Public Committee Judge's Award from the Pennsylvania Bar Association, Benjamin F. Levy Community Service Award from the Brandeis Law Society, and Bernard White Community Service Award from PLAN of PA.
