

ONLINE PRIVACY POLICY AGREEMENT

Use of Information Collected

Sirrom Development LLC does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Sirrom Development LLC may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from www.sirromdevelopment.com

- as necessary to maintain, safeguard and preserve all the rights and property of Sirrom Development LLC.

Notice to European Union Users

Security

The company also uses Secure Socket Layer (SSL) for authentication and private communications to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of credit card and personal information. In addition, Sirrom Development LLC is a licensee of TRUSTe. The website is also secured by VeriSign.
