MINUTES OF THE BERKELEY PARK DISTRICT REGULAR MEETING ON WEDNESDAY, APRIL 5, 2017

The regular meeting of the Board of Commissioners of the Berkeley Park District was held on Wednesday, April 5, 2017 at the Lind Park Building.

The meeting was called to order at 7:34 p.m.

A motion was made by Commissioner Ditchfield and seconded by Commissioner Nemec to approve the minutes from the 2017 Budget and Appropriation Hearing.

Jerry Perez said he would check and let Pete know, and he questioned about lights under the gazebo. Pete said he would run the rope lights again.
