They are requesting permission to cut down or trim up the trees that are located southwest of the gazebo, so that it would give more viewing area for the 4 concerts in the park. Commissioners will discuss the situation and Pete will contact them this evening with an answer. The village is also requesting a key to the Prairie Path Board so they may place a concert flyer in it. Key need to be found, and then they will be given one.
