### **Craft Guild 10/30/18**

Meeting was called to order at 6PM with Pledge of Allegiance led by President Shirley Williams.

No minutes for September were approved.

**Betty Weibert** - Treasurer's report – We have \$14,333.49. Betty has already left for Utah. Winterfaire according to the section of the report identified as Winterfaire shows a loss of \$77.54. We have not received our \$500 deposit back from the fairgrounds yet.

Trudi Gumpff whose husband worked the lobby and collected admission fees reported that they collected \$1,580 (net of starting dollars in till) and \$580 on Sunday, totaling \$2,160. This does not match the deposit for admissions of \$1,627.80. We were unable to figure out the discrepancy without Betty or the backup data.

There was a motion from Pam Lehman, to have Jim Brower and Lori Murray will look at the back up data that Betty gave Shirley. The motion was seconded and passed. At the time of the meeting, it was too early for a bank statement, so this research of the backup data was tabled until after it is received. Jim was also going to contact Betty for more information.

Lori Murray suggested that maybe we have someone outside (that we pay for) to do all of the books except write the checks. This person should know non-profit and will pay all of the taxes. Lori will talk with someone she knows to see if this person is interested.

**Jeannie Norman** will be on sabbatical next year, currently is planning on paying dues for next year otherwise basically gone and will not be doing Winterfaire.

**Committee reports** – most were not needed and therefore not reported on
