AZD13 Code of Conduct

- 1. No Director, Manager/Coach, Umpire, Spectator, or Player shall at any time lay a hand upon, shove, strike, verbally intimidate/harass or threaten an Umpire, Player, Spectator, Manager/Coach or AZD13 Board Member. AZD13 Board Members are to immediately suspend such person(s) from further play or observance of play. A written report must be submitted to AZD13 (within 24 hours of the incident). Such persons shall remain suspended until his/her case has been resolved and a final report in writing has been filed with the AZD13 Board.
- 2. No Manager/Coach, Spectator, Umpire or Player shall refuse to abide by an AZD13 Director's decision. Directors shall immediately suspend such person(s) from further play or observance of play and a written report must be submitted to AZD13 (within 24 hours of the incident). Such persons shall remain suspended until his/her case has been resolved and a final report in writing has been filed with the AZD13 Board.
- 3. No Player shall be guilty of using unnecessary rough tactics in the play of the game against the body or person of an opposing player. A written report must be submitted to AZD13 (within 24 hours of the incident). Such persons shall be considered suspended until his/her case has been resolved and a final report in writing has been filed and determination made by AZD13 Board.
- 4. No Director, Manager/Coach/Umpire or Player shall appear on the playing field at any time in an intoxicated condition. A written report must be submitted to AZD13 (within 24 hours of the incident). Such persons shall be considered suspended until his/her case has been resolved and a final report in writing submitted to AZD13 Board of Directors.
- 5. No Spectator shall appear on the field (exception: when a critical injury occurs, time is called, and it is deemed advisable to call for the assistance of a Spectator). It is the Manager's responsibility to supervise the Team's parents, fan's and spectators. Any violation may lead to ejection and/or suspension of the individual(s).
- 6. No Director, Manager/Coach, Umpire, Player, or Spectator shall use obscene language or gestures. It is the Manager's responsibility to ensure that Coaches and Players and their spectators shall refrain from using obscenities and obscene gestures. Any violation may lead to ejection and/or suspension of the individual(s).
- 7. AZD13 staff shall not exercise authority or title while Managing or Coaching a game in which his team is participating unless the action is necessary. A violation of this section will be dealt with more harshly than with any other offense.
- 8. AZD13, Manager/Coach or Member of the League shall use social media in any form to post any remark, picture, video, etc., that is derogatory to the wellbeing of AZD13 or their respective league. Any violation will result in disciplinary action up to and including removal from the League.

Penalties may include, but are not limited to:

- Written warning
- Game suspension
- Multiple game suspension
- Season suspension
- Removal from the league
