

Dr. John Morton-

"I never stop studying. There's always lots to learn. When you stop learning, that's about the end of you." Dr. John Morton-Finney was an accomplished lawyer, civil rights activist, and academic who accumulated eleven degrees throughout his life. Born in Kentucky on June 25, 1889, Morton-Finney was one of seven children. His father, a former slave, and his mother, a free woman, taught their children the value of education. Though Morton-Finney was only 14 when his mother passed away, he shared her love for education and aspired to serve his country.

Before he began his academic pursuits, Morton-Finney joined the 24th Infantry Regiment of the United States Army. Morton-Finney fought in the Philippines. After being honorably discharged from the army in 1914, he earned his first degree in 1916 from Lincoln College in Jefferson City, Missouri, where he also met and fell in love with Pauline Ray. The two married, relocated to Indianapolis, Indiana, and together had one child, Gloria Ann Morton-Finney. To support his family, Morton-Finney taught at Crispus Attucks High School. Eventually, Morton-Finney assumed the role of dean of foreign languages at the high school and taught African American youth the importance of quality education for 47 years.

While working full-time, Morton-Finney continued his education. He successfully completed all of the degree requirements to receive his Ph.D. in Education at Indiana University, but he decided to turn down the degree. Afterward, he chose law and earned five degrees in the area, including his first law degree from Lincoln College in 1935 and his J.D. from Indiana University in 1946 at the age of 57. He then embarked upon a lucrative career. After passing the Indiana bar in 1935, he entered private practice and eventually was allowed to argue cases before the Indiana Supreme Court. He also continued his education, earning his last academic degree from Butler University at the age of 75. In 1972 John Morton-Finney, now 83, was admitted to practice law before the United States Supreme Court. At age 96, he earned his Doctor of Letters degree through Lincoln College (now University). He was inducted into the National Bar Association Hall of Fame in 1991 before retiring in 1996 at the age of 107, making him one of the longest-practicing attorneys in United States history.

#### The Four Chaplains Story


The 368-foot steamship Dorchester, operated by the War Shipping Administration, was part of a convoy that left New York in January 1943 bound for the Army Command Base at Narsarsuaq in southern Greenland.

To sail from Newfoundland to Greenland, the ship would have to navigate icy seas and pass through waters infested with German U-boats.

After midnight on Feb. 3, 1943, the Dorchester was torpedoed by a U-boat in the Labrador Sea off Greenland and went down in 20 minutes, according to official records.

Of the 904 aboard, 675 drowned or died of hypothermia in the frigid waters. It was believed to be the worst single death toll for a U.S. convoy during WWII.

The Dorchester's loss is remembered most for the sacrifice of the "Four Chaplains" -- two Protestants, a rabbi and a Catholic priest. They were all <u>Army</u> first lieutenants who went down with the ship.





#### History

Just prior to the onset of America's involvement in World War II, President Franklin D. Roosevelt sought to unite several service associations into one organization to lift the morale of our military and nourish support on the home front. Those entities — the Salvation Army, Young Men's Christian Association, Young Women's Christian Association, National Catholic Community Services, National Travelers Aid Association and the National Jewish Welfare Board - became the United Service Organizations or, the USO.

Today, the USO has continued to support our nation's military and their families for over seven decades as they defend our country and its freedoms. By providing support to our servicemen and women as they perform their most challenging duties around the world, our credo is to be always by their side.

The reach of the USO's more than 250 centers extends to countries on every continent, operated by thousands of staff and volunteers whose goals are to match our service members' vigilance and provide best-in-class service to those who sacrifice so much for America.
