MILITARY ORDER OF PURPLE HEART DAY AUGUST 7

The Purple Heart Medal is awarded to members of the armed forces of the U.S. who are wounded by an instrument of war in the hands of the enemy and, posthumously, to the next of kin in the name of those who are killed in action or die of wounds received in action. It is specifically a combat decoration.

The organization now called the "Military Order of the Purple Heart" was established in 1932 to protect and serve the interests of all who have received the decoration. Made up solely of Purple Heart recipients, it is the only veterans service organization made up entirely of "combat" veterans.

Funds for welfare, rehabilitation, and/or service work conducted by the organization come from collecting used household items, running thrift stores, accepting automobile donations, and receiving monetary contributions. If you would like to support our many programs -

The Purple Heart Viola

At the community level, there is an annual distribution of the official flower, the Purple Heart Viola. These violas are assembled by disabled and needy veterans, many of whom receive little or no compensation from other sources. Therefore, your contribution to our programs is two-fold. It helps veterans participating in these efforts and also allows the organization to undertake numerous initiatives on behalf of hospitalized and needy veterans and their families.

Family members of Purple Heart recipients can join the Auxiliary of the Military Order of the Purple Heart, which also plays an important role both nationally and locally in veterans' hospitals.

Congress established the Military Order of the Purple Heart for combat-wounded veterans. The organization consists of military men and women who received the Purple Heart Medal for wounds endured in combat or due to acts of international terrorism.

From the day that will forever live in infamy to the terror attacks on our soil, our members have answered our country's call. Now, as combat-wounded veterans, we proudly continue to serve our country by helping America's active-duty service members, veterans, their families, and those who have borne the burden of battle.

Mike is the Director of Mobile County Emergency Management with over 23 years of experience. He coordinates with county and city resources to deploy disaster personnel and equipment during incidents and emergencies affecting Mobile County's 415,000 citizens. During emergencies, he staffs and activates the Emergency Operations Center (EOC), utilizing local and state resources. He also has ten years of experience in private industry manufacturing.

Mike is a Brigadier General with over 39 years of service in the Alabama Army National Guard as a Logistics Officer. He deployed twice for the Global War on Terror, in 2003 and 2013. He currently commands the 135th Expeditionary Sustainment Command. Previously, he led the 122nd Troop Support Command and the 731st Combat Sustainment Support Battalion. He has completed numerous military courses and graduated from the U.S. Army War College.

Mr. Evans holds a B.S. in Business Management from the University of Mobile and an M.S. in Management from Troy University. He also earned a Master of Strategic Studies from the U.S. Army War College. He is a Certified Emergency Manager (CEM) through the International Association of Emergency Managers and recently served as Region 4 Board President. Additionally, he holds a Master's Level Emergency Manager (MLEM) certification from the Alabama Association of Emergency Managers, where he has served as a committee chair, board member, and twice as President. He has extensive disaster response experience, including 19 presidential declarations, notably for Hurricanes Ivan, Dennis, Katrina, Sally, Zeta, the 2012 Christmas tornadoes, the Deepwater Horizon oil spill, and the COVID-19 pandemic.

The Mobile Bay Area Veterans Commission was established in 1986 to energize the area's Veterans Day Commemoration. The founders included Admiral J. Lloyd "Doc" Abbot, USN (Ret), Admiral Bill Stewart, USCG (Ret), Captain Hal Pierce, USN (Ret), and Lieutenant Colonel Vince Schiavoni, USAF (Ret).

Previous Recipients of the Patriot of the Year Award



1986
Admiral Thomas H. Moorer, USN (Ret.), a native of Alabama and a 1933 graduate of the U.S. Naval Academy, became a naval aviator and held a variety of commands. He served as Chief of Naval Operations and was appointed Chairman of the Joint Chiefs of Staff in 1970, retiring in 1974. He is still active in matters concerning foreign policy and private business.



1987
The late U.S. Representative William F. Nichols served in the Army during World War II, was critically wounded in battle and retired as a captain. After serving successfully in state politics, Mr. Nichols was elected to the U.S. Congress in 1966. His efforts on the House Armed Services Committee earned him the nickname, "Friend of the Serviceman."



1988
U.S. Senator Strom Thurmond served as state senator and circuit judge in South Carolina before serving in the Army in World War II. A decorated combat veteran, Senator Thurmond returned home and was elected governor of South Carolina. He was elected to the U.S. Senate in 1955. He is ranking member of the Senate Judiciary Committee, senior member of both the Armed Services Committee and the Veterans Affairs Committee and a member of the Labor and Human Resource Committee.



1989
U.S. Representative G.V. "Sonny" Montgomery, a retired Major General in the Mississippi National Guard, saw action in the European Theatre during World War II. He served in state politics before being elected to Congress in 1966. As chairman of the House Veterans Affairs Committee, he successfully sponsored the Montgomery G.I. education bill and has served in various capacities investigating POWs and MIAs in Southeast Asia.



1990
Former U.S. Senator and Rear Admiral Jeremiah A. Denton, Jr., USN, (Ret.) graduated from the U.S. Naval Academy in 1946 and became a naval aviator. While flying a combat mission over Vietnam, Senator Denton was shot down and subsequently held as a POW for more than 7 1/2 years. He was elected to the U.S. Senate in 1980 and served as a member of the Judiciary, Labor and Human Resources and Veterans Affairs Committees. He also chaired the Senate subcommittee on Aging, Family and Human Resources.

Veteran of the Year nominations for the 2025 Mobile Bay Area Veteran of the Year (VOY) will be accepted by the Mobile Bay Area Veterans Commission, from August 1 to August 22, 2025. Letter must be postmarked no later than midnight August 22, 2025. The veteran's cell phone number and mailing address must be with the nomination. The Veteran of the Year Committee will meet the following week and will select the VOY.

Award Criteria:

- 1. Must be a resident of the Mobile Bay Area, which includes Mobile and Baldwin Counties of Alabama.**
- 2. Must be a living veteran of one of the six armed forces of the United States, including Reserve and National Guard, or the United States Merchant Marine.**
- 3. Must have demonstrated outstanding patriotism, leadership, and selfless service and, also served as a volunteer in community or civic service.**
- 4. May be awarded for a single act or for continuous service.**
- 5. May not be a previous recipient of the Mobile Bay Veteran of the Year Award.**
- 6. A DD-214 or other proof of service must be submitted with the nomination.**

The award will be presented at the Honors Luncheon on Veterans Day, Tuesday, November 11, 2025.

The nomination will be valid for three years.

EDITORS NOTE

Too many times, I've been told "I didn't know there was a Veterans Cemetery in Spanish Fort"—often after the fact.

Just recently, a local veteran faced unforeseen circumstances that left his family struggling with unanswered questions about veterans' benefits. Thankfully, by God's grace, I connected with another Patriot who also dedicates their life to serving veterans. She met this veteran during her hospital stay. After a few calls to knowledgeable contacts, we were able to assist him and his family.

DID YOU KNOW YOU CAN PRE-REGISTER?

The Alabama State Veterans Memorial Cemetery at Spanish Fort covers more than 120 acres and includes an administration building, maintenance facility, committal shelter, and a memorial walk. Located in Baldwin County, the cemetery was dedicated in December 2012 and began interments in April 2013. It contains a total of 5,000 graves, including ground crypts, traditional graves, columbarium niches, and a scatter garden. The expected lifespan of the cemetery is 100 years.

Pre-registration is available and allows veterans and their spouses to confirm their eligibility for burial at the Alabama State Veterans Memorial Cemetery at Spanish Fort ahead of time.

There is no cost for pre-registration, and it does not require the veteran to be interred at the cemetery. Pre-registration aims to make the process easier for the veteran's next of kin at the time of death. The primary items required for pre-registration are a copy of the veteran's discharge certificate (DD Form 214) and, for married veterans, a copy of their marriage certificate.
