MEETING CALLED TO ORDER: President Nia MacKay called the meeting to order at 11:09 AM.

INVOCATION: 1st VP Blake Lindsay gave the invocation.

SECRETARY: Kathy Frazier, CRS, presented the minutes of the last board meeting, 12/15/22. There were two corrections to these minutes that were brought up: the meeting notes should be moved up into the minutes themselves and the venue for the Bill Melton Humanitarian Award Banquet should be Anderson Hall instead of Yates Hall. A motion was made to accept the minutes as corrected, a second ensued, no dissents, motion passed to approve the minutes. RE: Status Report & Proposal



BACKGROUND

In October 2004, the Oak Cliff Lions' Club (the "Club"), with the authorization of the Dallas Park Board, celebrated its 75th anniversary by installing a bronze statue of a Lion (the "Lion") and burying a time capsule in Founders' Park (the "Park") located at 1400 N. Zang Blvd @ Oakenwald in Dallas 75203. With donations from the Club, Methodist Hospital, and various individuals, a fund was designated by the Club for maintenance of the area of the Park surrounding the Lion.

In June 2019, with the authorization of the Dallas Park Board, a bronze statue of a lioness (the "Lioness") was installed by the Club near the Lion at the Park. Costs were covered by donations from various individuals. The Lioness was named "Carolyn" in memory of the first female president of the Club.

In addition to being a source of enjoyment for the community, the statues have demonstrated the goodwill and community service of the Club, since the plaques installed with the statues show that they were donated by the Club.

We are informed by persons associated with the Park Board and the Friends of Oak Cliff Parks that the existing statues have attracted many visitors at Founders' Park. It has been suggested that the Club add a couple of cub statues to increase the appeal, especially for families with small children.

PROPOSAL

To continue what the Club started in 2004, various individuals have made donations to the Club for the purpose of purchasing two bronze cub statues (the "Cubs") named "Mikey" and "Nia" in memory of past president Mike Lott and in honor of the Club's first "New American" president. Enough funds have been donated to purchase both bronze cub statues and to continue to maintain the landscaping surrounding the statues. The Committee recommends that the Board accept these donations for the designated purposes. If the Board approves, the cub statues will be placed next to their "parents" and they can be available for an installation ceremony this spring.

Current funds (as of January 31, 2022) available in the OCLC Foundation Account: \$28,384.00. Of this amount, \$10,000 is required by the Foundation Bylaws to remain in the account at the end of each year. This gives the committee \$18,384.00 to draw from for funding the 2021-2022 grant requests. The committee is setting aside about \$1,100 to cover the semi-annual District Dues that go to the Texas Lions Camp and about \$1,100.00 to cover our clubs 100% annual support to the District as well. Currently, there are no fundraising events scheduled for the rest of this Lions year. With this in mind, the committee, as a whole, recommends that the legacy organizations – those that have been granted funds over the past 5 years – be contacted directly with a deadline of March 31, 2022 – for them to submit funding requests that will be considered at the April committee meeting. **ACTION**: Sara and Charlie will work on this list and reach out to these organizations no later than Feb. 15th.

Additional concerns were raised about scholarship funding and if the committee needed to set aside any funds to support that funding. **ACTION**: Sara will reach out to scholarship coordinator and administrative secretary for additional details.

3rd quarter requests:

- A) \$625 for Dallas Community Policing Awards.
- B) \$1,125.37 for Friends of Oak Cliff Parks to offset costs for improvements at the OCLC Garden and OC Founders Park in general.
- C) \$1,000 to \$2,500 for One Community USA, an organization that supports community policing services through out Dallas and provides education scholarships.

Motion was made to recommend for items A & B, totaling \$1,750.37, be approved by the Oak Cliff Lions Club Foundation Board. The motion was seconded. All in favor, no nays, no questions. Motion passed.

Request C is tabled until legacy grants requesters could be contacted. Item will be reconsidered at the April committee meeting. **ACTION**: Sara will request additional documentation from groups A & B to comply with the current grant guidelines. Sara will present the recommendations with accompanying paperwork to the OCLC Foundation Board to seek approval of funds distribution.

Oak Cliff Lions Club Foundation Community Grant Guidelines 2021-2022

Our local community grants are awarded through an open application process and provide funding directly from the Oak Cliff Lions Club.

Guidelines

- Local Community grants range from a minimum of \$250 to a maximum of \$5,000.
- Eligible nonprofit organizations must operate on the local level (or be an affiliate/chapter of a larger organization that operates locally) and directly benefit the service area of the Oak Cliff Lions Club.
- The 2021-2022 grant cycle begins July 1, 2021 and the application deadline is April 1, 2022.
- Applications may be submitted at any time during this funding cycle. Please note that applications will only remain active until June 30.
- Organizations may only submit a total number of 1 applications and/or receive 1 grant within an annual grant cycle.
- All organizations applying for a Local Community grant must have a Federal ID Number and must be a 501(c)3 organization.

Eligibility Checklist

Organizations applying must meet one of following criteria:

- An organization holding a current tax-exempt status as a public charity under Section 501(c)(3) of the Internal Revenue Code.
- A recognized government entity: state, county or city agency, including law enforcement or fire departments requesting funds exclusively for public purposes.
- A K-12 public or nonprofit private school, charter school, community/junior college, state/private college or university; or a church or other faith-based organization with a proposed project that benefits the community at large, such as food pantries, soup kitchens and clothing closets.
- Non-charities, including organizations recognized as 501(c)(4), such as homeowner associations, civic leagues, or volunteer fire companies, are excluded

Selection Process

- A volunteer committee of Oak Cliff Lions Club Civic Benefits members will review the application and make initial funding recommendations to the Oak Cliff Lions Club Foundation Board on all submitted requests.
- The Oak Cliff Lions Club will set the frequency and process in which application determinations are made.
- The Oak Cliff Lions Club Foundation Board reserves the right to adjust the amount awarded to each organization without prior notice.
- Applicants will be notified of any decision via e-mail. All funding decisions are final.

- If an application is approved, grant checks will be mailed directly to the recipient's address listed in the application for the organization. Please allow four to six weeks for delivery.
- In the event of being awarded a grant, organizations should contact the Oak Cliff Lions Club administrative secretary in order to schedule a formal recognition event.

All grant applications are made subject to review of the organization's reputation and activities and its agreement to comply with applicable terms and conditions. Submission of an application does not guarantee funding. Funding exclusions include organizations that deny service, membership or other involvement on the basis of race, religion, color, sex, sexual orientation, gender identity, age, national origin, ancestry, citizenship, veteran, or disability status.
