# The Details

**Complimentary Consultation:** At this appointment we will discuss your hair needs, schedule your practice run and reserve your desired day. Our contract and cancellation policies will be reviewed and a credit card deposit for all services will be collected. Dates will not be booked until we have a signed contract and deposit.

**Trial Run for the Bride:** A personalized preview session is a great time to go over the color and style preferences that best fit your wedding day vision. Your bridal trial run will reflect the same look we choose for your wedding day (unless otherwise specified). Please keep in mind one preview session is provided at a reduced rate, any additional preview sessions are at additional regular rates.

- This should be scheduled at least 4 weeks prior to your wedding
- Bring pictures of different hairstyles that you are interested in for the hairstylist to consider
- Bring your headpiece, veil, and any hair accessories you plan to wear on your wedding day

**Wedding Day:** To help us serve you better and ensure that your wedding day runs smoothly, we ask that you and your wedding party please follow these simple guidelines:

- Please arrive with clean, dry hair to help the hold of your hairstyle. Every person getting their hair done in an up-do, half-up style, or curls must have their hair already dry. The stylist will not allow time for this. If such a case arises, the stylist will charge extra to blow dry or flat iron (if time permits) or the service will be forfeited and the charge will still apply.
- Bridesmaids should bring pictures of different hairstyles that you are interested in for the hair stylist to consider. Bring your headpiece, veil, and any hair accessories.
- Most importantly, please be on time for your wedding day appointment. Even starting 15 minutes late will put everyone behind and we don't want you to be late for your special day!
- The stylist needs a designated space to set up when on location. The bride is responsible for clearing an area before the stylist arrives.
- The stylist will need a work area with a chair near an outlet in a no walk-through traffic area.
- Good light and a mirror is a plus! If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply.
