Rudy & Kelly Hairstylists would like to make your wedding day a very memorable event. Please allow us to pamper you and your wedding party including the Groom, Bridesmaids, Groomsmen, Mothers and Fathers of the Bride and Groom during your entire engagement. We recommend waxing appointments be made the week before the wedding to allow for a recovery period. Rudy & Kelly also asks that you schedule for a free consultation and a trial run appointment before the actual wedding date.

A non-refundable deposit is due at the bride's trial run appointment before Rudy & Kelly will schedule any final appointments. The deposit will be the payment of the Bride's formal style. Please note that the Bride is responsible for the full payment one week before the date of the wedding for all members of the wedding party who have not yet paid.

Complimentary Consultation: At this appointment we will discuss your hair needs, schedule your practice run and reserve your desired day. Our contract and cancellation policies will be reviewed and a credit card deposit for all services will be collected. Dates will not be booked until we have a signed contract and deposit.

Trial Run for the Bride: \$50 This should be scheduled at least 4 weeks prior to your wedding.

- Bring pictures of different hairstyles that you are interested in for the hair stylist to consider.
- Bring your headpiece, veil, and any hair accessories you plan to wear on your wedding day.

Wedding Day: To help us serve you better and ensure that your wedding day runs smoothly, we ask that you and your wedding party please follow these simple guidelines:

- Please arrive with clean, dry hair to help the hold of your hairstyle.
- Every person getting their hair done in an up-do, half-up style, or curls must have their hair already dry.
 - *The stylist will not allow time for this. If such a case arises, the stylist will charge extra to blow dry or flat iron (if time permits) or the service will be forfeited and the charge will still apply.*
- Bring pictures of different hairstyles that you are interested in for the hair stylist to consider.
- Bring your headpiece, veil, and any hair accessories.
- Most importantly, please be on time for your wedding day appointment. Even starting 15 minutes late will put everyone behind and we don't want you to be late for your special day!
- The stylist needs a designated space to set up when on location.
 - *The bride is responsible for clearing an area before the stylist arrives.*
 - *The stylist will need a work area with a chair near an outlet in a no walk-through traffic area. Good light and a mirror is a plus!*
 - *If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply.*
