BY PROVIDING SCHOLARSHIPS FOR APPLIED BEHAVIOR ANALYSIS (ABA), CHILDREN DIAGNOSED WITH AUTISM SPECTRUM DISORDER ARE TAUGHT NEW FUNCTIONAL STRATEGIES THAT IMPROVE OUTCOMES FOR BOTH CHILD AND FAMILY.

IN 2022, 85 (EIGHTY-FIVE) CHILDREN WERE AWARDED \$405,195 IN APPLIED BEHAVIOR ANALYSIS SCHOLARSHIPS. SINCE BEGINNING ITS LIFE CHANGING WORK IN 2006, THE FOUNDATION FOR AUTISM CARE, EDUCATION AND SERVICES HAS AWARDED MORE THAN \$2.2 MILLION IN ABA SCHOLARSHIPS.

SCHOLARSHIPS ARE DETERMINED BY CONFIRMED DIAGNOSIS AND DEMONSTRATED NEED FOR FINANCIAL HELP TO PAY FOR APPLIED BEHAVIOR ANALYSIS (ABA) BEYOND WHAT INSURANCE WILL COVER. MOST APPLICATIONS COME FROM WORKING FAMILIES WITH CHILDREN WHO HAVE JUST BEEN DIAGNOSED AND CANNOT AFFORD RECOMMENDED TREATMENT AND FAMILIES WHO CANNOT AFFORD TREATMENT DUE TO EXTENUATING CIRCUMSTANCES.
